To Whom It May Concern:

As the California State Assemblymember representing the 11th Assembly District, including Solano County, I write to express my concern regarding the possible consolidation of the SCDD North Bay Regional Office in Vallejo, CA, with the North Coast Office in Ukiah, CA.

SCDD is established by state and federal law as an independent agency to ensure Californians with developmental disabilities and their families receive the services and supports they need, with a profound mission to "advocate, promote and implement policies and practices that achieve self-determination, independence, productivity and inclusion in all aspects of community life."

However, recently several of my constituents, some of whom are members of Parents Empowering Parents Special Needs Support Group, shared their concerns regarding the North Bay Regional Office in Solano County, which serves not only 4,000 families in my district, but also Sonoma and Napa County families as well. Therefore, if the North Bay Office were to merge with the North Coast Office in Mendocino County, thousands of families from Napa, Sonoma, and Solano counties with developmentally disabled loved ones would have to make the two-hour-plus commute to rural Ukiah, CA.

As a leading Special Needs Champion in Sacramento, and proud volunteer at the Special Olympics Summer Games for the past twelve years, I can attest that your support to keep the North Bay Regional Office open will be a vital tool in ensuring local families have access to instrumental and informational trainings, such as learning how to navigate Individualized Program Plans, Bullying and Autism Awareness classes, and educational field trips within the community.

Therefore, I urge your full consideration of, and offer my strong support for, keeping the SCDD North Bay Regional Office open in Solano County. Please feel free to contact me with any questions you may have at (916) 319-2011.
