Goal #1

Individuals with developmental disabilities have the information, skills, opportunities and support to advocate for their rights and services and to achieve self-determination, independence, productivity, integration and inclusion in all facets of community life.

- LARO Staff assisted officers of SABLAC in their outreach efforts at the Southwest SELPA transition fair. Their goal was to recruit new and younger members for SABLAC. They also handed out their publication, Bandaging the Budget. (GP Reached 30 OTH)
- LARO Staff assisted the president of SABLAC to conduct the monthly meeting of the group. They are preparing for their officer elections, reviewing the bylaws so that everyone understood the requirements of each position. (People Trained 10 SA)
- LARO Staff, on behalf of SABLAC, posted four outreach pieces on voting on SABLAC's Facebook page. They included information about voter registration, a plain language voting guide, and barriers to people with disabilities in voting. (GP Reached 170 OTH)
- LARO Staff attended & provided technical support to the Westside Regional Center (WRC) Consumer Advisory Committee (CAC) meeting on 5/4/16. Staff also distributed flyers promoting upcoming events: Effective Person Centered Planning on 6/25/16, the availability of Cycle 39 Mini-Grants, and the availability of training as requested by the group. (People Trained 12 SA/ 2 FA/ 5 OTH)
- NCRO Staff supported SSAN Legislative work group member to participate on teleconference call. Staff met with SSAN member prior to call to go over agenda and other meeting materials. 5/31/2016 Meeting was rescheduled to 5-31-2016. (People Active 1 SA / People Trained 1 SA)
- NSRO - SSAN has 4 workgroups and staff provided support to 3 SSAN workgroup meetings. Newsletter - met on 5/13; Legislative met on 5/17 and 5/31. Through the 3 meetings technical assistance was provided opening the conference call line and providing reminders of what the group's purpose, goals and objectives are. Staff provided guidance and helpful suggestions for improving leadership skills and ways to produce information to share with others. (People Trained 7 SA)
- NSRO Staff distributed SCDD Posters at the Statewide Self Advocacy Conference hosted by Supported Life and SCDD to 165 people. More than 500 posters were distributed to 135 self-advocates, 10 family advocates and 15 support staff. Many took multiple copies to share with others for education on achieving self-determination, Independence, Productivity and Inclusion. (People Trained 135 SA/ 10 FA/ 15 OTH)
- NSRO Staff provided support to create and present a power point presentation about SCDD and SAAC at the Statewide Self Advocacy Conference hosted by Supported Life and SCDD. 2 SAAC members presented the power point. 20 self-

- advocates, 1 family advocate and 3 staff attended the presentation and learned about SCDD and SAAC. (People Trained 20 SA / 1 FA / 3 OTH)
- NSRO Staff provided support to organize and implement the May 25, 2016 SAAC meeting. Technical assistance was provided to the SAAC chair to prepare for the meeting and to the members to successfully participate in the meeting by agenda & power point development and note taking for meeting minutes and reports. (People Trained 6 SA/ 1 FA)
 - NVHRO Staff provided technical support to the Self Advocacy Council 6 to present two sessions, provide the Dating Game, and have an agency fair table with handouts. Also provided support to SCDD members and a SSAN member for their training sessions. The theme of the conference was "Get Connected" and brought SABE to California. (People Trained 15 SA/ 2 FA/ 2 OTH/ GP Reached 300 SA/ 25 FA/ 50 OTH)
 - OCRO staff facilitated a tour of Goodwill Industries Orange County for the Orange County SSAN Representative by coordinating transportation and availability of the involved parties. The tour occurred on 6/17/16. (People Active 1 SA/ 3 OTH/ People Trained 1 SA)
 - OCRO staff facilitated the Integrity House Self-Advocacy Group on Wednesday, May 18, 2016. The Office of Clients' Rights Advocacy presented on voting rights; there were 14 self-advocates who participated fully in the presentation and discussion about the topic. The focus of the training was specific to current primary and presidential election dates for voter registration, change of party affiliation, creating a personalized ballot, access requirements at voting locations, and right to assistance on voting day at the polls. (People Trained 14 SA/ 5 OTH)
 - OCRO Staff collaborated with Integrity Cottages Housing to facilitate for their self-advocacy group. This meeting focused on the presentations the group would like more information about, including SSA, Housing, OCTA Access, and Safety training. As discussed at the last meeting, SCDD staff will assist the self-advocates in drafting a letter to property management about having parking tags for staff and managers who support residents. The group's secretary and chair will be responsible to gather signatures and mail to the appropriate parties. The self-advocates would like to have SCDD facilitate and help to arrange speakers as they need. Next month, in June hopefully, we are trying to secure a representative from Anaheim Housing Authority to discuss the section 8 housing choice voucher, although this has been a challenge to coordinate. (People Trained 10 SA)
 - OCRO Staff collaborated with Integrity Cottages Housing to facilitate for their self-

advocacy group. This was the third meeting, which focused on how to speak up for yourself, how to handle difficult situations, how to be a more effective advocate, and how to help others. Specifically, the self-advocates discussed: (1) having parking tags for staff and managers who support residents and can help out in critical, but non-emergency situations; (2) scheduling movie nights and games for Friday's for residents who don't have the transportation or financial means to go out on Friday nights; (3) schedule birthday parties and other activities at the Cottages to help maintain a support network at the Cottages. The self-advocates nominated a chair and secretary for the meetings. The self-advocates would like to have SCDD facilitate and help to arrange speakers as they need. Next month, in June hopefully, we are trying to secure a representative from Anaheim Housing Authority to discuss the section 8 housing choice voucher. (People Trained 11 SA)

- SDIRO Staff co-facilitated the monthly self-advocacy conference planning meeting. The planning team continued their discussions and created action plans for the final details regarding the conference. Registration numbers are low and strategies were discussed on how to boost up the registration numbers. Gathered a team of self-advocates to make REV UP the vote buttons to give away at the conference as well as San Diego People First buttons. Provided ongoing support to the planning team to assist in making sure the conference runs smoothly and the self-advocates are empowered to take ownership of the event. (People Attained Membership on Boards 13 SA / 8 OTH / People Trained 8 SA)
- SDIRO Staff facilitated the self-advocacy newsletter meeting with four people in attendance. Together the group identified topics and materials to include in the second edition of the newsletter and assigned tasks. They also discussed ways to modify and improve the newsletter based on feedback. The group also discussed adding a section for advertisement of micro enterprises. Neighborhood House, Access 2 Independence, the local ILC, A self-advocate, support staff from the Arc and a student from the Institute for Effective Education were the agencies represented at the meetings. (ORGs involved 2 SA / 4 OTH)
- SDIRO Staff provided support to the SDPF officers as they held their quarterly meeting. The topics that were presented were: Random Acts of Kindness, Acts of Services (Volunteerism) and Community Connections. The participants engaged in all aspects of the trainings and had the opportunity to make tags for their community service project that will take place in July. In addition to providing support to the officers as they ran their meeting, the self-advocates were

supported as they managed the check in table and prepared the packets for each participant. A voter registration table was set up and information on voting in addition to voter registration forms were distributed by one of the SDPF officers. (People Trained 17 SA / 3 OTH)

- SEQRO SCDD was asked to join the 7th Annual Self Advocacy Conference Committee Meeting. There were 400 participants in attendance last. It's a unique event in the Central Valley as it offers the opportunity for youth and adults with disabilities, teachers, parents and professionals to gain awareness through exposure to resources and specific learning topics. Due to this year being an election year, there will be an emphasis on voting and the process. SCDD will provide a training on healthy eating habits as well as assisting the committee with finding speakers for the conference. Bebe Perez of Resources for Independence Central Valley has asked our office to also present the main conference session on "Voting". This will be close to 150 people for 2 session, for a total of 300 clients/staff trained on their voting rights. (ORGs involved 2 SA/ 4 OTH)
- Staff provided a rights and self-advocacy training to individuals with I/DD as one of the first offerings of the San Jose Public Library's Insiders program to individuals with I/DD. (People Trained 4 SA / ORGs 1 OTH)
- SVMBRO SCDD staff worked with the SSAN representative from Central Coast to assist the SSAN chairperson with the final draft of the Memo of Understanding between the SSAN and the State Council. (People Active 2 SA/ GP Reached 14 FA)

- LARO staff conducted a training on Bullying to one of South Central Los Angeles Regional Center's (SCLARC) parent groups held at L.A. Care's Lynwood site. Only 2 parents showed up which surprised SCLARC staff given the popular topic. SCDD staff modified the presentation so that it was more of a small group discussion. The parents were given a copy of SCDD L.A.'s publication, "Enough is Enough: Anti-Bullying Strategies for Students with Developmental Disabilities, Their Families and Their Schools." The discussion covered selected parts of the booklet, stressing the importance of using the IEP process to address bullying, the benefits of bystander training programs, and other strategies as well as sharing experiences and Q and A. Staff also took the opportunity to explain the role of SCDD. (People Trained 2 FA/ 2 OTH)
- LARO On 5/19/16, staff completed final development of a PowerPoint for a webinar scheduled for 5/26/16 sponsored by the USC University Center for Excellence on Developmental Disabilities (USC UCEDD). Staff also performed a mock presentation in order to ensure all deadlines would be met during the actual webinar. (ORGs 2 OTH)
- LARO On 5/26/16, staff provided a one hour webinar sponsored by the USC University Center for Excellence on Developmental Disabilities (USC UCEDD). (People Trained 7 SA/ 38 FA/ 63 OTH)
- LARO On May 21, 2016, staff conducted outreach and attended a meeting of the Westside Moms Parent Support Group. Staff engaged in a question and answer session with all members regarding their greatest concerns surrounding special education. All questions were answered and predominantly related to IEP strategy, due process, and independent educational evaluations. There were 13 attendees and the session lasted for three hours. Staff also distributed flyers promoting upcoming events: Effective Person Centered Planning on 6/25/16, the availability of Cycle 39 Mini-Grants, and the availability of training as requested by the group. (People Trained 13 FA)
- LARO Staff attended the monthly special education task force meeting to discuss current issues in special education in the Los Angeles area. The discussion revolved around the lawsuit filed by parents in LAUSD against closing segregated school sites as implemented under the Chanda Smith modified consent decree. (ORGs 6 OTH)
- LARO Staff provided training to SABLAC on the ABLE Act. They were excited to hear about the new possibilities for saving money without jeopardizing their benefits. (People Trained 10 SA)

- NBRO staff presented a PowerPoint on IPP Basics. Points of discussion were what is an IPP, Person Centered Planning, what information should be included in an IPP, effective communication with your service coordinator, and the basics of addressing IPP disagreements. (People Trained 1 FA / 1 OTH)
- NBRO staff presented a PowerPoint on IPP Basics. Points of discussion were what is an IPP, Person Centered Planning, what information should be included in an IPP, effective communication with your service coordinator, and the basics of addressing IPP disagreements. Materials distributed were a copy of the power point presentation, Introduction to Regional Center Services, Get Ready for Your Child's IPP/IFSP Meeting, Letter to Ask for an IPP Meeting, and Fair Hearing Flow Chart. (People Trained 6 FA/ 2 OTH)
- OCRO staff hosted BCBA Anthony Hamedi, Founder and Director of Hope Autism Therapies, to conduct a parent training on "how to use ABA to help your child with a disability" for 6 parents and 4 professionals. This workshop covered the following topics: (1) what is ABA, (2) how it can help you, (3) how to obtain ABA services, (4) finding the best fit provider, (5) typically assessed skills in ABA, (6) functions of behavior, (7) behavior change programs and behavior shaping. (People Trained 6 FA / 4 OTH)
- SACRO staff served as a planning team member and sponsor for the 21st Annual Statewide Self Advocacy Conference from May 6th-8th, 2016. Planning team meetings were monthly throughout the year and sponsorship from SCDD provided printed materials, name badges and ribbons, folders, and various office supplies for the 350 self-advocates in attendance. SCDD continues to promote inclusion, independence and self-determination and ways for self-advocates to have a voice and this conference upholds and supports this vision. There were 30 self-advocates who participated on the planning team, giving it a theme name of "Get Connected". The self-advocates lead all sessions, gave speeches, and also acted as the moderators of each session. There were 30 sessions to attend, as well as an opening presentation, and social activities (karaoke, dating game, and dance). Self-advocate attendees were from all over California as well as Hawaii, Arizona, Guam, and Nevada. The National Western States SABE (Self-Advocates Becoming Empowered) held their annual meeting during the Self-Determination Conference. These visiting self-advocates were warmly welcomed during a "getting to know you" dinner on Thursday night hosted by local self-advocates on the Planning Committee. The conference provided an opportunity to learn about housing, employment, secondary education, learning to self-advocate, self-

- determination, emergency preparedness, healthy living, communication, crime prevention, starting a business, exercise, making your own choices, gaining control over your life, achieving your dreams, starting a business, preventing cyberbullying, marriage, and so on. (People Trained 350 SA/ 25 FA/ 25 OTH).
- SACRO staff presented SCDD information on a resource table at the 21st Annual Statewide Self Advocacy Conference from May 6th-8th, 2016. There were 350 self-advocates in attendance. SCDD offered printed information on topics of Self-Determination, Employment, Emergency Preparedness, IPP Planning, Transition, In Home Support Services (IHSS) and Independent Living. SCDD's informational flyer was available and Cal Fire Emergency information bags were given away as well. SCDD continues to promote inclusion, independence, self-determination and employment and as such poster boards were developed and posted. A sign in sheet was provided to increase the number of people we can send information to through MailChimp. (People Trained 350 SA/ 10 FA/ 20 OTH/ GP Reached 15 FA/ 10 OTH)
 - SACRO staff and SCDD Sacramento Regional Office Regional Advisory Committee attended a presentation/training titled, "Lessons Learned from Educational Inclusion and What it means for all Children", presented by Nelia Nunes, Parent advocate. Ms. Nunes presented the struggles, trials, the learning curve for school administrators and teachers along with the positive outcomes of full inclusion for her daughter, their family, teachers and students. Their family journey was explained and presented step by step and is an inspirational story of success. (People Trained 8 SA/ 8 FA/ 4 OTH)
 - SACRO staff led a training at DDSO (Developmental Disabilities Service Organization) Short Center North in their Employment + program, Self-Advocacy Skills 101 class on identifying and planning for your hopes and dreams. 25 students attended. (People Active 25 SA/ 2 OTH)
 - SACRO staff participated in the 6 Steps to Success In Special Needs Planning workshop organized by the Elk Grove School District for parents of special needs children. Michael Pearce of Pearce Law lead the workshop. I was given the opportunity to share with the attendees the mission and activities of SCDD. During break time, 8 families approached me to ask questions about services. Information about conservatorship, power of attorney, alternatives to conservatorship, and trusts and wills was discussed with families. (People Trained 1 SA 75 FA/ 5 OTH / People trained in system advocacy 8 FA)

on voter education was presented to 30 young adults who participate in a job club. The training covered the importance of voting, the right to vote, registering to vote and tips for successful voting. The training offered the attendees the opportunity to register to vote and ask questions about the voting process as well as what to do if they have a difficulty in accessing the polls on election day. Packets were provided to all who attended the training. (People Trained 30 SA/ 7 OTH)

- SDIRO, In collaboration with San Diego Regional Center, Disability Rights CA a training on voter education was presented to 35 people in Imperial Valley. The training covered the importance of voting, the right to vote, registering to vote and tips for successful voting. The training offered the attendees the opportunity to register to vote and ask questions about the voting process as well as what to do if they have a difficulty in accessing the polls on election day. Packets were provided to all who attended the training. (People Trained 29 SA/ 6 OTH / ORGs 3 OTH)
- SDIRO Staff coordinated and facilitated the monthly planning meeting for both the 2016 parent conference and wrap up discussion on the sibling event. The group reviewed the sibling event and identified strategies and areas to change for the next sibling event. Thank you letters to all volunteers were distributed and based on the low number of returned completed evaluations from the families who had a child come to the sibling event a new evaluation will be mailed to each family. The planning team is still in the process of determining what their workshops will be for the October conference. (People Active 3 FA/ 6 OTH / ORGs 9 OTH)
- SDIRO Staff presented a power point training on "Getting Regional Center Services Through Your IPP". The training discussed 5 major points: what is the IPP, who is the IPP team, how to prepare for the IPP, purchase of services guidelines and services available through the regional center. The training was held at the San Diego Marine Corp Recruit Depot in their Family Member Services building. One parent attended this training. (People trained 1 FA)
- SEQRO, on a monthly basis, the staff and the H.E.A.R.T.S Connection staff coordinate this event that focuses on helping educate parents, students and parent mentors to navigate the special education system. "The H.E.A.R.T.S Connection Family Resource Center is staffed by parents and family members of children with disabilities and/or special health care (People Trained 2 FA/ 2 OTH)

There are 7 regional centers in Los Angeles County serving about 1/3 of the population. SCDD LA Regional Manager met with SGPRC Executive Director as part of the reconnection post AB 1595, Chesbro, to best support regional center recipients in LA County. The purpose of the meeting is to actively engage SGPRC, create a shared vision and a channel to leverage resources, cultivate trust-based relationships to result in ongoing and effective collaborations. LARO Manager met with SGPRC's Executive Officers of Client Services, Federal Programs/Clinical Services, Community Services, and Compliance and Training, to discuss collaboration opportunities to meet the needs of its service recipients. (ORGs 2 OTH)
- NCRO- The Redwood Coast Regional Center and SCDD - North Coast Self-Determination Advisory Committee held their regularly scheduled meeting. The group had decided that they will meet quarterly until the waiver is approved however, after attending the Statewide Self-Determination Advisory Committee, the Chair (FA) discussed with the group that there were activities that could be undertaken by the group. The group decided to establish a training workgroup to develop the message that the committee members to take to their communities in order to outreach to the all individuals and families that did not contain specific information that would be dependent upon provisions in the waiver. (People Active 4 SA/ 3 FA/ 4 OTH/ ORGs 3 OTH)
- NSRO Staff participated in Far Northern Regional Center's Board of Directors meeting on May 20, 2016 by providing a presentation on SCDD updates and programs including status of Program Development Grant Cycle 39 and reviewed the State Plan Goals for North State Office's Request For Proposal, including deadlines and details. Information was provided on Medi-Cal 2020 upcoming conference, including speakers, topics and registration information. Information flyers were provided on Program Development Grant Cycle 39 and Medi-Cal 2020

- NVHRO - RAC meeting was held at the Arc of Amador & Calaveras (Calaveras Campus). Patricia Green from VMRC attended the meeting to give their report. Agenda in common drive. The guest speaker and presented was Diana Powell- a self-advocate from Tuolumne County. She gave her presentation on going from Homeless to Home Proud. It was really well received. Art Valdez: Art noted sensory movies in Manteca and Lodi and a mother's picnic in Lodi at Peirano's winery with a get together planned quarterly. He also spoke of a Facebook page called Autism Families of San Joaquin and shared that he continues to promote a challenger league to be part of Pacific Little League. (GP Reached 3 SA/ 3 FA/ 8 OTH)
- NVHRO is a standing agenda item on the monthly Coalition of Local Area Service Providers (CLASP). At this meeting - information was shared about the Cycle 39 RFP's, SAC6 meetings and next RAC meeting. The vendors talked about upcoming holiday schedule for the next year as well as rate increase and the DDS survey. (GP Reached 25 OTH)
- NVHRO staff attended the VMRC Consumer Services and Board meeting monthly at VMRC. Consumer services meeting discussed Clinical info, Resource Development update, Quality Assurance update and Case Management updates. Staff shared info on transportation resources and flyer developed by SCDD. At the board meeting, they approved budget info, SAC6 report, May Human Resources Report and May Caseload report. (GP Reached 6 SA/ 6 FA/ 15 OTH)
- NVHRO - The CHOICES Institute met to debrief about the April 2106 conference. Our office tallied the evaluation forms and items were discussed and the fiscal report was given. The committee had an election of new officers and will not meet until August 2016 to plan the 30th Conference in 2017. (GP Reached 3 SA/ 2 FA/ 10 OTH/ ORGs 15 OTH)
- OCRO staff presented on Self-Determination on May 24, 2016, to a group of 25 professionals, consumers, and family members. The focus of the training was an overview of Self-Determination including the five principles of Self-Determination, who is/is not eligible for the program, the individual budget, the independent

facilitator, the financial management services (FMS), and phase-in information specific to Regional Center of Orange County. The PPT was adapted with permission from the Los Angeles Regional Office. (People Trained in Leadership 2 SA/ 20 FA/ 3 OTH)

- OCRO staff participated in the RCOC Self-Determination Local Advisory Committee that reviews the development and ongoing process of the self-determination program, including advancing the principles of self-determination and to ensure operation consistent with the requirements of the WIC statute. At this meeting, the following topics were discussed: (1) Outreach to the public and prioritizing our efforts to non-English speaking populations (2) FMS presentation by 24hr HomeCare (3) Presentation for Vendor Advisory Committee (4) PCP Presentation status update (5) Suggestions or request received via RCOC website - only 2 comments received just to be added to the interest list (People Active 4 SA/ 2 FA/ 3 OTH/ People Trained in Leadership 2 SA/ 6 FA/ 4 OTH)
- SACRO assisted with the presentation given by self-advocate Zach Miller and 2 high school students on "Public Speaking for Self-Advocates" at the 21st Annual Statewide Self Advocacy Conference on May 6, 2016. Presenters gave tips and techniques to increase public speaking skills, discussed how to share your personal story in a way that is meaningful and powerful for others to hear. Presenters had the attendees break into smaller groups and practice speaking skills with each other. There were 40 self-advocates at this session. Prior to this session, the SCDD staff coordinated the self-advocate to visit the Sacramento Waldorf School and meet with a speech and debate teacher and 2 high school students who are part of the Speech and Debate Team. They planned the session together and then lead the session as a group. (People Trained 40 SA/ ORGs 2 OTH/ GP Reached 2 OTH)
- SACRO staff assisted with the presentation given by self-advocate, Lisa Cooley regarding "Self-Determination - What is it and When will it happen?" at the 21st Annual Statewide Self Advocacy Conference on May 6, 2016. Lisa Cooley informed the audience how the Self-Determination Program will be a new way to have control over their money that pays for services, leading to new service options. Ms. Cooley gave information about how to get on the list for Self-Determination and her session offered printed information regarding the topic as well. There was an opportunity for the audience to ask questions, and the most commonly one was "When can I get this service?" There were 350 self-advocates in total at the conference and 55 in attendance at this session as well as 2 family

members and 6 other attendees. Many comments from self-advocates requested clarity when referring to the "FMS - Financial Management System" and the "Facilitator" components of Self-determination. (People Active 50 SA/ 2 FA/ 3 OTH/ People Trained in Leadership 3 OTH)

- SACRO staff attended Alta Regional Center's Consumer Advisory Committee (CAC) meeting at ACRC. Topics of discussion were: The Governor's May budget revise this Friday, proposed new funding for regional centers for caseload reduction and additional service coordinators, 2 additional meetings this week with Nancy Bargman, Director of DDS, regarding Sonoma DC closure. A discussion of Federal Waiver reimbursements - 55% of people receiving regional center services are on the Waiver. ACRC is not projecting a deficit this year. Discussion of trip planned for June 14th to Sonoma Developmental Center to hold the CAC meeting with residents of SDC who are from ACRC's catchment area. Self-Advocates presented updates regarding their various boards including: SCDD's Regional Advisory Committee, Association of Regional Center Agencies Consumer Advisory Committee, Peer Advocacy Committee, and Alta California Board of Directors. Several individuals who had lived at SDC at some point in their lives volunteered to speak at the SDC meeting. SCDD staff explained that under contract with DDS, staff will be conducting Movers and Longitudinal study surveys of individuals who have moved out of state developmental centers. (People Active 18 SA/ 5 OTH/ ORGs 3 OTH)
- SACRO staff hosted and participated in the planning meeting of the Peer Advocacy Connection which is the planning committee for the Regional (semi-annual) Peer Advocacy Connection (PAC) workshop. Participants reviewed evaluations from the last meeting and developed the agenda and potential presentation topics for the October meeting. SCDD staff suggested reaching out to individuals living in care homes and encouraging them to attend future meetings. SCDD staff also suggested the committee develop a flyer that explains the Regional PAC meeting in more detail to help with marketing and increasing attendance. David Lopez, Client's Rights Advocate at ACRC said he would discuss the Residential Unit Supervisor if Ed Plon and several self-advocates could come speak with the Residential Service Coordinators to inform them about the Regional PAC meeting and encourage them to spread the word to the self-advocates and care providers they work with. Three self-advocates volunteered to assist Ed with this outreach efforts. Plans were made to develop a flyer at the next meeting. There were 18 self-advocates and 6 other attendees at this meeting.

This committee is made up of the chair person from each People's First Advocacy group in each of our 10-counties. Many of these individuals have the assistance of a facilitator for their group. The PAC meetings are coordinated by Ed Plon of Supported Life Institute's Self-Advocacy Project (funded by the Regional Center). The self-advocates make all major decisions related to the planning of the Regional PAC meetings. This group has outgrown the conference room at the Supported Life Institute so they asked if they could use our conference room. The following agencies are involved in this collaboration: ACRC, ASAN, Supported Life Institute, SCDD, and DRC. (People Trained 18 SA/ 6 OTH/ ORGs 5 OTH)

- SBRO Regional Manager met with the Executive Director of Inland Regional Center (IRC) regarding the intake process and referrals. We discussed concerns brought forth by our self-advocates and their families regarding the intake process, services, and access to the facility. We also discussed the SCDD role and responsibilities and we provided them an updated brochure and the trainings offered by our office. During the discussion, we brainstormed ideas to assist the community with understanding the roles, processes, and services of regional center. This office suggested that IRC post some of their processes to their website, and provided an example from San Diego Regional Center on how they have addressed this concern and assisted the families. The link to the processes used for an example is as follows: link <http://sdrc.org/>. The SBRO Regional manager requested a monthly standing meeting to discuss issues and concerns from the community and to follow-up with any concerns. The next meeting is scheduled for 2pm on June 13, 2016. (ORGs 3 OTH)
- SBRO staff collaborated with Premier Healthcare to present on the role of the Financial Management Services (FMS) within the Self-Determination program (SDP) as well as Inland Regional Center (IRC) to co-facilitate the training to the community members. The meeting was held within the SCDD San Bernardino Regional Office Conference room. The presentation also had a specialized component entitled "Navigating Financial Management Services (FMS)" which was presented to the group by a FMS provider who works throughout the state of California and could give training participants a better understanding of the role of the FMS. Materials that were distributed to the group were; Premier healthcare "Navigating FMS", "What is Self-Determination?", Self-Determination NOW! and the SCDD power point presentation. The presentation was designed to provide members of the community with an overview of the Self-Determination program information. (People Trained 8 FA/ 6 OTH)

- SCDD staff provided technical assistance and updates to the committee members regarding Self-Determination, trainings to the community in english and spanish, and increase in outreach to the community by IRC on the program. SCDD staff also informed committee that training was provided on April 19, 2016 to IRC training unit so that outreach can be provided to the community. Updates on CMS and DDS were provided to the committee from both IRC and SCDD staff. IRC and SCDD staff co-presented their second collaborative training on May 24, 2016 prior to the SDAC meeting. IRC and SCDD discussed providing possibly more trainings to IRC staff due to recent feedback from the community members and IRC staff that they do not have a clear understanding of the SDP program to appropriately discuss the program with consumers and/or families. In addition, Premier Healthcare provided a training on Navigating Financial management Services (FMS) for the group. All attendees were provided pre & post evaluation survey and the survey results are as follows; (People Trained 1 SA/ 6 FA/ 7 OTH)
- SDIRO - At the bi-monthly Regional Advisory Committee, staff provided a power point presentation on the Final Rules for the HCBS Waiver. These changes will have some impact on the way services are provided, and it was helpful for the members to be exposed to more information, since they may be questioned about what these changes will mean for people in the community. (GP Reached 5 FA/ 2 OTH)
- SDIRO At this bi-monthly meeting, the group was updated on the status of finances at the San Diego Regional Center, and a request was also made for those providers who were asked by DDS to respond to the salary survey, to please do so. The Legislative Forum update was provided, and there was a great deal of discussion regarding the HCBS rules. The Arc San Diego and the San Diego Regional Center are planning a one day conference open to providers only, to address how these changes will impact services. Someone from Louisiana that was formerly with the Arc in that state has been asked to come out and present. From the discussion heard, it seems as if agencies are more concerned about how they can remain the same and still obtain funding, rather than learn how they can provide a meaningful change in their program to meet the guidelines of HCBS. The Southern CA Housing Collaborative stated that they had another groundbreaking ceremony for another development that will have 7 fully accessible units for clients and families of the regional center. Staff reminded vendors about the Request for Proposals that are currently out, as well as the upcoming Self-Advocacy Conference and Project College. A request was also

- SDIRO Attended the monthly regional center client advisory committee meeting (8 people were in attendance), the group reviewed the regional center board meeting, clarified questions the members had and created a plan to better understand the material that is presented at the board meeting. The group also discussed their involvement in the Employment First trainings that would be done for staff, providers and the community. At the next CAC meeting the group will preview the Employment First Presentation that was created by the SSAN. (People Active 6 SA/ 2 OTH)
- SDIRO Upon request for training and support in understanding WIOA by the staff at a local agency SCDD staff provided training and the opportunity to talk about how their organization will be impacted by the systemic changes that are coming. During that meeting resources were shared in addition to suggestions on how they could start looking at the ways they currently provide services and how they will need to be transformed in the near future. (People Trained 4 OTH)
- SVMBRO In collaboration with Imagine Services of Santa Cruz, State Council SV/MB staff held the monthly meetings of the Self Determination Facilitation Learning Community. One meeting was held at the SCDD offices in San Jose, the other was held at the Imagine offices in Santa Cruz. At the training an update on Self Determination roll-out in California was discussed along with principles of person centered planning, and how fiscal management is likely to operate. (People Trained 2 FA/ 4 OTH)
- SVMBRO staff met with the chair and vice chair and regional center staff of the SDAC for the Central Coast area. At the meeting a flyer to be mailed to all Tri-County consumers was reviewed, edited, and approved. It will be mailed out to in the POS announcements that are to go out in June. SCDD staff stated they will take on the task of providing outreach to the community to inform them of self-determination and the status of the roll out. Goal #4

- HQ CIT - This is part of an ongoing series of trainings (through MHSA funding) to reach law enforcement/first responders with information about, tactical communication with, & response to persons with I/DD &/or psychiatric impairment(s). Participants are given information and resources to serve vulnerable and at-risk populations in an attempt to decrease the potential for both officer and citizen injury & death in the event of disabilities that may manifest in aggressive or unusual behaviors, impaired communication, or adverse public responses. As of this summer (2016), this course is mandated for all field training (law enforcement) officers and, in a shorter form, will soon be required of advanced officers. Many departments are opting for 1-day, 8-hr trainings. This CIT course is designed as a 32-40 hour course and allows time for a broader range of information and time for scenario training and hands-on exercises. (People Trained 28 OTH/ ORGs 7 OTH)
- HQ Provided staff training on service needs, communication, and physical issues regarding people with I/DD for SA/DV advocates, crisis counselors, shelter workers, and therapists. While most attendees had gone through the I/DD course for the basic academy, this class provided disability-specific information for SA/DV and therapy issues for serving victims of assault. Staff provides assistance/advocacy/accompaniment for Sexual Assault Response Team (SART) forensic/evidentiary medical exams, court hearings, and TRO proceedings, staffs a Domestic Violence Emergency Response Team (DVERT), offers paralegal services to victims who cannot navigate the civil justice system independently, gives classes on SA/DV, and supports victims in sheltered environments following real/potential/past abuse. While victims with I/DD have been served by this SA/DV agency and its affiliates, the staff recognizes that it is not fully conversant with the needs, unique characteristics, and services/supports of people with I/DD. This class stressed that victims with I/DD experience the same trauma that any victim experiences, in the aftermath of a violent assault, and that assailants are often those in positions of trust/authority, which only serves to deepen the fear, helplessness and hopelessness of victims with I/DD, who may find their independence threatened when experiencing/reporting such abuse. (People Trained 28 OTH/ Prog-Policy Created 1 OTH/ ORGs 4 OTH)
- LARO hosted and participated in the DRC Investigation Unit presentation held at the PCDA in Pasadena. Pamila Lew, Staff Attorney with DRC IU made a presentation on DRC IU overview and facilitated a Q&A session on various public

safety issues and legal rights centered on individuals with I/DD and their families. As the hosting agency, SCDD LA Regional Office staff provided handout materials after the meeting to enhance future collaboration with meeting attendees.

Handouts include "SCDD Los Angeles Regional Office: What We Do/Training & Event Calendar", "Self Determination Information Sheet", "Self-Advocacy Board of Los Angeles County" brochure, and "AIDD Fact Sheet". (People Trained 6 SA/ 7 FA/ 12 OTH / ORGs 2 OTH)

- NCRO - As part of the Partnership for Healthy Babies SCDD staff participated in the County Heros of Health and Safety Fair. Representatives from: Reach (Rescue Helicopter) CERT, Cal Fire, US Forest Service, County Sheriff, Local Police, Ukiah Valley Medical, PG&E, Red Cross, Anderson Valley Health, Public Health-Partnership for Healthy Babies and County Health and Human Services. The event included a variety of education hands-on activities - Search and Rescue Dogs, Police Dogs, Jaws of Life Demonstrations, Ambulance Demos. Staff was able to interact with first responders to share information and potential resources regarding their services and interaction with people with disabilities. (ORGs 20 OTH/ GP Reached 5 SA/ 16 FA/ 50 OTH/ Pub Policymakers Educated 3 OTH)
- NSRO staff provided outreach letters to all law enforcement agencies throughout nine counties of Region 2 in February 2016. The purpose of the contact was to introduce SCDD, its mission/purpose and to identify trends and needs regarding law enforcement interactions with people with disabilities. As of May 2016, North State Office has received 6 responses from a District Attorney in Shasta County, District Attorney in Trinity County, Shasta County Sheriff's Department, Redding Police Department, Butte County Sheriff's Department and Tulelake Police Department. (ORGs 6 OTH)
- OCRO staff attended a meeting on May 31, 2016 sponsored by the California Highway Patrol Safety Services Program (SSP). This collaboration was to discuss and determine varying state agency protocols for Emergency Action Plans in the areas of: Injury or illness; evacuation; bomb search; weapon; assault; demonstration; fire; bomb threat; explosion; active shooter; hostage; and earthquake. The CHP S.S.P. services officers remain available to the SCDD Orange County office for consultation, trainings, and concerns related to employee safety. (ORGs 30 OTH).
- OCRO - The Community Care Licensing Department (CCLD) Collaborative is a quarterly collaboration that includes state agencies, non-profits, the Department of

They were also provided with a bag of materials from the Safely Out project to "protect the vulnerable during disasters" a project of Citizen Voice. These included door hang tags that say "Safely Out" or "Need Help". Make a Plan, Prepare your Kit, and Be Ready was the overall message given to the 100 self-advocates, 5 family members, and 5 professionals who attended this session. The focus of the group is to network and develop strategies to increase opportunities for transitioning youth and adults with I/DD around employment, post-secondary education and community opportunities. Agencies provide updates related to youth opportunities and share upcoming events in the community, related to the mission of the network. One of the members is the Manager of Employment Services for Butte County Office of Education's SELPA. They are 1 of 4 county office of educations in California selected by Department of Rehabilitation (DOR) to enter into WIOA contract to provide Pre-Employment Training Services (PETS). Updates are provided on the program and services under WIOA contract. Far Northern Regional Center has been meeting with DOR to establish relationship around changing employment services. Butte Glenn Community College reports new opportunities for students with I/DD and new classes being approved by the state for all students. Employment providers are reporting new work opportunities for consumers and transforming programs to meet new federal rules around inclusion and integrated services. - NVHRO provided facilitation and participation in a group designing methods of improving transition services for students in Stanislaus County. Crafted meeting notes for group. (ORGs 9 OTH)
 - NVHRO staff attended a presentation by SCDD grant recipient Transitional Coaching and Development Institute at a transitional classroom setting in Jackson. The presentation concerned transition from educational to adult services with an emphasis on independent living and employment. It was offered by 3 self-advocates who attend TCDI. Staff observed content, delivery and audience reception to the presentation. In addition to the students, 5 staff and the Amador County SELPA director viewed the presentation.  - NVHRO staff participated in a teleconference discussing and describing various best practices in transitioning adult students from education to adult services. (GP Reached 50 OTH)

The Thompson Policy Institute presented on two main issues: The increased rate of Autism (nationally, statewide, and county-wide) and Autism in the workplace. The current Orange County Autism rate of school-aged children is 1 in 50. There was significant discussion related to the diagnostic criteria used by the CDC and by the Thompson Policy Institute to determine the current data regarding Autism rates. Additionally, the topic of the "Autism bubble" was discussed as there is a dearth of resources in the areas of education (properly supported) and employment for those moving on from high school and attempting post-secondary education and/or vocational education. People with Autism have a higher probability of being underemployed, unemployed, poorly paid, and/or having difficulty maintaining employment. Many suggestions were given about policy changes and educating the local community to cultivate the specific skills of someone with Autism during "transition" so that they are able to complete their education and obtain gainful employment. - OCRO staff attended the regular meeting of the Orange County Adult Transition Task Force (OCATTF) at the Irvine Unified School District on May 5, 2016. The topics discussed among the group included: Department of Rehabilitation Updates; Regional Center of Orange County Habilitation Referrals/Process; National Trends on Employment (Workforce Innovation and Opportunity Act (WIOA)); CA Blueprint for Reform for Individuals with Disabilities; OC Employment Data; Employment First Initiative; Work-Based Learning Opportunities; and Transportation Needs. The group confirmed the meeting schedule for the 2016-2017 school year and received information about a newly developed day program, Dreams of America. SCDD Orange County staff provided information regarding the SCDD Cycle 39 RFP information and promoted our e-blast communication for which four new transition professionals were added. The next OCATTF is September 8, 2016. The Orange County Adult Transition Task Force (OCATTF) is a collaboration where leaders from education, business, service agencies and family advocacy groups come together to share resources and address programming concerns specific to the successful transition of individuals with disabilities from school to work and community living. - SACRO staff attended Alta California Regional Center's (ACRC) Adult Day & Employment Vendor Forum. ACRC Community Services staff presented the following: Legislation updates regarding the increase in funding to vendors (result of MCO tax); HCBS work group updates, 4 Request for Proposals (In-Home Program, Adult Development Center, Behavior Management Program and Internet Safety Training); Employment data and ACRC's Vendorization Expectations and Requirements regarding Client Terminations/Suspensions. There were 55 people in attendance, representing 35 Adult Day program and Employment agencies. (People Active 55 OTH)
- SACRO staff listened to the Autism Society of San Francisco's panel discussion on HCBS settings rules. Panelists were: Rebecca Schupp, DHCS, Jim Knight, DDS, Amy Westling, ARCA, and Eric Zigman, GGRC, Javier Zaldivar, SARC and Aaron Carruthers, SCDD Executive Director. CMS HCBS settings rules were addressed with the panelists and much information was gained from the following questions: • How is "person-centered planning" different from the current IPP process under the new HCBS rules? What new options must be offered to consumers? • How will day programs and employment programs need to adjust

- SACRO staff presented information about the SCDD and the new Center for Medicaid Services (CMS) Rules to DDSO's Executive Director and 25 staff members. DDSO provides Day Program services for 359 students on a daily basis (Monday through Friday) with classes including woodworking, sewing, drawing, ceramics, music, art, physical education, and dance all on one large campus. Given the new CMS rules, SCDD staff offered an update that California's Transition Plan is still waiting final approval and addressed some of the circumstances in preparation for the new federal rules regarding inclusive settings. SCDD staff realized this large 'in house' day program setting is not congruent with the CMS settings rules so SCDD staff presented clearly the importance of the Person Centered Planning process and community inclusion options for consumers. - SDIRO manned a table at the San Diego Unified School District Transition Fair. The topic of the fair this year was regarding Post-Secondary opportunities, so I presented on Project College, but also brought along and provided numerous resources regarding the workshops offered by the Transition Coalition, information about San Diego People First - their schedule of meetings and events - Information about the LEAP jobs available through the State, and how to access the LEAP certificate and website; provided many people with information on the development of a meaningful ITP (individual transition plan); and also shared information and resources on Self-Determination, and Employment First. - SDIRO - The Transition Coalition met to discuss upcoming trainings, locations, days/times, etc. A Needs Assessment will be sent out to all the surrounding transition programs to see if staff can solicit input from families and students on preferred days, times and locations. Further discussion was held on the single subject vs. multiple panel member presentations, as both have been well attended in the past, although lately attendance has been lower. Topics for future trainings include the Point of Transition programs, Post-Secondary Opportunities, Benefits;

Living Options; Day Service Options; Self-Determination; Self-Advocacy; and the Work Innovation and Opportunity Act. There is a teleconference coming up on May 13th in Sacramento from 10:00 to 3:00 that staff distributed information on. Further discussion was had regarding the possibility of a large Transition Fair next year, possibly in February, at the SDRC to include San Diego Unified School District, as well as the Non-public schools that serve students in the San Diego area. In addition to the vendors, we could host approximately three workshops during the course of the event as well. Since there is a new to Community Services person starting in June at the regional center, outreach to her will begin when she officially takes over. There are now 18 Tailored Day Service programs in the San Diego area providing student supports on the college campuses, as well as other services. When scheduling the upcoming presentations, it was discussed that we should do more outreach to Middle School students and families. There is going to be a Transition Conference for Medically Fragile students on October 1st, and Jobtoberfest will be on October 4, 2016. People were also reminded that the SDUSD Transition Fair will be held on Tuesday night, May 31st at the Ballard Center, and PSE is the primary focus of this fair. The next Transition meeting will be held on June 29th at the office of the SCDD, and the September meeting will be on 9-28, which will hopefully include representatives from the SDRC as well as the SDUSD. - LARO Office hosted and participated in the PCDA presentation held at the PCDA in Pasadena. Diane Cullinane, M.D., made a presentation on DIR (Developmental-Individual-Relationship) model overview and facilitated a Q&A session on the alternative therapy model working with children with I/DD ages 0 through 21. As the hosting agency, SCDD LA Regional Office staff provided handout materials after the meeting to enhance future collaboration with meeting attendees. Handouts include "SCDD Los Angeles Regional Office: What We Do/Training & Event Calendar", "Self Determination Information Sheet", "Self-Advocacy Board of Los Angeles County" brochure, and "AIDD Fact Sheet". (People Trained 6 SA/ 7 FA/ 12 OTH/ ORGs 3)
- NCRO staff facilitated the meeting at the County Child Care Planning Council monthly meeting on May 7th. The 10 Collaborating agencies included Child Care Planning Council, Head Start, State Preschool, Pre-K teachers, County Office of Education, North Coast Opportunities, Mendocino College Child Development, local preschools, parents. The agencies discussed the progress of new bills & legislative issues, selected State Preschool Priorities for funding for the 2016-2017 year. North coast staff also participated in the executive committee meeting on May 25th and discussed progress towards the annual goals, new hires for Council positions, budget priority expenditures and marketing materials for early childhood education and intervention services. The two meetings discussed issues and legislation effecting general child care, early education and intervention services, the Impact grant collaboration project with First 5 Mendocino County, legislation to develop pre-K guidelines, program measurement tools for all state and private child care facilities, and a funding increase for the statewide child development programs. (ORGs 10 OTH/ ORGs engaged 10 OTH)
- OCRO staff participated in the Orange County Child Care and Development Planning Council's "Inclusion Collaborative" that meets monthly to ensure that children, age 0–12, with disabilities have equal access to all types of child care and education programs. At this meeting, the following items were discussed: -The surveys developed by this collaborative and the Early Childhood Mental Health Collaborative, went out to 2,650 child care providers and State preschools and phone call follow-ups will begin shortly. The CSUF Center for Social Science Research that will collect, aggregate, and analyze the data, reported that at least 714 surveys will need to be completed in order to have statistically significant results. To date, 137 surveys have been completed and the data assessment for those received has not yet been released. SCDD staff offered to host all future

meetings since the collaborative is looking for a new meeting location as of September 2016. The group agreed and the SCDD Orange County address will be provided to all members via the minutes. Legislation regarding SB172 (staff vaccines), SB 277 (child vaccines), and Pesticide Management certification training were reviewed. The Comfort Connection FRC Director mentioned a county-wide committee system established by the OC Social Services Agency, which addresses child abuse prevention. (ORGs 5 OTH)

- SCDD staff collaborated with Help Me Grow Orange County to meet the needs of Orange County families and connect them to developmental services and resources to enhance the development, behavior, and learning of children birth through five years. Help Me Grow Orange County is part of Children's Hospital Orange County & University of California Irvine Early Developmental Services (EDS) that provides a continuum of developmental services for children and families, from when a parent first has concerns about their child's development or behavior to full diagnosis and intervention for those children with developmental delays. Today, SCDD Orange County staff met with these parents who are new to navigating the service delivery system to help them with special education, IHSS, Social Security, and Regional Center questions and help to make sense of the California service delivery system and what agency service/supports their children may be entitled to receive. This advocacy clinic entitled "Special Education and Regional Center Advocacy Clinic - Ask an Advocate" served 5 families face-to-face and 1 parent by telephone. The goal of this collaboration and advocacy clinic is to try to garner national support for other Help Me Grow organizations nationwide to replicate. (People Trained 6 FA/ People Active 2 OTH)

- SACRO staff attended and participated in the Career & Employment Fair sponsored by the Sacramento Area Human Resource Association and the Sacramento Region Higher Education Coalition at the UC Davis Extension on May 11, 2016. There were over 25 businesses represented which gave SCDD staff an opportunity to introduce the SCDD's goal of Employment and the legislation, Employment First. In addition, SCDD staff provided outreach regarding the goal of the Northern California Business Advisory Committee (BAC). The SCDD and BAC brochures were distributed to each vendor. The BAC's mission is to do outreach to businesses so they can share their insight and expertise specific to their company and the industry sector they represent so in turn supported employment agencies and job developers and/or coaches will have an idea of training needed for clients to fulfill the business' need. It is the hope of the BAC to provide information and describe concerns or misconceptions companies may have about employing people with disabilities. (People Trained 40 OTH)
- SDIRO staff participated in the bimonthly meeting regarding Employment for persons with developmental disabilities in Imperial Valley. Updates on WIOA and ABX2 1 Legislation were discussed. During a discussion on the topic of training the organizations in attendance were very interested in collaborating as a way to offer local trainings to their staff. They were also very interested in having a discussion surrounding data collection and reporting methodology and this will be addressed at the next meeting. The issue of transition and transition services was also talked about and the group felt a separate meeting should be held. This meeting is targeted to be held in the fall and invitations will be sent to other organizations who are also involved in providing or funding transition services in Imperial Valley. Arc Imperial Valley, Community Catalysts, Imperial County SELPA, Department of Rehabilitation, Work Training Center and San Diego Regional Center were all represented at the meeting and 11 people were in attendance. - OCRO staff coordinated and accompanied the Orange County SSAN Representative on a tour of Goodwill Industries Orange County. The Senior Rehabilitation Counselor introduced us to their newest facility for all of Orange County, including the updated conveyor system designed to improve performance and reduce work-related injuries. The facility also houses the Goodwill Industries VA Program; we were also able to meet the VA program manager and see the supports offered US Veterans to assist them in accessing gainful employment. At this meeting, the following topics were discussed: (1) Workforce Innovation and Improvement Act (WIOA) and the provider letter that went out to vendors last month; (2) SCDD Cycle 39 RFP; (3) Updates to the OCEAN Employment and Resource Fair in October; (4) CMS Settings Rule; (5) SCDD event and training opportunities; and (6) how vendors are handling insurance and worker's compensation increases. OCEAN, established in 1991, is a professional association that assists members and employers in creating employment opportunities for individuals with disabilities. (People Active 5 OTH)
- OCRO staff met with the North Orange County Community College District transition counselors, School of Continuing Education trainer, and Anaheim School District transition staff to discuss the ins-and-outs of the transition process, including but not limited to: Linking qualified students to RCOC, DOR, SSI, IHSS, and CalOptima; importance of accurate school evaluations to assist with regional center eligibility; Non-credit classes and the implications/benefits for students with disabilities; mobility training; Workability III, College to Career (C2C), and Independent Vocation & Educational Supports (IVES). As well as all the various work incentives available to assist those with disabilities continue to collect social security benefits and wages without fear of premature dis-enrollment of benefits. (People Trained 9 SA/ 8 FA/ 10 OTH)
- SACRO, on Friday, May 27th SCDD staff participated in the Stakeholder Meeting on New Employment Initiative at DDS. It was an all-day meeting to get input on the new paid internship program and incentive program (Assembly Bill X2-1). There had been a stakeholder meeting in Southern California previously. DDS staff will take the input from both of these meetings and develop their guidelines for implementing this new program by the end of June. Funding is about \$20 million, half for the Internship program and half for the Incentives program. The goal is to increase CIE for people with I/DD in California. The Paid Internship Program allows up to \$10,400 during 1 year to pay the "intern with I/DD" in a CIE job. It would not be required that the employer hire the individual at the end of the internship, but it would be the goal. The plan is that individuals would be able to intern in challenging integrated positions and both increase their skills and increase employer familiarity with the skills and abilities of an employee with I/DD. The Incentives Program would reward the Supported Employment agency for making a successful CIE job placement. Beyond the regular vendored hourly payment schedule, they would receive a bonus of \$1,000 for a successful CIE placement, \$1,250 after 6 months of continued success, and \$1,500 after 12 months of continued successful placement. - LARO staff participated on the Electro Convulsive Therapy (ECT) Review Committee for a client served by Westside Regional Center on May 27, 2016. Pursuant to California Code of Regulations, Title 17, Division 2, Chapter 1, Subchapter 8, Section 5080(j) and Article 4, Section 50830-50835, a four-member panel made up of two board-certified, California licensed psychiatrists, a representative from the Department of Developmental Services who functions as a Clients Rights Advocate, and a representative from the State Council on Developmental Disabilities, Los Angeles Office must assemble for the purpose of approving or denying the proposed ECT treatment plan for the individual. On this date the ECT treatment plan was approved. (ORGs 5 OTH)
- NBRO staff attended the Sonoma County Special Education Local Plan Area's (SELPA) Community Advisory Committee (CAC) meeting. A presentation was provided to meeting participants on education relate counseling services. Areas covered were: what are the services and why would a student need them. - NCRO staff assisted the Behavioral Health and Recovery Board, Community Stakeholders committee members research and write a housing report for the Board of Supervisors and Mendocino County Health and Human Services Agency, Members are attending the Homeless Continuum of Care Committee to advocate for more housing for low income, Behavioral Health clients and people with disabilities. Several projects being worked on are a 30-40 unit complex, the Tiny House project and winter shelter. (ORGs 9 OTH/ Public Policymakers Educated 5 OTH)
- NSRO staff participated in the Butte County Coordinating Council (BCCC) and serves as Secretary. Staff organized a presentation from the Housing Authority of Butte County for the May 16, 2016 meeting. Doug De Soto, Housing Authority of County of Butte, provided information on Section 8 Voucher Program including specifics about the program operationally, and reported that 2/3 of the people served are elderly or disabled populations. The Section 8 Voucher Program is a rental assistance program and a person who is interested in applying, must be free of criminal activities for the past 3-5 years. Doug reported they work with Legal Services of Northern California (LSNC) to take a look at legal issues. He shared they will not accept a person with a methamphetamine charge. The Section 8 Voucher Program maintains a list of 2,000 people and about 18 people leave the list for various reasons, which opens new slots for people to be added to the list each month. The Section 8 Voucher Program opens the list every November for people to apply to be considered for the program. Doug discussed Public Housing Program and reported there are a total of 325 public housing units. The waiting list for Public Housing is open all the time and could be an 18-24 months waiting period. He discussed 2 collaborative programs between HACB and City of Chico programs: Lease Guarantee Program and Tenant-Based Rental Assistance Program (TBRA). The City of Chico's Lease Program assists Chico households that face barriers in qualifying for housing. - LARO staff reviewed the ABLE Act Webinar entitled Becoming ABLE Ready for the purposes of updating our presentation materials with the most current information. Several additions were made based on this webinar.
- LARO staff participated in the monthly telephone conference of the Paratransit Riders' Coalition. Discussion was about vehicle space for individuals who can transfer from wheelchairs, common topics to share with providers, whether to include providers on monthly calls (consensus was no), whether to invite another provider to meet with the group or instead continue the discussion with the first provider (consensus was to meet with a different one next), various driver wayfinding issues, and SCDD staff again brought up the issue of online reservations which still is not an available option. - NCRO staff facilitated a meeting between the City of Ukiah and the Alex Rorabaugh Recreation Center to discuss the difficulties in providing and accommodating inclusive programs at the Recreation facility for about 110 participants. - NCRO assisted with the outreach to notifying the community about activities at the Autism Awareness Concert and attended the event held in Ukiah CA. There were performances by individuals with Autism and other Intellectual and Developmental Disabilities. The Recreation center has been involved in providing dances and other programs at the ARRC for developmentally disabled, Special Olympics and other kids and adults with disabilities to improve opportunities to be out in the community and to meet the strategic plan goals of being an inclusive recreation center. Staff assisted the Special Olympics program in Ukiah to schedule their use of the building for basketball practice in Jan. and Feb. of 2017. The Lesbian, Bisexual, Gay, Transgender, Queer Chapter in Mendocino County, (LBGTQ) hosted a first ever Prom in Ukiah with about 70 in attendance. The ABC Day programs serving intellectually and developmentally disabled and folks with Autism are also using the Recreation center once a week to provide a variety of recreational activities as well as self-advocacy workshops. - OCRO staff communicated with 28 parent support group representatives to arrange for training on Self-Determination and/or other topics of interest to members. The responses to date have been positive and there is definite community interest in learning how their current service delivery system may change to better support their family member(s). Requests for training and coordination of dates/times are currently underway with the interested groups. (People Trained 28 FA)

The VAC is comprised of service providers who volunteer their time to attend meetings where service provider needs, issues and concerns are shared and discussed with RCOC. The VAC members serve a vital function as representatives of the service provider community as a whole, providing advice and counsel to the Board. (ORGs 37 OTH)
- SACRO staff and Self-Advocate, Lisa Cooley initiated a meeting with the Executive Director of the California Foundation for Independent Living Centers (CFILC) Teresa Favuzzi which convened on May 16, 2016. Programs and Coalitions cover an array of people they serve on the independent living center level. To assist in focusing on each of the important areas of advocacy, they have created programs to drive those needs. State Independent Living Centers (SILC) are local agencies and Governor appointed, California has 18. Given that SILC's are charged with serving people with developmental and intellectual disabilities as well, SCDD learned that the SILC's are interested in vendorization with regional centers. SCDD staff shared SCDD's state plan, mission and vision. The program will prepare students to work in non-profit and public health, social service and/or behavioral health organizations that provide prevention, clinical intervention and treatment services for at-risk children, youth and families. Those who earn a certificate can be employed as a community health worker, outreach worker, social services aide, mental health worker, substance abuse/addictions worker, youth worker, or peer paraprofessional. Through this collaboration discussions have initiated new course curriculum that will be offered in the Fall of 2017 that will benefit the community with respect to two key underserved populations: Working with Transition Age Youth and Working with Tribal Communities. As an ongoing collaboration between the two agencies in an effort to serve monolingual Spanish-speaking families in Orange County, the SCDD Orange County Office hosts all of Fiesta Educativa's parent support group and committee meetings. - NCRO staff facilitated a training on May 11th as part of the Behavioral Health Boards Cultural Diversity committee and strategic planning process. The Collaborating agencies included County Office of Education, Mendocino College, Behavioral Health and Recovery services. The training was provided by Ricardo Stocker, Ph.D. is a Doctor of Philosophy in Psychology. As a professor of Psychology and Communication at Mendocino Community College he teaches various courses on counseling and cross cultural interactions and diversity as well as practical therapeutic approaches based on relevant and appropriate cultural understanding. - HQ - As always, time and money represent significant barriers to effective training for first responders, who are regularly trained in topics associated with 'perishable skills.' Training time - spent away from regular assignments - is costly to departments, both financially and in available manpower. Law enforcement officers also (until they've taken/completed the training) don't often 'get' the correlation between disability-related information and what they perceive to be more 'mission-critical' training. Once training has been completed, however, officers routinely express appreciation for information that often has more value to them - both on a personal and a professional level.
- HQ There is some resistance to training on these issues by those in the social work fields. The prevailing belief appears to be that they already 'know' people and that their acquired knowledge, experience and skills are directly transferable to working with people with I/DD. While this is (largely) true, people with I/DD also have some unique needs and characteristics that must be respected, valued and taken into consideration by those who come alongside to assist in the aftermath of violence and trauma.
- LARO All of the parents expressed that at some point they all had either engaged or were planning to engage in due process with their districts. Much frustration was voiced because all of the parents felt the school district consistently told them lies about their rights, information about their children, and many processes. Strategies and technical assistance effective in combating this were provided to all of the parents.
- LARO An SDAC member who is also working with Citrus College (one of the community colleges in California) approached SCDD LARO staff mentioning there is a need to build a similar program like Taft College to serve students with I/DD in LA County. He invited SCDD LARO staff to their next planning meeting in July
- LARO It was requested by the public to have the SDAC meeting agenda be posted on SCLARC's website 10-day prior to the scheduled meeting. Bagley-Keene Open Meeting Act training was provided by SCDD LA staff in the past. SCDD LA Office staff will continue to monitor the compliance with BK Act.
- LARO Many complaints were voiced concerning the excessive wait times for DDS to submit the waiver application to CMS and the fact that DDS has never met any of the deadlines it has set for itself to do so. Additionally, there was discussion about not holding any more SDAC meetings until DDS submits the waiver application to CMS. Ultimately it was decided to hold a meeting in June to see if

DDS submitted the waiver, giving the committee a chance to provide input to DDS about it.

- LARO Minutes for WRC board meeting have not been distributed since October 2015. SCDD staff requested a copy of the outstanding minutes a few days prior to this board meeting. No response was received however all minutes were made available at this board meeting.
- LARO Self-advocates reported an increased need to utilize free or low cost services in the community. SCDD Los Angeles staff provided the group with copies of the "Bandaging the Budget" publication from the Self-Advocacy Board of Los Angeles.
- LARO Statistics and feedback from community inputs indicate that individuals with I/DD are at greater risk of abuse, neglect, and criminal victimization. There are pressing needs for different agencies to collaborate and leverage their resources to safeguard this vulnerable population. Local law enforcement agencies and disability services organizations need to work together to explore cross-training opportunities and inter-agency coalitions to close the gaps in different service systems.
- LARO The fear of losing SSI benefits while working gainfully has posed ongoing barriers for SAs pursuing competitive employment. LARO staff provided training opportunities and resources, such as DB101 and the "Why Work is Better" brochures with participants.
- LARO The low response rate for its NCI surveys and possible solutions to address the concern were discussed. The solutions include attaching SCDD QA Postcard and survey cover letter in English and Spanish, and advising its Case Coordinators to remind clients to respond to the surveys.
- LARO The Westside Regional Center (WRC) Political Action and Outreach Committee (PAOC) did not have access to the latest information concerning ABx 2 1. SCDD Los Angeles staff provided the PAOC a summary of the major provisions of ABx 2 1.
- LARO To access affordable and accessible housing in the LA region was identified as one of the pressing needs. The low response rate for its NCI surveys and possible solutions to address the concern were discussed. The solutions include attaching SCDD QA Postcard and survey cover letter in English and Spanish, and advising its Case Coordinators to remind clients to respond to the surveys.
- NBRO Due to local Regional Center high rate of staff turnover, SA/FA are not

familiar with who their service coordinator which in turns often times causes delays in, or denials of, service needs.

- NBRO Parents are not aware that they have the right to request a social emotional assessment at any time and that the school district must respond to the request no later than 15 days.
- NCRO As of the date of this report, several issues need to be resolved before the project can move forward.
- NCRO Free resources were given out some, but not all, materials were available/translated into Spanish. More training for those who work with the disability community needs to happen especially those from the Hispanic community.
- NCRO Services not being provided by Spanish caregivers and professionals and lack of outreach to the Latino community. Latino community not being reached and percentages being served are low.
- NCRO When hand outs and discussion documents are received only a few days before the meeting, the self-advocate member-who has a very busy schedule-and facilitator do not have adequate time to review the subject matter prior to the meeting.
- NSRO Community members and agencies have expressed the need to address the chronic and pervasive shortage of qualified candidates/job applicants in the community for positions in the human resource field that have the knowledge skills and abilities to work with underserved populations including individuals with intellectual and developmental disabilities. Staff is particularly interested in supporting the effort to build capacity in the area of Native American and Latino program graduates who are able to effectively work with Native American and Latino transition-age youth (16-25 years old) and their families in a culturally and linguistically appropriate manner.
- NSRO In Home Supportive Services (IHSS) is experiencing many changes around the FLSA Overtime regulations. The new regulations are challenging the recipients, care providers and Public Authority IHSS program staff. Staying educated on the changes is essential to maintain program services and avoid unnecessary violations.
- NSRO Staff has developed a strong relationship with Housing Authority of Butte County and will be working to develop connections with the Housing Authorities in the other 8 counties of the region. Community advisory groups like BCCC, bring agencies and issues together that support connections. The information and

awareness of housing programs through Housing Authority of Butte County has increased awareness and increased housing opportunities for Butte County consumers and families.

- NSRO Staff provided support to SSAN Officers to organize the upcoming June 8-9, 2016 meeting. Through 2 planning meetings (5/4 and 5/18) technical assistance was provided regarding coordination, note taking, agenda development, etc. Numerous communication occurred prior to and following each meeting. (People Trained 4 SA)
- NSRO The information provided by the law enforcement agencies revealed some of the following information: Shasta County stated "Crime Victim Assistance Center has provided services to approximately 100 subjects with disabilities out of the 9,000 cases so the overall percentage of cases that involve subjects with disabilities is low." "Out office does not participate in PERT." Trinity County stated "estimated number of requests for assistance/information from victims with disabilities - 15 (6.75%) and our agency does not participate in PERT or a multi-disciplinary equivalent at this time." Siskiyou County stated, "Unfortunately we have no way of providing this information. We don't ask people about their disabilities and we do not document this information in any way. Regarding PERT, we utilize the services of Siskiyou County Behavioral Health." Redding Police Department stated, "We do not track calls handled by our agency and our agency does not participate in PERT or a multi-disciplinary equivalent." Butte County stated, "Our records does not track data of that nature and there is no way to give you an estimate that would entail any degree of reliability". "I am pleased to report that the Butte County Sheriff's Office recently entered into a collaboration with the Chico Police Department, CSUC Police Department and Butte County Behavioral Health." Tulelake Police Department stated, "5-10% call are from subjects with disabilities; Do not participate in PERT."
- NSRO The SAAC Chair participates on many committees and projects. Despite having facilitation support, staff have to remind both the Chair and his facilitator of what he committed to and/or planned for upcoming meetings. Staff has often had to assist in writing the Chair reports since the Chair and/or his facilitator forgot to do it.
- NSRO The SSAN officers have been very clear that meetings are to be member led and have a history of not being productive without staff assistance. Assistance was provided with updating the workgroup calendar, providing meeting announcement templates and reminders by emails and calls. SSAN

workgroups established their Purpose, Goals, and Objectives last year and staff continues to remind members on what they said they want to accomplish.

- NSRO There are 3 SSAN officers but only 2 participated in each meeting. Officers will commit to doing various activities but then do not always follow through. Staff continues to provide reminders of the commitments and this often results in the SSAN Chair doing the work of the other officers.
- NVHRO Lack of clear understanding by the public in regard to services available and how to access support for transition age students in San Joaquin County.
- OCRO A Community Care Licensing form (200A) has received attention from the CCL Policy Unit Manager in Sacramento regarding non-ambulatory licensure to provide care for children who are unable to exit independently in an emergency. Due to the phrasing on the current form, it would require multiple additional steps (and money) to obtain a non-ambulatory license. CCLD indicates they will remove #11 from the form to remedy this situation. The time line for this change to the form is uncertain.
- OCRO Although the Summit referenced IDEA, ADA, Ticket to Work, WIOA, and AEBG the fact remains that those with Autism generally do not transition well, if at all, into post-secondary education or training. According to the TPI data, upwards of 50% do not have a realistic sense of work, an interest in a specific career, or have realistic career goals. The Thompson Policy Institute will continue to collect data and provide analysis to help stakeholders determine proper and effective areas of focus for policy recommendations
- OCRO In fiscal year 2013-14, HMG served 2,345 family members and 884 professionals and of those family members served, 64.5% have Medi-Cal/CalOptima as the primary insurance provider and 62.7% have an annual household income less than \$29,000. HMG Community Liaison reported that a lot of parents they serve need more education and help to better advocate for their children with disabilities in navigating the California DD service delivery system and hence the rationale for the partnership.
- OCRO Overall, RCOC spends \$23,108 per White consumer (all ages), \$15,073 per Asian consumer, and \$12,112 per Hispanic consumer (2016 data). There is no doubt a similar trend in Hispanic students receiving special education services, as many parents at today's support group said that their children with disabilities who qualify for special education are not receiving a free and appropriate public education (in their opinion) as identified by lack of services to support IEP goals.
- OCRO RCOC has 81 consumers remaining at Fairview Developmental Center,

yet there appears to be little resource development and/or active push to transition those residents into the community. At the last South Coast Regional Project Meeting, it was evident that RCOC was under performing as far as active transitions compared to the other regional centers. In March, RCOC only had 1 consumer identified to be placed by the end of the fiscal year, compared to the 6-7 consumers from the other RCs.

- OCRO Several employment vendors discussed challenges in creating new group supported employment sites due to minimum wage requirements. Similarly, local school districts reported that they are struggling to secure Workability/TTP sites due to restrictions with DOL requirements and inability to use for-profit sites.
- OCRO Several stakeholders are concerned about whether the outreach and enrollment sites for SB 75 will have to report enrollees to Immigration and Custom Enforcement and if this will potentially jeopardize a person's future citizenship/residency status if they will be classified a public charge.
- OCRO The Dayle McIntosh center highlighted the fact that transportation training was recently limited to only work and/or school; no longer allowing "recreational" destinations. Although this makes sense, it also puts the consumers at a disadvantage because they are no longer able to experience or prepare for transfers or other changes that may occur outside of their regular route.
- OCRO The Fiesta Educativa Annual Conference is the only major Spanish-speaking conference of its kind in Orange County. This conference is needed in order to educate the Hispanic community and monolingual Spanish-speakers about the services and supports they are entitled to receive under the Lanterman Act and/or IDEA and how to go about advocating for such services.
- OCRO The Orange County Transportation Authority/Access Services provided timely service for the start of his tour; however, they did not pick him up within the allotted time-frame. This is not a new systemic issue in Orange County, but is problematic for the safety and security of those with disabilities.
- OCRO The statewide housing crisis facing adults with developmental disabilities is starkly evident in Orange County, which is home to 19,000 persons with developmental disabilities served by RCOC. Many of these adults are struggling unsuccessfully to reach their goal of securing safe, decent and affordable housing in the communities where they were born, raised and educated. They are priced out of even a basic one-bedroom rental apartment in Orange County. As a result, they are forced to continue living with their aging parents or living in other living arrangements.

- OCRO There is a licensee in Orange County that presently operates 5 CCFs, serving about 20 consumers in total. This facility is pending possible (but likely) licensing revocation and the facility operator is trying to garner support from all consumers, families, and even agencies to prevent any negative licensing action. This licensee is also facing Department of Labor action due to employee overtime issues. RCOC is trying to secure back-up placement for the consumers should revocation occur, but there are very few CCF vacancies in Orange County especially for those with higher level of care.
- OCRO There is one individual whose husband of 15 years ago passed away a few years prior; however, SSA informed her that she is not eligible for widower's benefits. She expressed difficulty communicating with SSA and understanding their verbal and written correspondence because they don't say/write things in a way that is easy to understand. She said that this is one issue this self-advocacy group would like to address with SSA.
- OCRO two issues arose from this meeting: (1) school districts misidentifying students with an intellectual disability as having a learning disability, which adversely affects the student's chances for regional center eligibility due to the exclusion of the latter diagnosis in Title 17 and/or school evaluations not providing an accurate portrayal of a student and not thoroughly documenting needs that it renders the school reports useless for regional center eligibility purposes; (2) whether school evaluations negatively affect eligibility for the Latino population, specifically.
- OCRO While RCOC posted the agenda on their website 10 days in advance of the meeting, they failed to send an email to those on the interest list until the day before the meeting. All parents in the audience reported that they received the email notification of the meeting the day before at 4:30-4:50pm.
- SACRO Day program vendors voiced concern as ACRC requires a 30 day notice to terminate a client from a program, however many vendors do not receive the same 30 day notice when a client chooses to leave and ACRC does not continue payment for the 30 days (Title 17 says both parties must give 30 day notice). ACRC explained there are circumstances which do not allow them to pay 2 vendors if the consumer chooses to change programs abruptly although ACRC will encourage staff to discuss the protocol of the 30 day notice to clients.
- SACRO DDSO staff are concerned that the consumers they serve will not be able to adapt to community inclusion, and the Executive Director reports he gets resistance from staff when he reduces a class size from 12 to 6 students. Some

quotes from our meeting. "They are content, they want to be with their peers". "Like full inclusion in schools, I don't see the purpose".

- SACRO Families continue to need additional information about the transition process from school to adult programming. They welcome information about conservatorship and special needs trusts, as well. Families are overwhelmed by the day-to-day care of their special needs children and can benefit from as much simplified and accessible information as possible.
- SACRO It was presented to the audience that the Self-Determination waiver has not been signed at the Federal level, therefore the Department of Developmental Services cannot implement this service to consumers at this time. Self-Advocates feel it necessary to spread the word to peers so that they will be aware of the upcoming service and get on the list at their Regional Center if they are interested.
- SACRO Lack of affordable housing is a concern and mostly due to the untapped resources such as Mutual Housing offers that could benefit people with I/DD. Barriers to implementation and/or access to this development in communities we serve is due to the lack of information sharing and lack of awareness of our population and their needs. Individuals with I/DD are at risk of homelessness based on SSI rates and high rental costs. SCDD staff is assisting in bridging the gap between Mutual Housing and the regional center to eliminate the barrier.
- SACRO Many agencies spoke about the LEAP program, however, that does not always assist people we serve sufficiently, depending on their disability. They may need additional assistance to go through the hiring process and become successfully trained and employed.
- SACRO Parents who advocate full inclusion are a valuable resource to other parents and school personnel. Barriers to children receiving education in a regular classroom are most commonly due to parents need for support, education and advocacy for the child/family to pursue what should be readily available and offered through the school district. IEP trainings including empowerment of parents in this pursuit is needed.
- SACRO Participating in People's First Chapters is a great way for self-advocates to learn about services and learn to speak up for their rights. Members in these chapters are very active and increase their knowledge and skills as the result of each training and meeting. It is exciting to work with this group of adults who are so eager to be involved and have a voice! Increasing outreach to individuals in board and care home will help those individuals increase their self-advocacy

skills.

- SACRO Self-advocacy is stronger when an individual has confidence in speaking and sharing their hopes, dreams, goals, and support needs. This session gave each individual the opportunity to reflect on the power of speaking confidently to be heard and help achieve their dreams.
- SACRO Self-Advocates need some assistance to prepare their "Go Kits", make plans, and write and post appropriate emergency information in their homes and to put copies in their "Go Kits". Many were affected by the fires in 2015 and during the earthquake of 2014. They understand the need to plan but require some assistance to complete the process.
- SACRO SILC's rarely receive a referral from a consumer with an intellectual disability, however, SILC's are mandated to serve any and all disabilities and on this date discussed the possibility of becoming vendored with the regional center.
- SACRO The IPP and Person Centered Planning process are both important to assist adults with I/DD to identify their dreams, goals, and the supports they need to achieve them. They often need additional information to help them understand realistic goals and to support them in achieving them.
- SACRO The lack of appropriate dental care for people with I/DD, especially needing sedation dentistry, was raised several times. CA H&W suggested inviting DHCS (Dept. of Health Care Services - Dental Division) to the next Community Connections Forum.
- SACRO There is a new MOU to improve multi-agency collaboration among DDS, CDE, and DOR to increase competitive employment for people with I/DD in CA. Only 9% of I/DD in CA are employed. Among the general population, 70% participate in some sort of employment. The goal is to increase the 9%, however, over the past few years, this number has decreased. It is hoped that these programs will encourage and support CIE opportunities.
- SACRO With changes in medication benefits through managed care and fee-for-service Medi-Cal, medications are often changed from Brand to Generic. This change can cause problems for people with disabilities, some of whom have health issues and take multiple medications. They can be encouraged to learn their medication names and dosages and to discuss any changes with their pharmacist.
- SDIRO Parents still desire more educational opportunities. Several parents want to work on developing resources for yoga and other ways to teach their children relaxation techniques.

- SDIRO SCDD staff provided facilitation support to San Diego People First officers as they prepared for their annual self-advocacy conference and debriefed over the May Quarterly meeting. The group also had an update on the Strengthening Self Advocacy grant project. (People Trained 9 SA / 2 OTH)
- SDIRO The group reviewed the plans for the upcoming presentation to be held at the annual self-advocacy conference and discussed follow up on leads to conduct presentations at other locations. One organization that had the training several months ago requested a follow up training on self-advocacy for 30 of the programs participants. The group set a date to create that presentation (People Attained Membership on Boards 6 SA/ 2 OTH)
- SDIRO The numbers of individuals with disabilities who are registered to vote is low. In addition many individuals with disabilities are unaware of their right to vote and the accommodations that can be made to make voting more accessible.
- SDIRO There continues to be a concern expressed by families that there is a lack of training and understanding of the services available for their child.
- SEQRO Because the SCDD no longer offers direct advocacy and the need continues to exist, the Sequoia office has opted on assisting families in this way so as to continue providing more individualized assistance without direct advocacy.
- SEQRO Because the SCDD no longer offers direct advocacy and the need continues to exist, the Sequoia office has opted on assisting families in this way so as to continue providing more individualized assistance without direct advocacy.
- SEQRO Families are unaware of what IHSS is for and they often fail to access it because they don't even know it exists. The SCDD has developed a one-page handout which we provide at all events that the Sequoia office is involved in.
- SEQRO Families do not understand the resources limitations and what they entail. SCDD went over those limitations and the families seemed to better understand the program at the end of the presentation.
- SEQRO Finding a venue that can accommodate over 400 participants that is accessible and affordable is still proving to be an issue but the next meeting will be going to a few locations to find out if they meet the needs of the conference.
- SEQRO Mendota High School is in a little city that is surrounded by fields. The population is 90% migrant workers and it is hard for them to come to events like this because they work long hours and are just trying to survive. The Director of Special Education was really happy with the turnout of this event. He really

appreciated our office being there.

- SEQRO Spanish speaking families appear to encounter substantially more problems with both understanding their special education rights as well as receiving appropriate services from the school districts in certain areas. When staff polled the families on whether they had an email account, only 2 of 20 raised their hands. Most stated they did not use the Internet. This is a barrier to staying in contact with the school personnel and documenting concerns as well as accessing special education resources. Parents would benefit from a hands-on training at a local library on how to utilize email and the Internet as it relates to learning about special education and creating an on-line paper trail of communication with school district staff. The rapidly widening technology gap has created an inherent disservice to the lower income Spanish speaking community.
- SEQRO The San Joaquin Valley has long suffered as the epicenter of the nation's housing crisis. As of December 2011, unemployment rates ranged between 14.7% in Madera County to 18.7% in Merced County, well above state and national averages. Poverty rates are also some of the highest in the nation, ranging from 15.7% in San Joaquin County to 24.6% in Merced County, as of the 2010 census. Additionally, several valley cities have consistently ranked in the top five hardest hit foreclosure areas in the nation, with 1 in every 140 housing units in San Joaquin County in foreclosure in January 2012. These already sizeable challenges have been exacerbated by the loss of redevelopment agencies and consistent budgetary uncertainty among local agencies which makes it harder for people with developmental disabilities to access housing.
- SEQRO There is a large monolingual Spanish speaking community in Kern County and it is difficult for the families to obtain services because the districts do not always have Spanish speaking staff.
- SEQRO This conference, unlike most in the Central Valley is designed to reach out to the monolingual Spanish speaking community. Unfortunately, there isn't many opportunities in the area for parents to turn to for education on services related to people with developmental disabilities.
- SVMBRO Housing vouchers are offered to those with low and no income. Special populations can be designated. Generally, veterans, homeless, elderly, and physically disabled have been identified. There is a need to increase the awareness of the Housing Authority about the housing needs of those with developmental disability.

Emerging Issues

- SVMBRO Individuals with I/DD would clearly benefit from ongoing rights/self-advocacy training. The individuals who attended were all in post-secondary programs. In the future, we hope to have individuals who attend day programs attend and extra outreach to the day program community will be necessary.
- SVMBRO Slow roll out of Self Determination in California is prohibitive. The committee has agreed to focus activity on Outreach. Currently the SDAC is working out its role as an advisory group to the regional center.
- SVMBRO Spanish speaking families appear to encounter substantially more problems with both understanding their special education rights as well as receiving appropriate services from the school districts in certain areas.
- SVMBRO The data indicates that non-white individuals live at family home further into adulthood than whites. Review of this circumstance can be helpful in directing developmental services to be more aligned with the residential needs of the communities being served and are services culturally competent at the residential service level?
- SVMBRO The Disability Collaborative is dedicated to preparing families for transition of children to adult services. This is the third Summit being planned.
- SVMBRO The representative from Williams Syndrome Association reports that the severity of the disability is often misunderstood by the provider community. Families have difficulty getting IHSS, Special Ed, and DDS services. Increasing awareness of the disability and services needed is a priority of the organization and has requested SCDD provide the support and technical assistance to meet their goal.

EMERGING ISSUES (Please describe emerging issues that have been encountered for this month while delivering Technical Assistance)

NCRO	Issue: Apparent lack of understanding of some city employees and rights under the American's with Disabilities Act (ADA) Staff Action: Staff took the opportunity to provide informational guidelines from the Department of Justice to help the city employees better understand their responsibility to the full community and compliance with the ADA.
NSRO	Generic services are confusing for people to access and obtain proper information of location, phone number and thorough assistance.
NSRO	Information about WIOA remains confusing and there needs to be more training for students, families, employers and community agencies in general.
NSRO	More information and training on Housing information and programs throughout the region is needed. People are confused on how to access housing and the housing programs.
NVHRO	We refer quite a bit to DRC OCRA and would like a mechanism to track what happened as often times we are called back and are told no one could or would help them.
SVMBRO	The Spanish speaking community disproportionately lacks information and resources to understand special education and other relevant rights in order to engage in effective advocacy for their family member.
SVMBRO	There appears to be a lack of post-secondary options within a specific school district
LARO	Many of those to whom technical assistance was provided regarding both special education and regional center reported they believe staff from the various agencies have lied to them.
LARO	Encountered new issues which are related to the right to accommodations in higher education.
OCRO	RCOC terminating daycare funding at age 18, even though the need still exists after age 18 because the adult child still requires supervision during the time he/she gets out of school/program to the time parent comes home from work
OCRO	RCOC refusing to fund for another service, such as PAS or daycare, while the consumer is receiving ABA therapy due to parent participation provision – SCDD is supporting legislation AB 2809 - as there are many families whose children receive ABA after school while the parent is still at work.
SBRO	Parents of IRC consumer called to report that IRC CSC informed them that there was no Self-Determination Program within the Inland Empire.
SBRO	SBRO 12 Action: This concern will be added to the agenda for the monthly meeting that SBRO has established with IRC on June 13 th with Associate Executive Director at IRC.
SBRO	Family Advocate called regarding rights of residents within CCL & IRC vendored facilities. Mother has issues because daughter was prescribed a special diet due to her food allergies and the care provider is requiring the resident to pay for her own food. Also, the water tastes

	bad at the facility and the residents are required to purchase their own bottled water. Referred mother to OCRA, Ombudsman, IRC/CSC, IRC QA liaison, County Water Department, Public Health and emailed referral resources along with 4731 complaint form. Mother responded to email and stated that she had tried to call IRC (4) times and could not get through to a live person. She called a number on the pre-recorded message for care providers and got yet another pre-recorded message about training coming up in 2014.
SBRO	SBRO 12 Action: This concern will be added to the agenda for the monthly meeting that SBRO has established with IRC on June 13 th with Associate Executive Director at IRC.
SDIRO	Generic parenting services are sometimes very complicated and confusing for people with disabilities and there are limited programs that are available to meet the need of the parents.
SDIRO	Information about WIOA remains confusing and there needs to be more training for students, families, employers and community agencies in general.
SDIRO	More information and training on recreation programs throughout the region and how to access them if modifications or additional supports are needed.
