The Home and Community based waiver needs to be included in the curriculum for self determination meetings.

Person centered planning Is not the IPP but it is what an IPP is supposed to be. It's more than an IPP.

Goes through important factors of the individual

History that is immediate is important right now not necessarily like the birth history of an adult

The person is the critical person and also the members person in the family and friends

Goals what would the person like to do in life and dreams

Then work towards services needed to achieve that

Could include medical professionals may not be able to get all these professionals at the same time so you can do a pre plan

Presuming competence is the foundation

Reframing behavior as behavior is communication

Respecting cultural diversity

Provide supports health and safety across the lifespan

PCP individuals helps plan their lives with friends and supporters involvement and understanding of the individual

Strengths, hopes, preferences of individuals use these to put together a plan for the life of the individual.

Two main concepts

Dignity of risk-- tip toe around as though they should not take risk. Give them a choice.

Conservatorship--once you make conservatorship the person with a disability has permanently lost their right; not irreversible actually (Irene Padilla). Court is to keep accounting and review.
