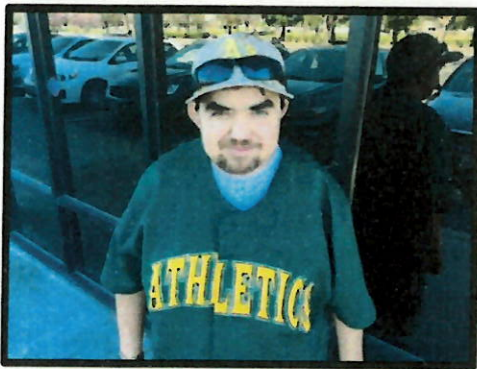


# SAC 6 Chatter Letter

## SAC6 Members SPEAK UP



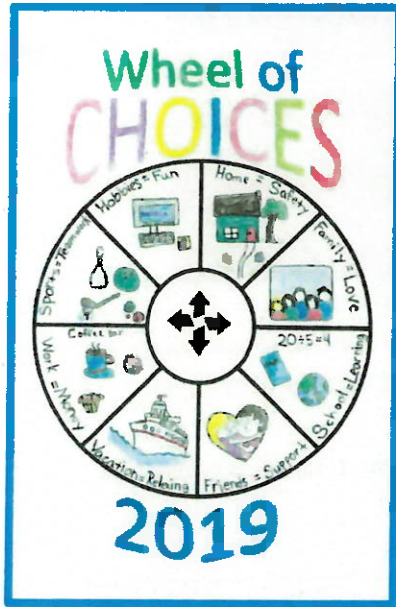
