Cycle 43 Grants

The Council acted to award Program Development Grant (PDG) Cycle 43 funding at the regional level in the amount of \$20,000 for each regional office for a total \$240,000. The State Plan Committee will be presented with the scoring team's recommendations for consideration for Grant Cycle 43.

While all regions received at least one response, not all responses passed administrative review or received scores high enough to be funded. The Committee will discuss options for the remaining funds.

Action Recommended

Recommend approval of the scoring team's recommendations to the full Council at the July 14, 2020 Council meeting. The Committee may also make additional recommendations to the full Council on the use of remaining Cycle 43 Program Development Grant funds.
