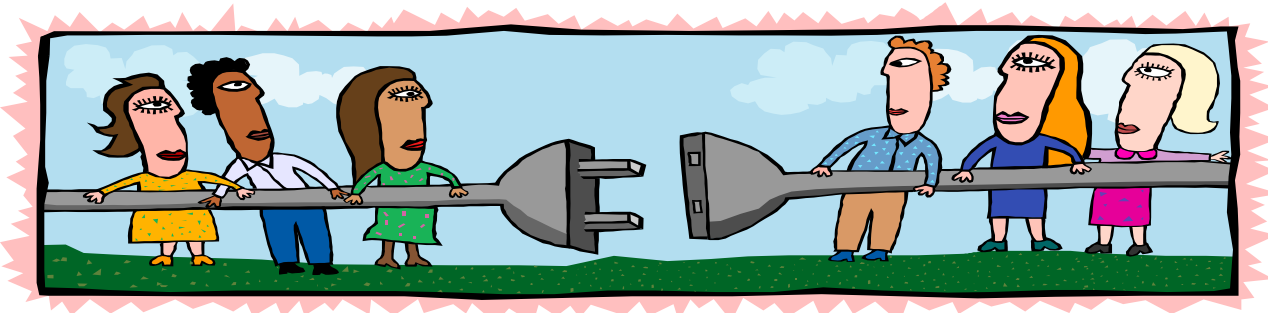

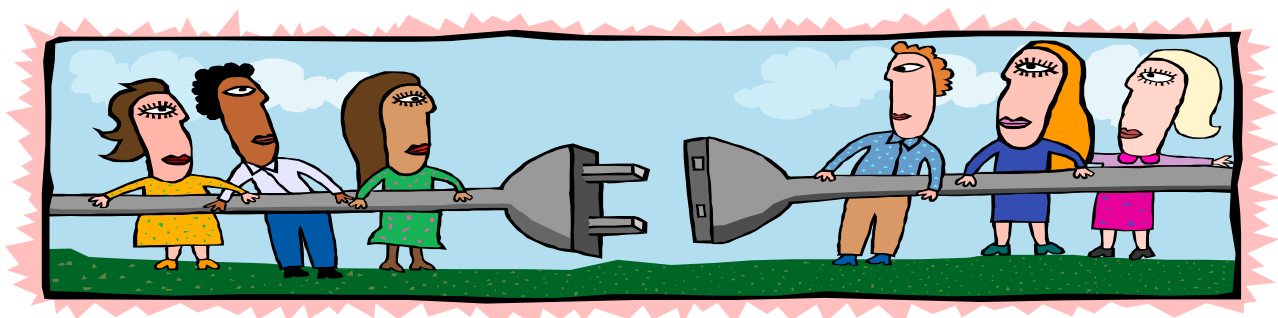

6:30p Call to order/Introductions

- Sheraden Nicholau gave meeting housekeeping information.
- Valerie Buell conducted the voice roll call and invited guests to introduce themselves using the Chat function and invited the legislative guests/representatives and anyone from an organization to include contact information in chat.

6:35p Approval of Meeting Minutes for September 30, 2020:

6:40p Public Comments:

- Mariana Gorelik (FA) shared experience of trying to help her daughter with Medi-Cal redetermination issues. She shared that Medi-Cal staff at the local SF office incorrectly determined her daughter's eligibility status for the Medi-Cal program she has been enrolled in. This has happened multiple times, she reports. As a result, she had experienced interruptions in service eligibility and the family has put hours of work each time into correcting Medi-Cal's mistakes. This may be a systemic barrier for people with disabilities in accessing their Medi-Cal benefits, putting their health care access at risk.

- Senator Scott Wiener: Thanked Mariana for sharing her story and her work. He and his office would like her to give her contact information so they can help. He reflected on the impact of COVID and discussed the importance of learning from what we are going through and correcting inequities, so we can improve / get better. We need to make sure we are meeting people's needs, including healthcare needs. As an example, he authored legislation that requires insurance companies to include mental health care.

7:02p Greg Giguere of the San Mateo County District Attorney's office gave a presentation on Domestic Violence (DV). After the presentation, the RAC held discussion, and Q&A. Some highlights are:

- Women with disabilities had a 40% greater risk of violence than women without disabilities and are at particular risk for severe violence.
- 70-85% of DV cases go unreported.
- Crimes of violence against people with disabilities are statistically far less likely to be prosecuted.
- Types of abuse.
- Common signs of DV.
- What to do if you suspect DV or are a victim of DV.
- Information about shelters and support agencies dedicated to Domestic Violence for aid and resources outside the law enforcement process.
- Mandated reporters must report the suspected abuse to law enforcement.
- What happens when DV gets reported to law enforcement.

7:59p Legislators and their staff were invited to give comments on the topic of Domestic Violence (DV) and on the presentation. All those representing legislative offices put contact information in the chat function.

- Leslie Bulbuk – Anyone in Assemblymember Marc Berman's district can get in touch with Leslie Bulbuk and their office will be happy to get you the resources you need.
- Gabby Skarka – Marin County Field Representative for Representative Jared Huffman. Thank you for sharing your stories and you can reach out to Gabby at his office with any needs.
- Joan Lubamersky – Assemblymember Marc Levine's office. There have been calls about domestic violence to his office. They would like to take calls from constituents.
- Robert Raburn – Bay Area Rapid Transit (BART) Board appreciated getting invitation to this office. Witnessed custody handoffs at BART stations. 100% of BART Police have been trained on crisis intervention. Many of the calls BART Police get are domestic abuse or people in crisis. They are not criminal calls.
- Tara Kopp – Field Representative for Representative Mark DeSaulnier's office serving Contra Costa County. Thanking everyone for sharing stories and welcomes constituents to contact their office with any issues.
- Alejandra Sanchez – Assemblymember Tim Grayson is an advocate and supporter for survivors of domestic violence. Contact office for any needs. Appreciate everyone who has spoken and shared their experiences.

8:08p Member Reports: RAC members and Councilmembers Lau and Adler reported on their regional and statewide advocacy work and priorities. Some highlights were:

- **Francisco Garcia:**
 - Working with the Hispanic community support groups and with La Familia. He will bring Domestic Violence up as a topic with the groups he is working with.
 - Working on this year's Congreso Familiar series of events-- workshops every Saturday in Spanish.
- **Marla Silversmith:**
 - Presented at the STAR Conference. Great attendance.
- **Dianne Millner:**
 - Continue to work on the Self-Determination Advisory Committee. It will be rolled out to everyone eligible this upcoming summer.
- **Elizabeth Grigsby:**

- Busy with advocacy work and related groups, all Zoom based.
- **Regina Woodliff:**
 - Thank you to the RAC for being patient with her absence and is grateful for the RAC and those who have helped her learn to speak up.
- **Nicole Adler:**
 - Re. DV; people don't know what to ask for or what to do when they need to get help. It should come from the other direction. Decision makers and advocates should say, "this is what we are doing, will this help?"
 - Shared, if she went through it herself, she would want full justice. There should be harder sentences for DV.
- **Francis Lau:**
 - SCDD has selected a new chairperson for the new year, Councilmember Wesley Witherspoon and new vice chairperson, Councilmember Lee Bycel.
- **Pam Perls:**
 - Following Special Education Certification changes, San Francisco Police Department changes, in hopes that we as a group can make a difference in related areas of advocacy.
- **John Marble:**
 - Holding trainings on Neurodiversity.
 - Helping contacts on the Biden and Harris transition team think about building their teams to include disabled people, and helping federal agencies ensure outreach to disabled people.
 - Encourage people to use this time to shape what your elected officials' offices look like. Ask how they think about their staffing and who they reach out to.
- **Kate Rauch:**
 - Forming a RAC workgroup with Francisco to help establish quiet lab time at hospitals and clinics. Can provide a one-page sheet about the quiet lab concept.

8:34p Reports:

- **Regional Center Reports:**
 - Eric Zigman gave the report for GGRC:
 - COVID Response:
 - Saw an uptick of COVID positive clients around the middle of July.
 - 10-12 client per month report they are COVID Positive, and the same number of support staff as well.
 - Distribution of PPE – Developed a new way to distribute. Already distributed over 2 million pieces and it is not enough.
 - The Association of Regional Center Agencies (ARCA) has done a good job of reaching out to the California Public Health Committee that is discussing the priority around vaccine availability. Pushing for the people we serve and the people who serve them to be high priority and be in the early group to be vaccinated.
 - Passed out meals for Thanksgiving. 90 Families/200 Individuals.
 - 150 Backpacks with school supplies were passed out.
 - New rollout of non-residential services called Alternative Services: A flexible way for day programs and other programs that are not residential to continue to support people in the community.
 - Lisa Kleinbub gave the report for RCEB:
 - The next focus in COVID response will be how the vaccine gets rolled out. It will be a challenge because of those who are suspicious of it.
 - The Alternative Service Delivery may be a model for how people are served and an opportunity to make big changes.
 - Paying attention to changes on the federal level and reforms that may come from both federal and state government.
 - Re. Domestic Violence: We need to recognize and be aware of people being more dependent and more isolated due to the shelter in place. When we see

people on Zoom, and we think they need more support, it is important to check in with them.

- **Developmental Disability (DD) Councils:**

- Ben Chen gave a report for Alameda County DD Council:
 - Continued work on advocating for IDD community throughout the pandemic.
 - Recently held COVID-19 and Disability Community Listening Session in Alameda County.
 - Alameda County submitted an initial vaccination plan to the State that covers logistics and distribution, stakeholder engagement, identification of critical populations, and reporting and monitoring.
 - DD Council will be working to advocate on behalf of the disability community within the stakeholder engagement process and working on equitable distribution of vaccinations.
 - More information on Alameda County's Public Health Webpage.
 - The next Board of Directors meeting will be December 9, 2020, 9:30 AM to 12:00 PM. There will be a panel presentation on Mental Health and Wellness during COVID-19.
- Vi Ibarra gave a report for Contra Costa County DD Council:
 - Next meeting will be Jan 27, 2021.
 - The East Bay Legislative Coalition (EBLC) is planning the Virtual East Bay Legislative Breakfast to be held on Friday, January 29, 2021.

- **People First:**

- Shawn Costello reported Bay Area People First held elections. Patrick McKay is the new President and Shawn Costello is the new Vice President.
- Ron Usac shared the upcoming meeting dates.

**Follow up items

2022-26 State Plan (Draft)

Goal 1

The Council will empower people with intellectual/developmental disabilities to become strong self-advocates, peer trainers and community leaders.

Objectives

1.1

The Council will provide information, resources and 125 trainings to strengthen 1,250 self-advocates in:

- 1)** identifying and asking for the supports and services that they need;
- 2)** becoming and serving as peer trainers; and,
- 3)** developing skills and opportunities to engage as strong activists for issues that are important to them and their families

1.2

The Council will support self-advocates in peer networks by providing facilitation, tangible supports and peer advocacy/leadership opportunities through at least 1 statewide and 12 regional self-advocacy entities, reaching 6,000 self-advocates.

Goal 2

The Council will lead in partnership with family/self-advocates and others to protect and enhance civil rights and improve community-based systems to be more fully inclusive and supportive of people with intellectual/developmental disabilities and their families.

Objectives

2.1

The Council will develop, improve and/or change 30 practices, 15 policies, and 10 regulations (or guidance) and/or laws in the systems of regional centers, community-based services, and governmental entities. This work will include the areas of employment, education, housing, and health/safety in ways that will benefit people with intellectual/developmental disabilities and protect their civil rights, promote full inclusion, and/or provide additional supports and services, improving their lives in tangible ways.

2.2

The Council will engage in 20 regional and 5 statewide innovative/special projects and/or events in the areas of employment, education, housing, and health/safety to:

- 1)** empower 5,000 people (family/self-advocates and others) in systems change efforts and give them information, skills and/or supports to increase their abilities to become effective advocates; and/or,
- 2)** increase services to improve supports for people with intellectual/developmental disabilities and their families.

2.3

The Council, in collaboration with California's four (4) partners (one Protection and Advocacy agency and three University Centers for Excellence in Developmental Disabilities), will seek to improve the generic service system that impacts people with intellectual/developmental disabilities who are underserved by choosing an area of emphasis in the State Plan, such as education, employment, housing, and/or health/safety, and report on how that system is serving people with I/DD, gaps in that service delivery system, recommendations on how to improve the systems to meet the goals of the DD Act, and pursue policy and practice changes in those areas. The collaboration will result in 2 reports, 6 recommendations for policy or practice changes, and 2 Legislative or Administrative changes to policy or practice.

Goal 3

The Council will partner with and empower more people with intellectual/developmental disabilities and their families, so they know their rights and can advocate for and receive supports and services

Objectives

3.1

The Council will provide (staff-led, peer-led and/or collaborative) training to 60,000 people (family/self-advocates/others) throughout the state – virtually, online and/or in person - and provide technical assistance (TA)/advocacy clinics, reaching 50,000 people with assistance and resources to identify and obtain the supports and services that will help people with intellectual/developmental disabilities live a safer and healthier life.

3.2

The Council will engage in 100 projects and events in the areas of employment, education, housing, health/safety, and emerging issues, reaching 25,000 people (family/self-advocates/others) with information and resources to enhance their knowledge and increase their capacity to obtain supports and services that are important to them.

3.3

In order to reduce the disparities in obtaining a free, appropriate public education, the Council will work with 5,000 Spanish-speaking family/self-advocates throughout the state to advocate for and increase the number and type/quality of special education services they receive through their own local education agencies.



Your Insight and Input Requested for the Next 5-Yr State Plan

The State Council on Developmental Disabilities' new 5-year State Plan has been approved and will be submitted to the United States' Administration on Community Living (ACL) Office on Intellectual and Developmental Disabilities (OIDD) by August 2021.

The Council received statewide input about the needs of Californians in developing its goals and objectives this last year. Thank you for being a part of this important work.

Based on your and other Californian's feedback and input, the Council identified specific topics and systems as the most critical areas of need.

We are now asking for Regional Advisory Committee and Bay Area advocates for:

- Input on specific or emerging regional issues within **education**.
- Input on specific or emerging regional issues within **employment**.
- Input on specific or emerging regional issues within **health & safety**.
- Input on specific or emerging regional issues within **housing**.
- Input on specific needs or project ideas focused on **self-advocacy**, as we start to develop the workplan for the new State Plan.

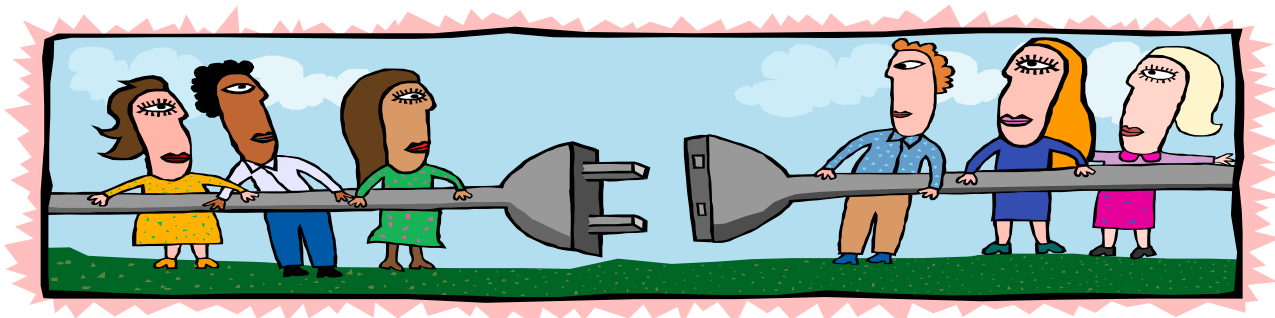

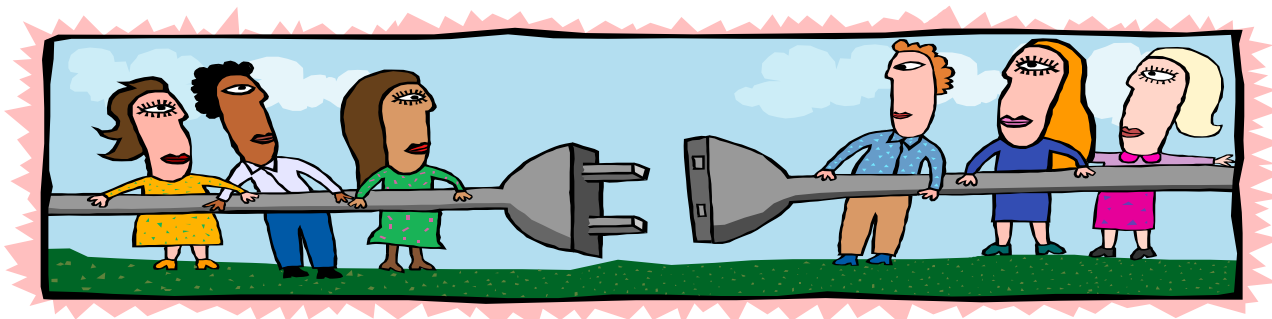
