1. CALL TO ORDER

Committee Chair Jeana Eriksen called the meeting to order at 1:04 P.M.

2. WELCOME AND INTRODUCTIONS

Committee members and others in attendance introduced themselves.

3. ESTABLISHMENT OF QUORUM

A quorum was established.

4. PUBLIC COMMENT

There was no Public Comment

5. CHAIR REPORT AND ANNOUNCEMENTS

Committee Chair Jeana Eriksen reviewed Zoom operations and etiquette during the meeting and asked members to be patient and kind with one another.

6. APPROVAL OF JANUARY 25, 2021 MINUTES

Members reviewed the minutes from the January 25th meeting. The minutes can be found starting on page 7 of the March SAAC packet.

ACTION 1

It was moved/seconded (Witherspoon [SA]/Lagrand [SA]) and carried to approve the January 25th minutes as presented. All members present voted in favor of the motion.

In the interest of time, the committee chose to move to what was originally listed as Item 9 on the agenda "SAAC Feedback on Emerging Issues for 2022—2026".

7. SAAC FEEDBACK ON EMERGING ISSUES FOR 2022-2026

SCDD Manager of State Plan and Self-Advocacy, Rihana Ahmad, along with SCDD Senior Planning Analyst, Janet Fernandez, led the committee in a discussion on emerging issues to keep in mind during the development of 2022-2026 SCDD agency workplans. Members of the committee mentioned concerns over vaccine safety and equitable access to vaccines, maintaining safety in reopening schools, access to highspeed internet for distance learning and mental health services.

Members would like to see the Council expand their work on providing services to transition aged youth, continue to advocate for affordable housing, access to Competitive Integrated Employment (CIE) and working to improve relationships between law enforcement and people with disabilities.

Committee Members expressed concern that COVID-19 restrictions may have a long-term impact on society and may impede Council staff's ability to engage in important work and activities.

8. REVIEW OF COUNCIL BUSINESS

SCDD Executive Director Aaron Carruthers reviewed Council Business with the Committee in preparation for the upcoming Council meeting. Executive Director Carruthers provided committee members with an update on the proposed 2021—2022 SCDD Budget and answered questions related to the budget process. Executive Director Carruthers also reviewed the proposed 2021—2022 Legislative Priorities and Positions with the committee.

9. SAAC RECOMMENDATIONS/INPUT TO THE COUNCIL

SAAC members discussed the policy recommendations of the Legislative and Public Policy Committee (LPPC) and considered how the Council could approach the voting process in order to efficiently address all of the bills under consideration.

ACTION 2:

It was moved/seconded (Aldana [SA]/ Marquez [SA]) to recommend that the Council vote on the legislation by state plan goal area. All members present voted in favor of the motion.

10. SAAC FEEDBACK ON DDS CIE BLUEPRINT ROADMAP

DDS, Community Programs Specialist, Community Services Division and Work Services Section, Elizabeth Mard, reviewed the DRAFT DDS CIE Blueprint Roadmap with the committee and requested their feedback on the tool. Members tested the usability of the tool and provided their initial feedback. Members were encouraged to continue reviewing and testing the tool and email their feedback to Elizabeth at <u>Elizabeth.Mard@dds.ca.gov</u>.

11. MEMBER UPDATES

Members discussed their concerns about day programs and supported employment, the disparities in the vaccine rollout and looking forward to returning to normal once COVID—19 is no longer a constant concern. Members stressed the importance of listening to medical experts and government officials when making decisions related to reopening the state and returning to daily activities.

Committee members shared updates from other Council Committees and were referred to the committee reports included in the March Council Packet.

13. SSAN REPORT

Councilmember Lagrand provided members with an update on the Statewide Self—Advocacy Network.
