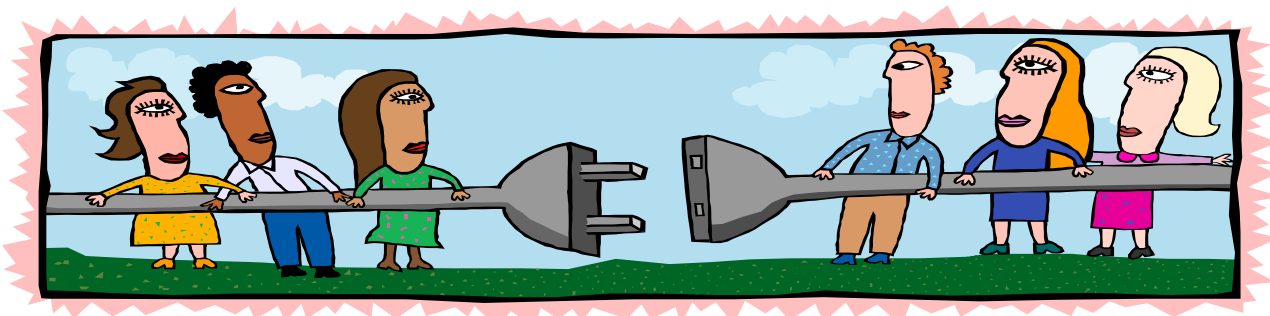

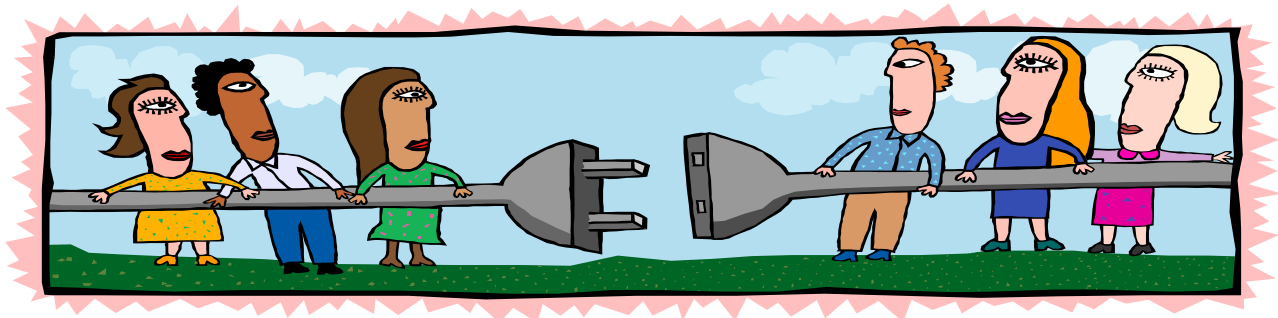

6:31p Chair Elizabeth Grigsby called the meeting to order. Valerie Buell reviewed housekeeping: Zoom functions, chat, and interpretation services, and then took roll call of RAC members.

6:40p Approval of Meeting Minutes for February 23, 2022:

Moved: Sasha Bittner

Seconded: Marla Silversmith

Roll Call Vote: All Ayes

6:42p Public Comments: Some highlights were:

- Valerie Buell commented that she attended a Tradeswomen Inc. event honoring woman in the trades. At the event, Valerie asked about jobs for self-advocates in this community. Senator Skinner replied in support.
- Will Sanford commented they talked about tradespersons with IDD with the Adult Schools and they had a prerequisite getting into those types of programs. They said that trainees could take the 10 to 12 weeklong class twice, if needed. Accommodations can be available to trainees with access and functional needs.
- Jamie Yan Faurot commented about positions for women with disabilities in this work. They want to contribute to society and share their lived experiences.

6:49p Fred Nisen and Paul Spencer from Disability Rights California (DRC), gave a presentation on Voting Rights 2022. This presentation included a power point presentation included in the meeting packet. Some highlights were:

- Election basics, voter registration, and options for voting were reviewed.
- Comparisons between traditional polling place models and the new Voter's Choice Act (VCA) model were also reviewed.
- Reminders of voting dates, eligibility, resources, registration, voting under conservatorship, and accessible voting options, both in person and from home, were reviewed.

8:00p Additional Legislative Office and/or RAC Member comments: Some highlights were:

- Senator Nancy Skinner addressed the RAC. Highlights were:
 - She thanked Fred Nisen and Paul Spencer for the presentation as she learned there were audio materials she never knew

about and her office can now share them with any constituents who call.

- She remembers the town halls held in the state building and the times that cuts were made to programs that support members of the IDD community. She is currently chair of the budget committee and has worked to restore funding, put money into the developmental services rate study, made adjustments for the Early Start program funding, added money for communication for Deaf individuals, added money for non-MediCal older adults and people with disabilities to transition out of nursing homes and into the community, and continued to support Program of All-Inclusive Care for the Elderly (PACE).
- Mike Levinson commented he had some questions about the voting segment. He was part of the voter outreach and education call which he serves on in San Mateo County.

8:15p Community Partner Reports:

- **People First:** Highlights from Patrick McKay, President Bay Area People First and of the Northern Alameda People First Chapter:
 - Bay Area People First board members met on Monday, September 26th. They continue to have meetings over Zoom due to COVID-19 and will continue to meet over Zoom for the next few months.
 - San Francisco People First met in August in person at Delores Park and were happy to see each other face to face once again.
 - The annual Golden Gate Self-Advocacy Conference will be on October 26th from 10:00 AM to 12:00 PM over Zoom.
- **Regional Center Report Highlights.**
 - Hop Lou, Chief Financial Officer, gave the report for Golden Gate Regional Center (GGRC):
 - GGRC is acquiring additional staff over the next few months. The system (across California) is now serving close to 400,000 consumers and families with an annual budget of approximately 12 billion that increases exponentially every year.

- The next implementation (from the rate study) will be January 1, 2023. GGRC will equate to approximately 50% of the increases expected to receive.
- There is a new GGRC Early Start Intake Director named Brittany Gonzales. She will attend a future RAC meeting.
- Lisa Kleinbub gave the report for Regional Center of the East Bay (RCEB):
 - Regional centers have received funding to reduce caseloads for many people served and are moving to fill positions as quickly as they can across the state.
 - RCEB will hold a meeting on October 18th at 4:00 PM to look at the performance contract and performance measures they expect to meet as part of receiving funding to lower caseloads.
 - As RCEB looks into the Home and Community Based (HCBS) Final Rule they have some funds to explain what that means to people served.
 - They also have funds to explain HCBS to the broad community of families and service providers, to help ensure understanding what it means to live in inclusive settings in our communities. There is a proposal on the RCEB website.
- **Developmental Disabilities (DD) Councils Report Highlights:**
 - Ben Chen gave the report for the Alameda County Developmental Disabilities Council:
 - The Local COVID-19 health emergency remains in effect. Alameda County has seen substantial improvements in cases, but this has typically been followed by surges in cases, so they are currently in the 'low tier community transmission' designation.
 - Bivalent vaccines are available. That's Moderna vaccines for those 18 plus and Pfizer for those 12 and older. And bivalent vaccines mean they increase immunity both against the original strain of the virus, as well as the newer Omicron variants.

- The current risk for Monkey Pox for the general public is low. There is a new website on [Monkey Pox](#) to keep community members informed.
- California has launched [Abortion.CA.gov](#) providing information about accessing abortion services throughout the state.
- The East Bay Legislative Coalition (EBLC) is hosting a State Assembly District 20 Candidate Forum on October 13th at 6:00 PM. Candidates Shawn Kumagai and Liz Ortega have graciously agreed to participate. Constituents are invited to participate.
- The next Alameda DD Council Board Meeting will be October 12th from 9:30 AM to 12:00 PM.
- Will Sanford gave the report for the Contra Costa Developmental Disabilities Council:
 - Mains'l gave a presentation on a new website called [Center on Me](#) that helps individuals of a variety of communication styles create their own person centered plan. They can build plans for themselves without having other people interpret for them. It is a \$250 a year membership but it allows people to identify and bring people on board, to control their plan.
 - The East Bay Legislative Coalition (EBLC) is excited to host new people and meet the fourth Wednesday of every month, over Zoom.

8:30p Member Reports: RAC Members and Councilmembers reported on their regional and statewide advocacy work and priorities. Three RAC members were recognized for their service on the RAC with a video from Sheraden Nicholau: Dianne Millner, Pam Perls, and Kate Rauch. Highlights included:

- Gabriela Solval played the video from State Council Regional Manager, Sheraden Nicholau, highlighting these members'

extraordinary two terms of services on the Regional Advisory Committee.

- Sascha Bittner: Thanked Kate, Dianne, and Pam for their service.
- Francisco Garcia: For the first time, City of Fremont hosted a Disability Resource Festival. During this festival they commemorated the work of advocate Feda Almaliti and her son, Muhammed, who both perished in a house fire in 2020. A safety preparedness project was created after their passing, in their honor, to ensure families with loved ones with disabilities are ready for emergencies. This project involves firefighters and the police department.
- Elizabeth Grigsby: Reminded everyone of the Golden Gate Self-Advocacy Conference coming up on October 26th from 10:00 AM to 12:00 PM, and thanked Gabriela Solval for her help in the planning.
- Dianne Millner: Serving on a Local Self-Determination Advisory Committee, and serving on a workgroup developing a Bay Area website dedicated to SDP and related resources.
- Pam Perls: Named to the Contra Costa Health Commission and working on a couple of their committees. Will also be an interviewer for the National Core Indicators project for 2022-2023.
- Kate Rauch: Reflected on her two term services, and thanked members for the recognition.
- Marla Silversmith: This fall worked with the executive director of the San Mateo Special Education Local Plan Area (SELPA) around family outreach about IDD services, with the help of Sheraden Nicholau and Eric Zigman, and scheduled in person meetings and hybrid meetings for parents that can't meet for this kind of family engagement.
- Florence Wong:
 - The San Mateo County Commission on Disabilities had a third annual inclusion festival in August, at Redwood Park, in Redwood City.
 - The Caregiver Abuse Registry workgroup is meeting. It's going to take about another year before we have a proposal before we share with legislators.

State Council Program Development Grants (PDG): Cycle 44 Updates

PathPoint: Providing Upstream Mental Health Support for People with IDD

Focus Area: Health and Safety Funding Amount: \$41,902

Outcomes Summary:

PathPoint's project piloted two upstream mental health interventions: Dialectical Behavioral Therapy (DBT) Skills and Mental Health First Aid. The project provided an opportunity for the individuals we serve to learn new skills to support their mental wellness. Not only did the trainings provide them with practical tools and knowledge about how to support their own mental health, but they were also provided with training on how to support others who are dealing with mental health challenges. The multifaceted approach allowed these individuals to expand their understanding and prepare them to be in supportive situations with others.

Parents Helping Parents: Building Strong Families during Transition to Adulthood

Focus Area: Health and Safety Funding Amount: \$57,808

Outcomes Summary:

This project addressed the mental health needs among people with IDD (and their families) who are transitioning to adulthood by providing support and information to increase knowledge and skills and decrease anxiety. Parents shared that they increased their confidence to advocate for loved ones during the transition to adulthood. They learned about the rights of their loved ones and will be using all the information provided. They reported that they were better able to navigate the system during the transition to adulthood and felt more confident in talking with their loved ones and the professionals with whom they work.



Chime Institute: Inclusive Model for Self-Determined Learning

Focus Area: Education

Funding Amount: \$87,000

Outcomes Summary:

This project's mission was to promote self-determination, independence, productivity, and inclusion by: 1) providing explicit instruction and opportunities for the practice of self-determination skills for students with extensive support needs in general education classrooms; and, 2) presenting a free online toolbox of strategies to promote self-determination skill growth for students with extensive support needs in inclusive settings, including instructional strategies for early childhood through high school classes. Video of teachers providing embedded self-determination instruction and students engaging in goal setting and monitoring activities will be shared from the toolbox developed through this project.

Down Syndrome Connection of the Bay Area (DSCBA): Mental Health & Wellness Alliance

Focus Area: Education

Funding Amount: \$55,030

Outcomes Summary:

The DSCBA created customized and customizable communication boards for individuals with IDD and therapists to use during therapy to help them express thoughts and feelings, as well as tools to help individuals cope with mental health issues. The grantee also adapted an outcome measurement tool (My Outcomes) to track program results. One hundred percent of the project's participants scored in the 'green' or Service Target Zone as of the last session. The Service Target is the score predicted at the end of successful treatment and reflects reliable change greater than that expected as the result of chance, maturation, and/or measurement error. This project has been timely as the pandemic has had lasting impacts on people with IDD and their families, including more people with IDD experiencing depression and grief due to social isolation and loss of routine. This project has helped participants process these losses.



State Council Program Development Grants (PDG): Cycle 45 Summaries

Adaptive Parent Project: Furthering Education & Opportunities for People w/ IDD

Focus Area: Health and Safety Funding Amount: \$28,125

Summary:

The grantee and its collaborative partners will identify educational curriculum and resources written by providers with expertise in caring for patients with IDD and will perform quality assurance assessments for best practices and inclusivity. They will also develop educational materials/products for patients with IDD to build a better understanding of healthcare and build more collaborative care practices for patients and their providers.

Acorns to Oak Trees: Tribal Outreach/ Training Project on I/DD

Focus Area: Employment

Funding Amount: \$100,000

Summary:

This project will provide a new and innovative vocational model to train individuals with IDD for careers that align with their interests and serve the community of people with IDD. The project will be to pilot a training program for adults with IDD to teach music to students with IEPs from LA area K-12 schools. The project will establish both a digital curriculum for music teacher training and a student-based teaching experience.
