1. CALL TO ORDER

Committee Chair Nicole Adler called the meeting to order at 1:34 P.M.

2. WELCOME AND INTRODUCTIONS

Committee members and others in attendance introduced themselves.

3. ESTABLISHMENT OF QUORUM

A quorum was established.

4. PUBLIC COMMENT

Nicole Adler spoke about the importance of authentic representation in Hollywood. She stated that if a character has a disability, they should be played by actors who are real people with disabilities, if a character is a part of the LBGTQ community, the actor playing the character should also be a member of the LBGTQ community. Representation in Hollywood is important for anyone who wants to see someone like themselves on screen.

5. CHAIR REPORT AND ANNOUNCEMENTS

Committee Chair Nicole Adler talked about the ongoing challenges to accessing support for the Self-Determination Program and the need to make the process easier. Chair Adler recognized that a lot is going on in the world right now and thanked people for taking the time to attend the meeting and encouraged members to be patient and kind to each other.

6. APPROVAL OF JULY 25, 2022 MINUTES

Members reviewed the minutes from the July 25th, 2022 meeting. The minutes can be found starting on page 7 of the September 2022 SAAC packet.

It was moved/seconded (Marquez [SA]/ Ybarra [SA]) and carried to approve the July 25th minutes as presented. Motion passed without objection.

7. REVIEW OF COUNCIL BUSINESS

SCDD Executive Director Aaron Carruthers provided members with an overview of the September Council meeting agenda. The Council will receive reports from the Council Chair and Executive Director, along with Committee and Executive Staff. Committee members asked if the November meeting would be in-person or over Zoom. Executive Director Carruthers said that Council leadership would like to meet in-person, but that the agency is paying close attention to the ongoing public health concerns.

Members discussed ways that the committee can provide recommendations to the Council.

9. FEEDBACK ON SCDD SELF-ADVOCACY DEAP TRAINING

Co-Chairs of the SCDD Self-Advocacy Disability Expert Advisory Panel (DEAP) Dena Hernandez, North Valley Hills Regional Office Manager and Peter Mendoza, Sacramento Regional Office Community Program Specialist reviewed the DRAFT Introductory Self-Advocacy Training developed by the DEAP and encouraged members to email any feedback they might have on the material to Dena, Peter or SCDD Self-Advocacy Coordinator Riana Hardin. A copy of the presentation can be found starting on page 17 of the September Self-Advocates Advisory Committee packet.

10. MEMBER UPDATES

Members shared updates on self-advocacy barriers and issues in their communities, self-advocacy projects they are working on, committee updates and the Statewide Self-Advocacy Network Report. Highlights from their updates included: transitioning back to in-person meetings when appropriate, the importance of people with disabilities being included in graduation ceremonies, and the continued need for affordable housing.

11. SSAN REPORT

Council Chair Wesley Witherspoon provided committee members with a summary of the September SSAN meeting. Highlights included presentations from CalABLE and UC Davis MIND Institute and discussions about what it means to live self-determined lives.

Reflections on the 32nd Anniversary of the Americans with Disabilities Act (ADA):



The Self-Advocates Advisory Committee (SAAC) of the California State Council on Developmental Disabilities (SCDD) offers the following reflections and recommendations on the 32nd Anniversary of the ADA:

The ADA **MEANS**:

- **4** Better **ACCESS** to supports and services in our communities
- People with disabilities are seen as HUMAN BEINGS and should be treated EQUALLY
- The ADA helps us to be better advocates, councilmembers and citizens because we have and KNOW OUR RIGHTS
- 4 The ADA is FREEDOM to CHOOSE how we live our lives
- Security in KNOWING that you have the rights to services and supports you may need in the FUTURE because your disability CHANGES as you go through life and you can develop new and different disabilities throughout your life.





The IMPACT of ADA:

- Society became aware of the importance of LANGUAGE and started to update disability terms to be more INCLUSIVE
- The use of CURB CUTS and efforts to make PUBLIC TRANSPORTATION ACCESSIBLE
- People with disabilities have the CHANCE to be who we are and EXCEED other's expectations of our abilities

RECOMMENDATIONS from the SAAC to SCDD:

- More INFORMAL CONVERSATIONS about disability topics
- Talk about SOCIAL ISSUES and CURRENT EVENTS and how they impact people with disabilities
- Share more self-advocacy VIDEOS and STORIES
- Advocate for BETTER TRAINING for support staff
- Use SOCIAL MEDIA to raise awareness of the Council's work by live streaming meetings, tweeting and using hashtags
- TAGGING Council members in social media posts
- Self-Advocates **INTERVIEWING** each other on social media
