



**6:36p** Chair Elizabeth Grigsby called the meeting to order. Valerie Buell reviewed housekeeping: Zoom functions, chat, and interpretation services, and then took roll call of RAC members.

6:38p Approval of Meeting Minutes for February 23, 2022:

Moved: Sascha Bittner Seconded: Elizabeth Grigsby Roll Call Vote:

- Ayes: Sascha Bittner, Jennifer Fung, Francisco Garcia, Elizabeth Grigsby, John Marble.
- Abstain: Marla Silversmith, Florence Wong.



**6:39p** Public Comments: Elizabeth Grigsby asked for public comments. Highlights included:

- Leslie Bulbuk from Assemblymember Marc Berman's Office introduced herself and invited attendees from San Mateo County to reach out if they need assistance with any state agencies.
- Sara Desumala gave an update regarding the People First Gathering meeting via Zoom and her concerns that attendees must pay to attend even though regional centers are supposed to pay.
- Gethsemane Moss from Senator Bill Dodd's Office introduced herself and gave an overview of the catchment area the office serves. She invited constituents to reach out to his office in Vallejo if they would like to contact her for help with anything. She also gave a review of Senate Bill SB271 which would allow wheelchair users the right to repair their own equipment and would also require manufacturers share repair information to increase access to spare parts.
- Katie Jaycox from Representative Josh Harder's Office introduced herself and invited anyone from the Discovery Bay and Brentwood area to reach out to their office with any needs they have.
- Assemblymember Damon Connolly introduced himself to the community and reviewed his district area as well as his status as a freshman Assemblymember.
  - His office introduced 21 bills this year.
  - He is on the Select Committee on Wildfire Prevention.
  - He has worked with Centers for Independent Living and is familiar with the work they do.
  - He encourages everyone to participate in the "There Ought to Be a Law" contest.
  - Attendees shared information with him about Home and Community Based Services (HCBS) and concerns about the rollout of the final rule. Attendees suggested meetings with his office to give him more information and there will be a follow up with the RAC and Cristina Sanchez.

**6:59p** Sheraden Nicholau introduced the panel gathered to present on the diversity of community focused ways to support and build equity within systems, and to reduce disparities in these systems; made up of Esther Wong, Dominique Mellion, Maria Ramirez, Norma Gonzalez, Arlene Vasquez, and Ben Chen.

#### Highlights include:

- Ben Chen from the Alameda County Developmental Disabilities Council:
  - Reviewed the Racial Equity Work that started in September 2020, and the workgroups created to focus on allyship and support.
  - Stressed recognizing the need for data collection when developing intervention and infrastructure supporting underserved communities.
  - Encouraged creating coalitions and partnerships with other equity groups to support each other, avoid duplicating work, and build momentum.
- Norma Gonzalez and Arleene Vasquez from La Familia:



- Reviewed the background of La Familia's Promueve y Actúa (Promotes and Acts) Program created to promote access to services and resources available to Spanish speaking communities with family members with Intellectual Developmental Disabilities (IDD).
- Reviewed the Navigator Project that helps families with orientation of regional center services and workshops around many of the services available, providing one on one support and consultations.
- There are 10 support groups available for families served.
- Dominique Mellion and Maria Ramirez from Families United for Equity:
  - Reviewed background of Families United for Equity, focused on ending systemic racism impacting African American families, people served, and providers in the regional center system and in IDD services.
  - Reviewed data and reports around disparity and funding and the need to use surplus dollars to address and reduce disparity.
  - Call for transparency and accountability on a local level (like regional centers) and state level (like DDS).
  - Reviewed information about Assembly Bill AB1147.
  - Stressed the importance of calling out systemic racism and the historic roots of it in the DDS system. Gave a brief history of eugenics, providing articles showing the sterilization and marriage restrictions that happened in CA and in the United States that disproportionately impacted people of color and people with disabilities.
- Esther Wong from Diversity in Health Training Institute:
  - Reviewed background for Diversity in Health Training Institute working to recruit bilingual Asian professionals to join the workforce, to serve the Asian language speaking people with disabilities and families.
  - Reviewed the outreach and training provided to the communities served and the focus on families that these communities care about.
  - Recent focus on Chinese and Vietnamese speaking communities. Now expanding into Burmese and South-East Asian language communities.
  - Many in these communities don't know what regional centers are, let alone what services are available; outreach is needed.

**7:50p** Q&A after the presentations: Some highlights were:

• Questions about how to get involved with these specific programs and orgs: Panelists shared information in the chat.

#### 7:55p Community Partner Reports:

- People First Highlights:
  - Patrick McKay, President Bay Area People First (BAPF) and of the Northern Alameda People First (NAPF) Chapter:



- The meeting schedule for the rest of the year has been scheduled.
- New members are encouraged to take on office roles and are encouraged to reach out if interested in joining.
- Regional Center Report Highlights.
  - Eric Zigman gave the report for Golden Gate Regional Center (GGRC):
    - Expressed how the presentation was informative and also a reminder of the information gained from past trainings on inclusion. These include trainings on Implicit Bias, Equity, and Access provided to GGRC.
    - Self-Determination continues to be a priority, despite the issues with funding the Fiscal Management Services (FMS). There have been some recent updates on FMS rates, and there may also be an incentive for the FMS to hire more bilingual staff.
    - Dr. Goode from Georgetown University National Center for Cultural Competence testified today in the Assembly Budget Committee and stressed the work California is doing, leading the nation, such as with Service Access and Equity Grants, but shared the state needs to do better to define what equity is.
    - Budgets to purchase services are only in regional center control to the degree that authorized providers can be found that will provide the service. When those dollars are not spent, they go back to the Department of Developmental Services—the regional center cannot choose to use these funds for other purposes or to address equity needs.
  - Lisa Kleinbub gave the report for Regional Center of the East Bay (RCEB):
    - During the presentation from Dr. Goode at the Assembly today, the question was asked of DDS, whether they had a calculation for reforming the core staffing formula, which is what funds the regional centers. It is a good question.
    - RCEB recently had a job fair that went well.
    - RCEB will have a Cultural Humility Training next year. They are looking at doing a fairly standardized model of that training across the state.
    - RCEB will put forth a Request for Proposal (RFP) to develop/provide a home for people that are deaf or hard of hearing and use ASL.
- Developmental Disabilities (DD) Councils Report Highlights:
  - Ben Chen gave the report for the Alameda County Developmental Disabilities Council:



- The Annual Transition Fair was held in March and was a return to an in-person event. There were 150 attendees with 12 presentations.
- The Alameda & Contra Costa County Joint Award Celebration will be hosted on Zoom on June 6<sup>th</sup> from 6:30 PM to 8:00 PM. This annual event celebrates people within our system that have made an impact on our community.
- The Golden Village Family Conference will be on May 13<sup>th</sup> from 8:45 AM to 3:00 PM at Ed Robert's Campus in Berkeley and targets families speaking Cantonese or Korean or Vietnamese and includes IEP and community support resources that are available in the community.

**8:25p Member Reports:** RAC Members and Councilmembers reported on their regional and statewide advocacy work and priorities. Highlights include:

- Nicole Adler: Working as chairperson on the State Council's Self-Advocacy Committee. Is supporting Assembly Bill AB1147. Down Syndrome Connection of the Bay Area received a grant to help clinicians to work with and train individuals with IDD and Down Syndrome.
- Sascha Bittner: Working on a new group, California Community Living Network's PAVE Stakeholder Advisory Group. PAVE is looking at community supports and wanting to connect with consumers with lived experience, with the goal of developing improved service outcomes measurement.
- Jennifer Fung: Working to help Asian Americans with disabilities in the region regarding transportation, budgeting, and employment.
- Francisco Garcia: Working with La Familia to distribute information about services and workshops. Congreso Familiar is coming up in August 2023. Working on bringing agencies together for this large event.
- Elizabeth Grigsby: Expressed appreciation for the information shared by the panel, and reminded everyone we are a community working towards systems change. We must look broader than at just one agency when we work on systems change.
- John Marble:
  - Shared he was to speak in Chico State University, for their Autism and Neurodiversity Month event, and learned a lot about how they use their budget and staff to have the greatest impact supporting those they serve. He was impressed by the high turnout of attendees.
  - Students with autism who are transitioning to work continue to encounter many of the systemic things that Disability Rights California laid out in the presentation they gave at our last RAC meeting. He is eager to hear what they are doing going forward.



- Shared the personal details of a medical emergency experienced in Guadalajara and the things he needed to do to self-advocate, communicate with medical professionals and law enforcement, and how the things he teaches his students helped him navigate this emergency.
- The Centers for Disease Control and Prevention (CDC) released a report recently that included terms speaking about certain parts of the autism community that were then later used in a tweet by the National Association on DD Councils. The terms are used by a well-funded group that wants to eradicate conditions of autism. John expressed concern about the use of such terms. John made a motion (below).
- Florence Wong:
  - The warm water therapy pool, at Mills Hospital in San Mateo, was closed because of the pandemic in 2020. Sutter Health was not planning to reopen it but may reverse that decision after advocacy work done by the San Mateo County Commission on Disabilities and other groups.
  - The Caregiver's Registry Workgroup will meet via Zoom on May 2nd at 10:00 AM and requested community feedback on what kinds of things community members look for in a registry in order to better draft the language for when proposing its creation.

**8:48p** Motion by John Marble: This Regional Advisory Committee of the State Council, will draft a letter to make formal recommendations to the CA State Council on Developmental Disabilities, around the use of language impacting the autism and IDD community, specifically referring to the terms 'severe autism' and 'profound autism' that had been used in recent reports and social media.

Moved: John Marble Seconded: Sascha Bittner Roll Call Vote: All Ayes John Marble will write the letter.

#### 8:57p Other Announcements:

# The Top 5: Overview of California's Self-Determination Program



# 1. While the expansion of Self-Determination Program in California is new, Self-Determination isn't *NEW*.

CA's Self-Determination Program (SDP) is an alternative way for people served by regional centers to get the services and supports they need to live the lives they choose.

SDP is an alternative to 'traditional' services. Traditional services usually mean that after an Individual Program Plan (IPP) is finalized, the regional center refers people to vendored-agencies to help meet some of the needs identified in their IPP.

SDP provides more choice, control and responsibility for a person with intellectual and developmental disabilities (IDD) to use their regional center budget to purchase services and supports *their way*.

The expansion of SDP in California is relatively new. However, SDP itself is not new. The concept of self-determination is not new. Self-determination is part of an international movement that changes systems so that people help design supports and services that work best for them.

Self-Determination is a part of larger civil rights movements. SDP upholds and is in alignment with CA's Lanterman Act, the federal Home and Community-Based Settings (HCBS) Final Rule, and the U.S. Supreme Court's Olmstead decision.



# 2. Person-Centered Thinking & Planning is the foundation for both 'traditional' regional center-funded services, and for the Self-Determination Program.

It all starts with person-centered thinking and planning. Person-centered thinking and planning can start with the individual and their circle of support identifying short-term goals, long-term goals, dreams, and the challenges that individual faces. Person-centered planning contributes to an effective IPP. This is the same in both traditional services and in SDP. Person-centered planning helps individuals determine what services and supports work best for them. In SDP, that may mean using vendored service providers, non-vendored service providers, or blend of both.

In SDP, individuals and their team determine how to use their individual budget to purchase the services and supports needed-- and how much to pay providers / services / products. Some people in SDP utilize an Independent Facilitator's help. Everyone in SDP utilizes a Financial Management Service (FMS) provider to help then pay for services and supports, and to help stay on budget.

#### 3. Your Self-Determination Local Advisory Committee wants YOU to get involved.

Each CA regional center has a local volunteer advisory committee to provide oversight of the Self-Determination Program.

Regional center and the State Council on Developmental Disabilities each appoints onehalf of the membership of the committee, for each of the 21 local committees. Committee members include people-served, clients' rights advocates, family members of people-served, and community leaders. The committee reflects the multi-cultural and geographic diversity of the region. The committee reviews the development and ongoing progress of SDP, including whether the program advances the principles of selfdetermination: freedom, authority, support, responsibility and confirmation. The committee makes recommendations for improvement to the regional center and to the Dept. on Developmental Services. Each regional center consults with the local volunteer advisory committee when planning for SDP training, too.



The **Self-Determination Local Advisory Committee** wants you to get involved! Come to their public meetings, held each month. Go to your regional center's SDP homepage for information about the committee's next meeting, or contact you State Council office and we can help you get that info.

# 4. Everyone has a role to play in helping Self-Determination expand successfully in CA. Here are a few more you should know about:

The State Council has a volunteer committee, the **Statewide Self-Determination Advisory Committee (SSDAC).** Committee members include the chairs of the 21 Self-Determination Local Advisory Committees or their designees. The Statewide Self-Determination Advisory Committee meets to identify best practices, effective training materials, SDP roll-out concerns, ways to enhance the program, and recommendations for outreach and education.

The State Council, in collaboration with federal partners, works to understand people's experiences in SDP, and to identify barriers to participation. They use what has been learned from the statewide committee, local advisory committees, and other sources. Then, the State Council shares the information and recommendations with peopleserved, their families, regional centers, and the Dept. on Developmental Services. The State Council also sends a report about SDP to the state's Legislature, in compliance with Section 9795 of the Government Code, with recommendations to enhance the effectiveness of the SDP. The State Council provides statewide orientations for people interested in the program. Also, the State Council's regional office teams can provide technical assistance and systems navigation to people when they experience challenges with or have questions about the program.

The Dept. of Developmental Services has set up an **Office of the Ombudsperson for Self-Determination Program**. This office provides information to regional center people-served and their families, facilitates solution to disagreements, investigates complaints regarding implementation of the program, recommends strategies for change to the department and the legislature, and compiles and reports data to the legislature. This



office aims to increase the number of individuals in SDP, to reduce the amount of time it takes to enter SDP, and to recommend policy change at regional centers and DDS.

**Participant Choice Specialists**, funded through the 2021 Budget Act, are positions designed to support the expansion and success of SDP. These specialists serve as subject matter experts at each regional center, to help increase choice and control through SDP and Participant-Directed Services. Their responsibilities include outreach, making accurate information on SDP available to regional center staff, people-served, and families; providing training; and helping regional centers with enrollment and benchmarks.

# 5. It takes teamwork and persistence to address barriers and bottlenecks that arise when a dynamic program like SDP is scaled across a large and diverse state like CA.

There are a lot of moving parts to a complex program like SDP. We hear from many Californians who are thrilled with the program, who are designing and paying for services and supports their way, reaching their goals. We also hear from Californians who are experiencing barriers to transitioning, process confusion, or administrative challenges as they work to kick-off their 2<sup>nd</sup> or 3<sup>rd</sup> year of SDP. Currently, there is a shortage of FMS providers across the state, and this impacts many people's ability to transition into the program or get questions answered in a timely manner. There is more work to be done in areas of education, administrative process streamlining, capacity-building, and troubleshooting.

It is vital that we continue to work together to identify and address these challenges. We can continue to make this program better. Together, we can make SDP an exciting and accessible option for more Californians with IDD and their families. Let's continue to build our future!
