1. CALL TO ORDER

Committee Chair Nicole Adler called the meeting to order at 2:02 P.M.

2. WELCOME AND INTRODUCTIONS

Committee members and others in attendance introduced themselves.

4. PUBLIC COMMENT

There was no public comment

5. APPROVAL OF MAY 22, 2023 MINUTES

Members reviewed the minutes from the May 22nd, 2023 meeting. The minutes can be found starting on page 7 of the July 2023 SAAC packet.

ACTION 1

It was moved/seconded (Ponton [SA]/ Witherspoon [SA]) and carried to approve the May 22nd minutes as presented. (Aye: Adler [SA], Jones [SA], Nieves [SA], Ponton [SA], Reyes [SA], Ryan [SA], Witherspoon [SA], and Ybarra [SA]; Not Present: Gaona [SA], and Garnica [SA]). Motion passed.

6. MEMBER UPDATES

Members shared their recent advocacy activities, including attending local People First meetings, Regional Advisory Committee Meetings, attending the California Statewide Self-Advocacy Conference, and starting their own podcast. Members discussed issues of concern in their communities, including access to medical care, specialists, and social rec, making friends and connecting with others, low attendance at self-advocacy meetings, and continued frustration with the Self-Determination Program.

7. REVIEW OF COUNCIL BUSINESS

SCDD Executive Director Aaron Carruthers provided members with an update on the status of the agency and an overview of the July Council meeting agenda. SCDD continues statewide efforts to promote access to supports and services for people with I/DD so they can be included in their communities. Executive Director Carruthers assured members that SCDD is monitoring federal developments on the debt ceiling.

8. SCDD Self-Determination Program Evaluation

SCDD Executive Director Aaron Carruthers provided the committee with a high-level overview of the recommendations in the Self-Determination Program Evaluation, which has been submitted to the legislature. Recommendations from the report included improving access to information about the program, streamlining the enrollment process, reducing the administrative burden, increase training and support for independent facilitators, using the Self-Determination Program as a tool to improve workforce hiring and retention, and increasing equity within the program.

Members voiced their appreciation for the concept of self-determination but recognized that there is room for improvement. Members were concerned about the number of steps and amount of paperwork involved in the Self-Determination Program and noted that many regional center clients choose to leave the program out of frustration or lack of support.

9. Reflecting on the Americans with Disability Act

Members ended the meeting by sharing reflections on the meaning and impact of the Americans with Disability Act. Committee members shared ideas about how to build on the ADA by improving access to medical care, increasing the accessibility of community events, expanding collaborations with mental health services, creating spaces to talk about the intersectionality between disability and other identity groups, continuing to update the language used in laws and everyday communications to be more inclusive, and strengthening and safeguarding state legislation.
