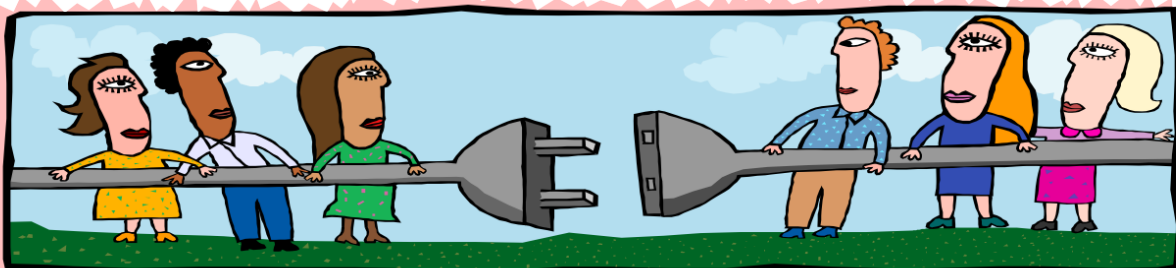

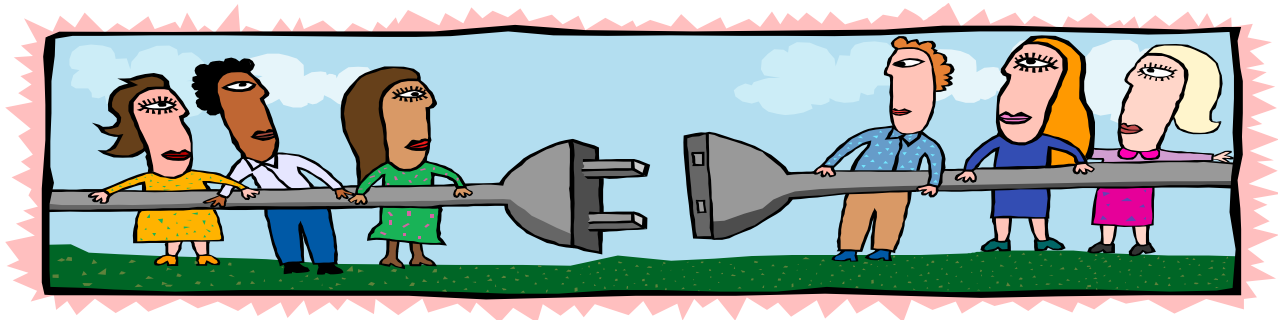

6:36p Chair Elizabeth Grigsby called the meeting to order. Valerie Buell took roll call of RAC members.

6:36p Approval of Meeting Minutes for April 26, 2022:

Moved: Sascha Bittner Seconded: John Marble

Florence Wong requested an amendment to the minutes on page 6: The first bullet point under Florence Wong's name amended to add "and other groups" after "commission on disabilities".

Roll Call Vote:

- Ayes: Sascha Bittner, Jennifer Fung, Francisco Garcia, Elizabeth Grigsby, John Marble, Emily Witkin, Florence Wong
- Abstain: Marla Silversmith.

6:39p Public Comments: Elizabeth Grigsby asked for public comments. Highlights included:

- Liz Dietz from the American Red Cross introduced herself as the Pacific Division Disability Integration Co-Advisor and gave an overview of the region her office supports in the Bay Area, from Napa and Sonoma all the way to San Benito, and into Contra Costa and Alameda County.
- Janet Nunez introduced herself and shared information about Parents Helping Parents, their strategic plan to help self-advocates transition to adulthood, and some of the webinars they offer with information including financial planning, housing, and more.

6:46p Christine Tolbert introduced herself, gave a presentation, and led discussion on the California Self-Determination Program and a review of the Self-Determination Orientation website. Highlights include:

- Orientations, Trainings, and webinars:
 - SCDD started doing statewide orientations online with captioning and Spanish, and other languages with translators. We are actively planning to conduct them in Armenian, Farsi, Arabic, and Hmong. This is a two-hour orientation.
 - Attendee trending ranges are 10% are persons-served and 84% are family members.
 - Feedback: 86% found the information useful, 82% plan to enroll, and 14% are undecided.
 - All resources are on the website including hand-outs, presentations, quick links, steps to enrollment, and service definitions. They are available in several languages.
 - SCDD will offer twice as many orientations starting in August 2023; people can register on the website. There is an independent facilitator webinar series available, as well.
- Legislation:
 - SCDD has worked with the University Centers for Excellence on Developmental Disabilities (UCEDDs) to conduct Self-Determination Program Satisfaction Surveys statewide and SCDD will provide a report compiling the data from those surveys, along with other collected data to make recommendations to the legislature. The report will be submitted to the legislature in two days (end of June 2023).
- The Department of Developmental Services has presented system trends and related data on Self-Determination Program at the Statewide Self-Determination Advisory Committee meeting.
- Enrollment has been on a steady but slow increase.
- Outreach to underserved communities is important as enrollment is not representative based on population size.
- There are long reported wait times to secure a financial management service (FMS). Customer service challenges have been reported as less than

satisfactory. Earlier this year there was a DDS directive specifying an increase in rates for the financial management service (FMS) providers, with the intention to make FMS services more sustainable and scalable in providing services to Californians.

7:47p Legislative Office Comment after the presentation: Some highlights were:

- Leslie Bulbuk from Assemblymember Marc Berman's Office shared:
 - This office has had to help constituents with Self-Determination in the past and invites those who need help to reach out to this office in the future.
 - The legislature is working on passing the CA state budget. The new Assembly Speaker will be Assemblymember Robert Rivas from District 29.

7:50p Community Partner Reports:

- **People First Highlights:**
 - Patrick McKay, President Bay Area People First (BAPF) and of the Northern Alameda People First (NAPF) Chapter:
 - The new Bay Area People First meeting time will now include a networking time starting at 4:15p on meeting days. The next meeting will have a presentation on disability etiquette, by Benjamin McMullan from the Center for Independence of Individuals with Disabilities.
- **Regional Center Report Highlights.**
 - Eric Zigman gave the report for Golden Gate Regional Center (GGRC), and first commented on legislative and budget bill updates:
 - Family fees applying to some in the regional center system that were on hold during COVID may be coming back. Regional centers and other advocates are working on getting them eliminated permanently.
 - The ability for case managers being able to use Zoom / telehealth services for people-served was continued to June of 2024. It is an option that people served can decide for some services.
 - Assembly bill 1147 is being watched. It would restructure some of the Lanterman Act. Regional centers have deep concerns about some of the proposals in this bill.
 - For example, section seven, regarding regional centers' board of directors, would reduce board members' terms at regional centers, would have the government (DDS) train the board members instead of regional centers, and would also enforce a five-year limit to service.
 - Lisa Kleinbub gave the report for Regional Center of the East Bay (RCEB):

- There is a new initiative where RCEB is recruiting a new level of case managers who don't necessarily have the typical experience expected of a standard case manager. This results in a six-month associate case manager program. This program will have qualifying associates assisting with cases and learning the system, and provides an opportunity for them to expand their skills and experience, making them eligible to apply for case manager roles.
- RCEB's board has decided to move forward with a strategic plan to develop the board's priorities and plan where the regional center's resources will be devoted in the coming years.
- A request for proposal (RFP) has been put out regarding language access and cultural competency, seeking to develop new relationships in underserved communities in Contra Costa and Alameda counties.
- **Developmental Disabilities (DD) Councils Report Highlights:**
 - Vi Ibarra gave the report for the Contra Costa County Developmental Disabilities Council:
 - The Contra Costa and Alameda County Developmental Disabilities Councils held the Joint Awards Event on June 6th. There was a total of 13 awards presented.
 - Contra Costa Health was awarded a Developmental Disability Service Access and Equity (SAE) Grant to hire Specialty Health Ambassadors. These Ambassadors will work with the larger health ambassador team for Contra Costa County to provide outreach to the underserved communities, helping them connect with various resources (including regional center supports). The program is currently recruiting more part-time Specialty Health Ambassadors.

8:10p Member Reports: RAC Members and Councilmembers reported on their regional and statewide advocacy work and priorities. Sheraden Nicholau began with recognizing retiring members Sascha Bittner, Francisco Garcia, and Regina Woodliff, and introduced the newest member Emily Witkin:

Highlights include:

- Sheraden Nicholau shared with attendees an overview of the work done by Sascha Bittner, Francisco Garcia, and Regina Woodliff during the six years they have served on this RAC and welcomed Sascha Bittner and Francisco Garcia opportunities to share their thoughts on their participation.
 - Several members of the RAC expressed their well wishes and thoughts.
- Sascha Bittner: Working with the National Council on Disabilities, particularly on community-based services and with a focus on satisfaction within the self-determination program.

- Jennifer Fung: Planning to do research on disabled people / Asian Americans with disabilities in the near future, with a focus on Marin County.
- Francisco Garcia: Working with Spanish language family support groups and have received a couple of invitations from Sacramento, including one from the Mexico Consulate. Collaboration Latina is holding an event in September that will be in Spanish, with English translation. Many of us are also preparing for Congreso Familiar in August 2023.
- Elizabeth Grigsby: Recently was able to visit a day program called Opportunity. It was great seeing the participants in the program. They reported being happy because they returned to in-person meetings and program.
- John Marble: Finishing a current semester teaching adults who are transitioning to work. Have been doing a series of speaking engagements including going up to Chico State University for their Neurodiversity Week to speak to faculty and students. The work they are doing around neurodivergent students is impressive and is a great model to look at. Invited to Washington D.C. to speak about neurodiversity at work, and spoke to about 18 agencies there.
- Marla Silversmith: A passion is agency collaboration. Working with GGRC and getting families training and resources.
- Emily Witkin: Working with kids with a variety of needs, so am interested in kids services in the regional center system, as well as the communities I come in contact with.
- Florence Wong: Inviting everyone to come to the San Mateo County Disabilities Commission on July 27th from 11:00 AM to 3:00 PM at Red Morton Park in Redwood City. The San Mateo Co Caregiver Abuse Registry Group gathered data from many different stakeholder groups. The group distributed a survey and the data we received showed an overwhelming amount of support for establishing a caregiver registry in California but also showed many didn't know much about similar registries.

8:48p Other Announcements:

- Sara Desumala: Attended the People First Gathering this year in Sacramento. Many people could not afford to attend in person.
- Sheraden Nicholau: The new RAC meeting time will be from 5:30 PM to 8:00 PM and the next meeting will be September 27, 2023. We can expect hybrid meetings going forward.

UPDATE

2023 SCDD POLICY PRIORITIES

- The Council voted to prioritize employment as a policy priority in the legislature
- There are a lot of employment efforts happening in our system, but our community is still under employed at a rate of ***less than 20%***
- With the end of subminimum wages (SB 639, 2021), individuals are moving to competitive integrated employment – real jobs for real pay.
 - This means we need to do better at connecting individuals who want to work to the right jobs.

Employment Priority #1

Limited Exam Appointment Process

State Internship Program (LEAP SIP)

- The State Internship Program (SIP) is intended to increase the number people with intellectual and developmental disabilities working in state jobs.
 - The program was temporary, and less people participated, not knowing how long it would last.
- SCDD worked with Department of Rehabilitation and the legislature to make an important employment focused, temporary state internship program *permanent*. **We won!**
- We will work to increase the number of state internship and job opportunities in the coming years.

Employment Priority #2

Create an Employment First Office

(1 of 2)

California is an Employment First state. This means:

- Assume that everyone with IDD wants to work and can work.
- Supports should be provided to ensure success at work, regardless of disability.

An Employment First Office would work with all state employment programs to make sure that they are increasing the number of people with I/DD working in real jobs for real pay.

Employment Priority #2

Create an Employment First Office

(2 of 2)

In this year's state budget process, we successfully created an Employment First Office. **We won!**

- Beginning July 2024, for the first time in history, California will have a dedicated team, the “Office of Employment First” who will work to increase the number of people with I/DD in the workforce.
- The goal: To make your job seeking efforts just as successful as anyone else's, regardless of disability.

Employment First Office

Brief Explanation of Legislation

AB 121 (Developmental Disabilities Trailer Bill)

- ✓ Creates the Employment 1st Office in the California Health and Human Services Agency on 7/1/24

WIC 4868.5

- ✓ Ends the existing Employment First Committee on 7/1/24

WIC 4868 (f)

- ✓ Creates the new Employment First Committee

WIC 4868.5 (e)(1) – (2)

So, What Does This all Mean?

This year we made improving employment opportunities a priority and
we won!

- ✓ There will be more opportunities to work in state jobs.
- ✓ There will be a permanent state office dedicated to improving employment opportunities for all.

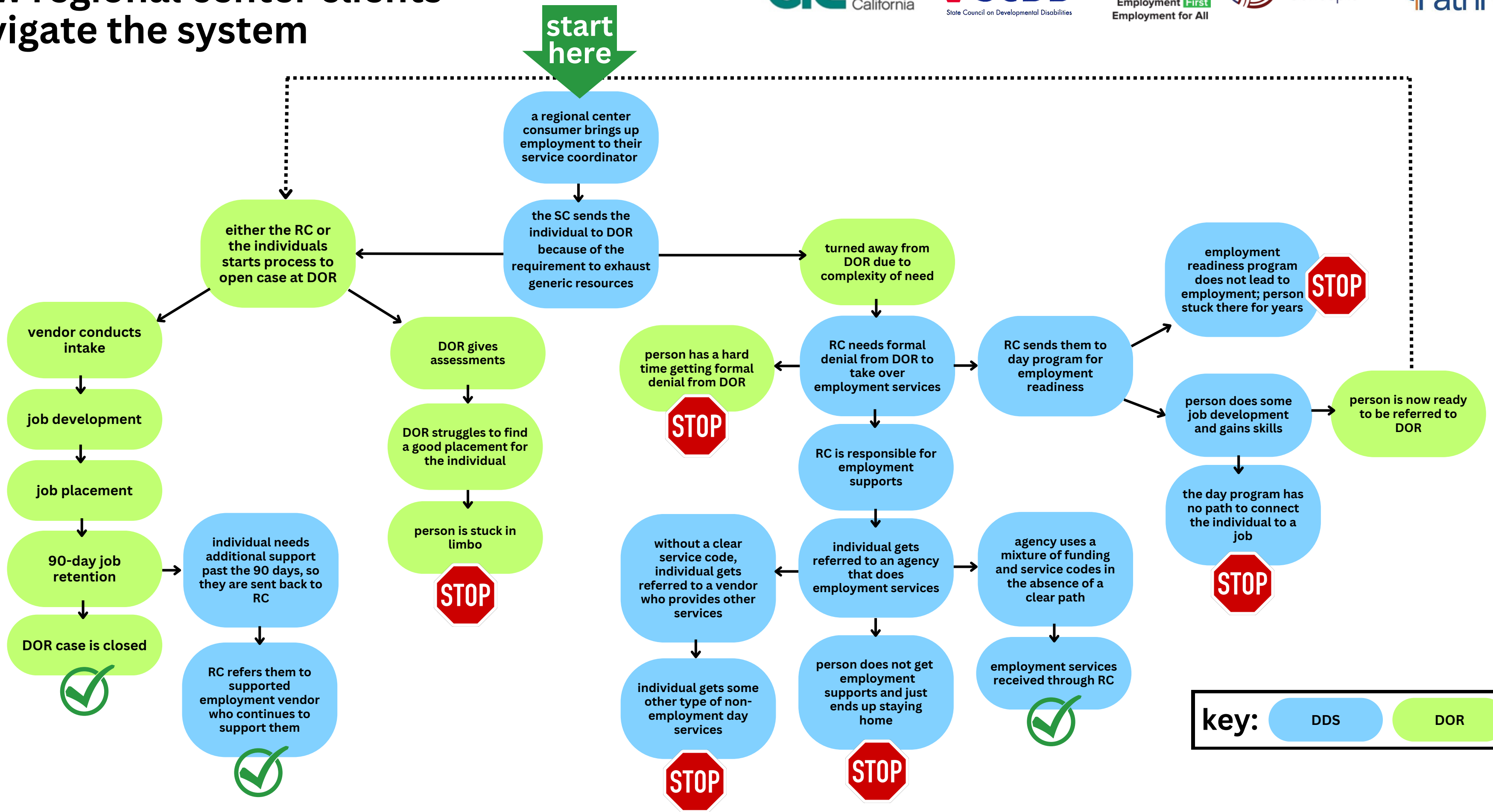
Next Steps

- SCDD is working on supporting the creation and operations of the new Employment 1st Office.
 - Ongoing meetings with Cal APSE, DRC, Regional Center representatives, employers, providers, and self and family advocates.
 - We are gathering recommendations, best practices and other stakeholder feedback and will share them with the CA Health and Human Services Agency (HHS).
- We hope to engage in ongoing communication with HHS so your feedback is welcome on an ongoing basis leading up to July 1, 2024.

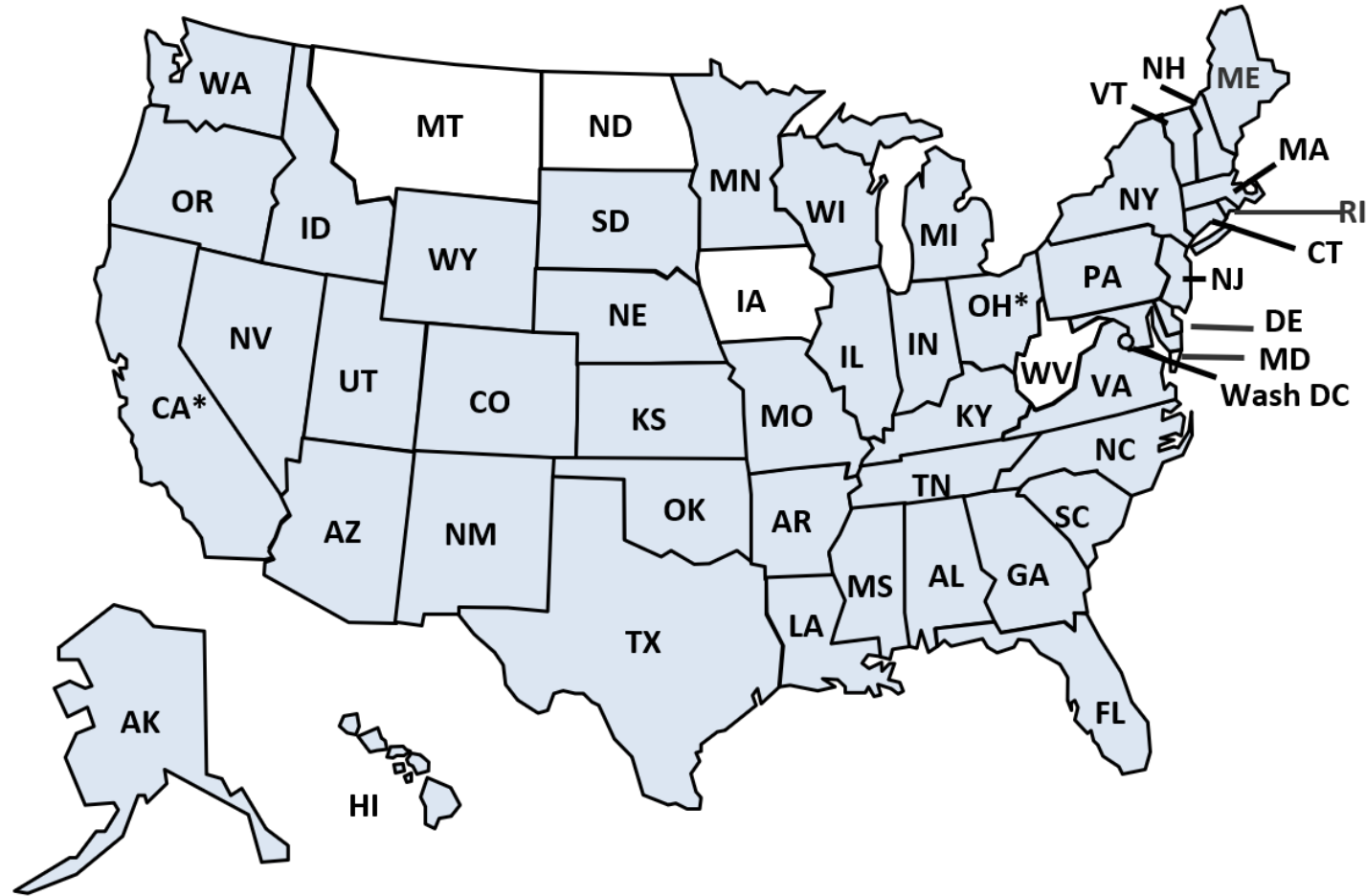

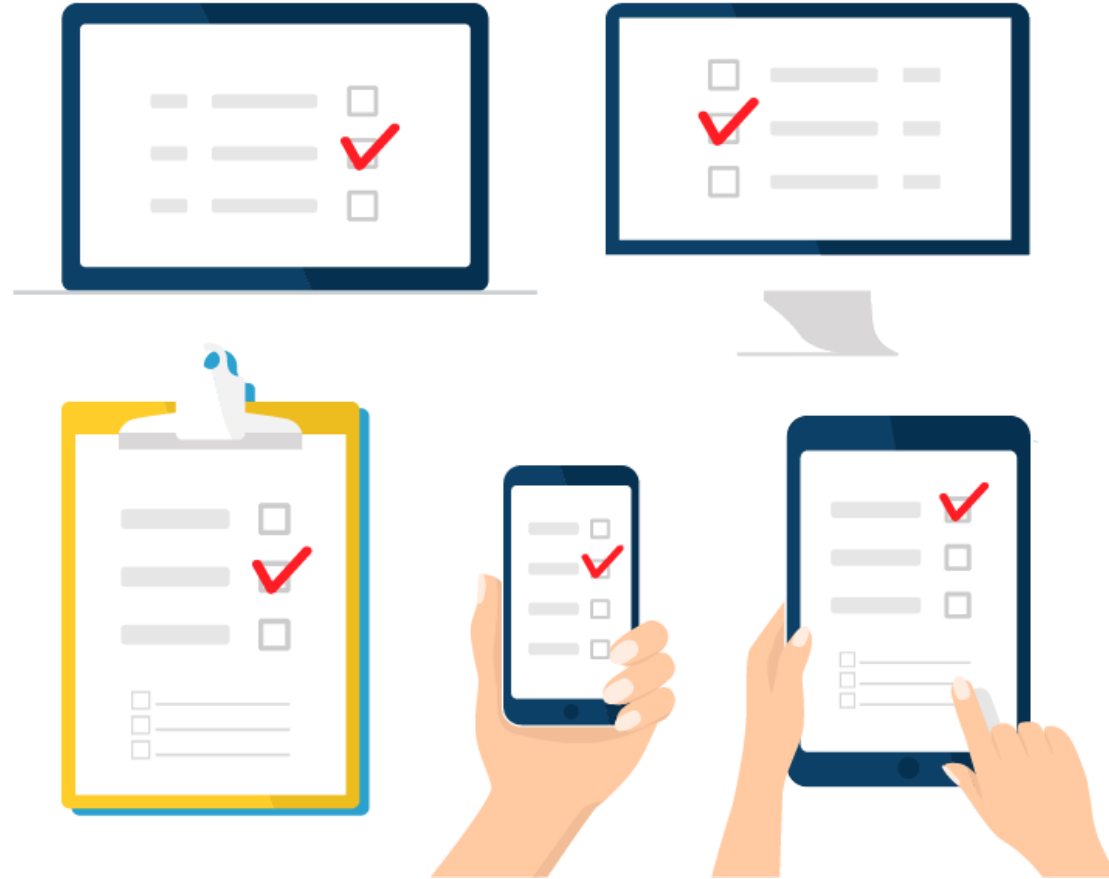

Adult Family Survey

- ▶ Mailed to families with an adult family member living at the family home (at the same physical address as family members).
- ▶ 18 years and older

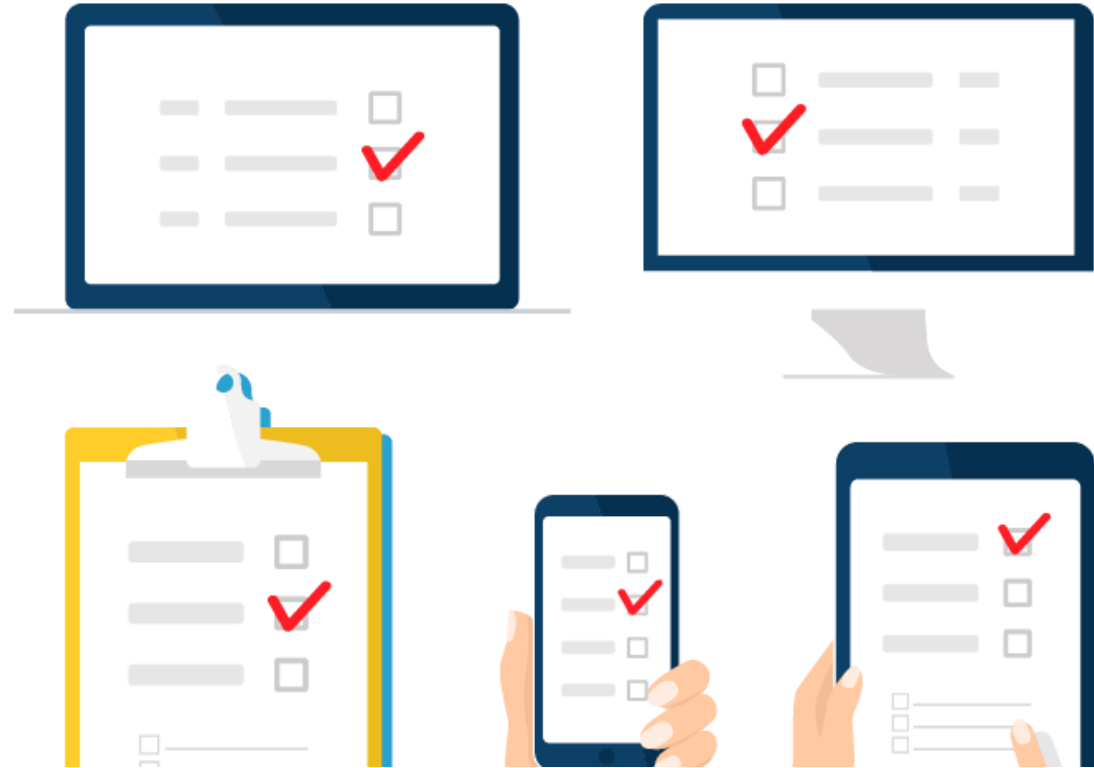
Family/Guardian Survey

- ▶ Mailed to families with an adult family member living OUTSIDE of the family home.
 - E.g. Someone living on their own or in a licensed facility or home. They might utilize services like Independent Living, Supported Living, or other services and supports.
- ▶ 18 years and older

Child Family Survey

- ▶ Mailed to families with a child living in the family home (at the same physical address as family members).
- ▶ 'Child' is defined as someone 17 years and younger.

QUICK FACTS

- ▶ Voluntary
- ▶ Not a TEST– Your experiences and thoughts matter.
- ▶ Confidential
- ▶ Your / your family member's services do not change; your regional center will not know if you completed the survey
