Legislative Process

- The State Legislature has 80 Assembly Members and 40 Senate Members.
- There are four steps in the Legislative Process:
 - Step 1: The idea. Ideas for legislation come from different sources, but a member of the State Legislature is who champions the idea as a bill.
 - Step 2: Assigning a bill number. The idea is written into a bill and the Legislator introduces the bill to the public, this is when it is given a bill number.
 - Step 3: Amendments. The bill then goes to policy committees to be reviewed, improved with amendments and then voted on in a committee hearing.
 - Step 4: Governor Signature. If the bill passes all of the needed votes in the Senate and Assembly, it will go to the Governor to sign or veto. If he signs the bill it becomes law, if he vetoes the bill then the bill fails.

2023 Bill Ideas Contest and Report

- In September we launched our 3rd annual bill ideas contest
- Over the year, we received a total of 52 bill ideas, many were about improving services, civil rights and housing.

2023 Bill Ideas Contest Winner

 In order to identify the winner of the contest, we considered bill ideas submitted between September 1 − 31.

There were so many smart ideas! The bill idea that stood out the most, the winner, was written by self-advocate Raquel Gibbons from Orange County

2023 Contest Winner Bill Description Part 1 of 2

- Raquel's bill is about the lack of support for people with mental health and behavioral health conditions that include symptoms like aggression.
- Outpatient and Inpatient facilities tend to focus on depression, eating disorders, and substance abuse. Most will refuse patients who display aggressive behavior or are considered a risk of harm to themselves or others.

Some even recommend their parents call the police to handle the emergency.

2024 Policy Priority Recommendations

Because of current events, LPPC is recommending "Health, Home, Work" as the priorities to focus on during the 2024. This theme is based on housing, mental health and employment.

"Health, Home, Work" is a well-timed approach that will support many of the current big issues in the Legislature.

2024 Policy Priority Recommendations

- Health mental health is a big topic right now due to the Governor's changes in the Mental Health Services Act this year and the creation of CARE Courts last year.
- 2. Home housing is a big focus for other disabilities advocates, this week there are two summits focused on how we can help people with disabilities who are either unhoused or at risk of becoming unhoused.
- 3. Work Council is releasing our first 2024 annual SB 639 report on subminimum wages and we are working with CHHS on the Employment 1st Office.
