#### 1. CALL TO ORDER

Chair Wesley Witherspoon called the meeting to order at 10:32 A.M.

#### 2. ESTABLISH QUORUM

A quorum was established.

#### 3. WELCOME/INTRODUCTIONS

Members and others in attendance introduced themselves.

#### 4. PUBLIC COMMENTS

There were no public comments.

#### 5. CHAIR REPORT AND COMMITTEE REPORTS

Chair Witherspoon shared that he attended the National Association of Councils on Developmental Disabilities (NACDD) Conference in Florida alongside Executive Director Carruthers. He trained Council Chairs on how to run a good Council. He also announced plans to present at the Association of University Centers on Disabilities' (AUCD) 2023 Conference in Washington, DC in early November on leadership roles for people with disabilities in non-profit organizations. Furthermore, he was invited by the National Association to serve on a search committee for the next CEO, composed of self-advocates, family advocates, Council Executive Directors, and Council Chairs.

The Chair announced various national observances for September, including Rosh Hashanah, Mexican Independence Day, National Voter Registration Day, and Yom Kippur. For October he highlighted Hoshana Rabbah, World Cerebral Palsy Day, National Coming Out Day, his birthday on the 30<sup>th</sup>, and Halloween. He also invited Councilmembers to his birthday party on October 21<sup>st</sup>.

# 6. APPROVAL OF JULY 2023 MEETING MINUTES Action 1

It was moved/seconded Fujita [F.A]/ Adler [S.A.]) and carried to approve the July 2023 meeting minutes as presented. (See last page of minutes for a voting record of members present)

#### 7. STATEWIDE SELF-ADVOCACY NETWORK (SSAN) REPORT

SCDD SSAN representative Alex Reyes provided Councilmembers with an update from SSAN's in person hybrid meeting on September 7th, 2023. The next SSAN meeting will be held in December.

#### **SCDD POLICY UPDATE**

Deputy Director Bridget Kolakosky announced the 3rd annual "There Should Be a Law Contest!" from September 1st through September 30th. In 2023, the Council prioritized employment, safety, and housing. Employment was their number one priority. Deputy Director Kolakosky highlighted the success of the Employment First policy which led to the creation of the Employment First Office and the permanence of the LEAP SIP program. She relayed that the Legislative and Public Policy Committee has consistently dedicated time during their meetings to address concerns and engage in discussions on policies related to safety for people with disabilities. Additionally, the ongoing advocacy for housing, specifically through the co-sponsoring of SB 37, aimed to address rental subsidies for those in need.

She provided a comprehensive overview on the legislative process of the bills supported by the Council. She noted that given the two-year legislative session, bills that did not pass in 2023 may still progress. AB 244 failed to meet its committee deadline, while SB 483, AB 222, and SB 37 shifted to a two-year cycle. The Council extended its support to SB 544 and AB 624, while withdrawing support from AB 1097 due to its transition into a tax measure. Two bills, SB 246 and AB 1568, failed in the Appropriations Committee but may be reconsidered. The Governor signed AB 87 and AB 946 into law. AB 1567 remains in committee with hopes for advancement next year. Bills awaiting the Governor's signature include AB 248 (Mathis), AB 545 (Pellerin), AB 447 (Arambula), AB 624 (Grayson), SB 271 (Dodd), and SB 544 (Laird).

The Council does not often take positions on federal bills, as they defer to the National Association of Councils on Developmental Disabilities on federal legislation. However, they received information about the SSI Savings Penalty Elimination Act, a bill designed to enhance security income benefits and raise asset limits to \$10,000 for individuals and \$20,000 for couples. Staff will monitor the Act as it is in motion and subject to amendments.

#### 8. EXECUTIVE DIRECTOR REPORT AND STAFF REPORTS

Executive Director Carruthers began his report with a quote from Dr. Victor Pineda, a Social Development Scholar and Disability Rights Advocate. He highlighted the need to celebrate diversity within the Latino community and among individuals with disabilities.

The State Plan serves as the Council's contract with the federal Administration on Community Living (ACL) for federal funding. This 5-year plan (2022-2026) reflects the Council's values and commitment to bringing positive change to California for individuals with disabilities and their families. Notable achievements from the past year included the completion of 4 out of 11 objectives, a revision to increase the goals for those objectives, and significant progress on two more objectives. State Plan staff have initiated the Program Performance Report (PPR), detailing last year's achievements. Furthermore, the ACL approved the Council's workplans for 2024, 2025, and 2026. These internal documents guide the Council's work. As a reminder, Cycle 45 grants end on September 30th, and Cycle 46 grants begin on October 1st.

The Statewide Self-Advocate Network (SSAN), a self-advocacy project overseen by the Council, held their first in-person hybrid meeting on September 7, 2023. They met to discuss ways to be more effective in their work, both individually and collectively as a self-advocacy network. They generated ideas for regional projects in the areas of Self-Advocacy, Systems Change, and Capacity-Building. Additionally, SSAN restructured its workgroups to prioritize four short-term projects related to employment. These projects include hosting an Employment (NDEAM) Webinar on October 30th, creating employment tip-sheets, documenting success stories in employment, and developing Disability Awareness Trainings.

On September 12, 2023, the Service International Employees Union (SEIU) members ratified a contract with the state of California. This agreement included a 3% wage increase for employees starting July 1, 2023, and a 7% increase for Office Technicians. This move ensures that entry-level state jobs will now offer \$25/hr, an essential raise to acknowledge employees' hard work and to address inflation. The next step involves modifying the Council's adopted budget display for 2023-2024 to accommodate the wage increase, which will be presented to the Executive Committee for approval.

The Executive Director shared that he and other community leaders were invited to the White House for "Communities in Action: Building a Better California" on October 5, 2023. He offered to carry forward messages and concerns from Councilmembers regarding issues that matter most to individuals with IDD and their families.

Councilmember Brodie-Crumsey advocated for removing the R word from federal language. Councilmember Jones discussed the challenges faced by married couples with disabilities due to benefit structures that risk cutting their income. Councilmember Neward discussed the importance of partnering with developers and building owners to address access issues and supporting disability-owned businesses through private-public partnerships. Councilmember Reyes emphasized the importance of including people with disabilities in decision-making. Councilmember McNair advocated for person-centered services from infancy to end of life, emphasizing the need for well-trained, respectful, and well-paid staff. Councilmember Barnwell emphasized the importance of considering the perspective of people with disabilities when crafting laws and policies, keeping in mind their unique challenges, talents, and attributes. Councilmember Ponton raised awareness of rare diseases and the need for accessible healthcare, especially in rural areas. Councilmember Nieves called for equal participation in employment, healthcare, and social opportunities. Councilmember Gaona pointed out the need to reevaluate IHSS benefits to avoid penalizing higher earnings. Councilmember Adler reinforced the significance of eliminating derogatory terms from law and society.

The Executive Director assured Councilmembers that he would convey their concerns to the White House.

## 9. NATIONAL DISABILITY EMPLOYMENT AWARENESS MONTH OCTOBER 2023 STORIES AND LESSONS LEARNED

National Disability Employment Awareness Month, celebrated every October, highlights the contributions of workers with disabilities and promotes inclusivity in the workforce. Three self-advocates, Sydney Krebsbach from the Washington State Council, Councilmember Julie Gaona, and Councilmember Alex Reyes shared their unique employment journeys.

Sydney, who co-chairs the Washington State Developmental Disabilities Council, discussed her experiences as an Energy Specialist at Spokane Neighborhood Action Partners (SNAP) and her advocacy work with the ECHO Autism Hub Team at the University of Washington. She recounted her decade-long journey through various jobs, emphasizing the challenges she faced in securing stable full-time employment. Sydney's

inspiring message urged others not to give up in their search for the right job.

Councilmember Julie Gaona recounted her academic journey, highlighting a shift from university aspirations to community college and eventually to a career catalyzed by volunteer work. Julie emphasized the value of volunteering as a pathway to employment and skill development.

Councilmember Alex Reyes noted that he was hired through the SSI Program "Your Ticket to Work" with the Fremont Unified School District in 2015. He currently serves as a substitute campus supervisor, and responsible for campus security. He also revealed that he began his own DJ business in 2001. Alex emphasized the importance of finding the right resources for job opportunities.

# STATEWIDE SELF-DETERMINATION ADVISORY COMMITTEE (SSDAC) SUMMARY

#### Date of Meeting

September 28, 2023

#### Meeting's Focus

The Statewide Self-Determination Advisory Committee (SSDAC) met on September 28<sup>th</sup>. The meeting began with Co-Chairs reporting on several Self-Determination Program (SDP) related items, including the SSDAC Workgroup's activities since the last meeting and a summary of the data that was collected in the SSDAC Bi-monthly Reporting Survey, and the release of the SCDD Unprofessional Conduct Policy.

Executive Director Aaron Carruthers provided members with an update on the SDP-related activities the Council is engaging in, including SDP data collection, the Statewide Orientation, and the SDP evaluation findings.

Staff from DDS then provided members with an update on SDP-related activities, including relevant updates on directives, new data sets that were being collected and more.

During the second half of the meeting, Committee members were provided with an update on the SDP Best Practices Platform. Members also engaged in an activity to help determine the topics that will be discussed at the SSDAC's December meeting. This meeting will be a Town Hall event where members will hear from members of the public on issues related to Financial Management Services (FMS).

#### Meeting's Focus

The Employment First Committee (EFC) met on October 12<sup>th</sup>. The primary focus of the meeting was to determine how the committee will focus its efforts on informing the newly established Office of Employment First under Department of Health and Human Services. On July 1, 2024, SCDD's Employment First Committee will be inoperative, and the Employment First Office will form an Employment First Committee as part of its mission. Members reviewed and approved the timeline for the 2023 EFC Annual Report and adopted an outline of what will be included in the report. Members have agreed to focus the annual report on providing the Employment First Office with information and recommendations that will assist in moving employment policy forward.

Members received updates from Deputy Director's Tania Morawiec and Bridget Kolakosky. Deputy Director Morawiec provided updates on Competitive Integrated Employment (CIE) implementation activities, including the NEON grant. Deputy Director Kolakosky presented an update on CIE related bills the Council is supporting and/or co-sponsoring.

The meeting concluded with updates on standing agenda items such as the implementation status of data sharing legislation, the CIE Blueprint, and more.

#### **Chief Deputy Director's Report: November 2023**

The Chief Deputy Director (CDD) continues overseeing operational matters, in concert with staff, and identifying organizational tools to assist the team. Time also has been spent meeting with staff, management, and external partners on various programs, program policy, and implementation, including the Supported Decision-Making Technical Assistance Program (SDM TAP).

Other projects include collaborative conversations with DDS partners regarding the CRA/VAS and QA programs, and other opportunities/project ideas regarding employment and quality assessment surveys. Conversations address funding and contracting matters as well as program efficiencies such as digital surveying strategies.

The Chief Deputy Director continues to facilitate and oversee SCDD's administrative functions such as budget management, contracts, and day-to-day operations.

- Successfully recruited for, and filled, the last of three limited-term positions for the Supported Decision-making Technical Assistance Program (SDM-TAP) Grants Program. The team is fully staffed with one supervisor and two analysts.
- Participated in community conversations regarding the SDM-TAP. This was a series of stakeholder discussion regarding individual and family experience with supported decision making and what was successful and/or challenging for those pursuing or interested in supported decision making. Many participants registered for the conversations to merely learn more about supported decision making.

The conversations explored supported decision making in five distinct settings: healthcare, education, the courts, service systems, and financial interests. Stakeholder input will inform both the program grants and supporting contracts (e.g., program evaluation).

Reviewed program and administrative contracts for approval.

- Reviewed and approved numerous invoices for program, administrative, and operational services.
- Worked with the budget manager on numerous budget-year projects (i.e., technical budget building) and drills from control agencies such as the Department of Finance.
- Collaborated with SCDD's Vaccine Project Manager, Mirna Leal, on final projects and events funded by our grant from the Centers for Disease Control, and attended several meetings and planning sessions with our UCEDD partners in support of our work with them on healthcare access and equity issues for people with I/DD.
- Continued participation in a workshop series co-led by the Department of Developmental Services and the Department of Aging: the State Alliance Team. The project is funded by a federal grant intended to bridge I/DD and aging and expand reach to serve more Californians with I/DD with cultural and linguistic competency, especially those who represent diverse populations and are older and/or have aging family caregivers. The group has identified several priorities and subsequent will refine these further into action steps. Priorities include, developing resources and training to promote awareness on early signs of cognitive decline for individuals with I/DD, and creating an inventory of tools, best practices, and resources for future planning.

#### REPORT FROM DEPUTY DIRECTOR, POLICY, AND PUBLIC AFFAIRS

#### **POLICY UPDATE**

- ✓ Employment 1<sup>st</sup> Office: continued the ongoing work of gathering resources and referrals to support the CHHS agency in preparing for, and launching, the Office of Employment 1<sup>st</sup>. This includes work in the Employment First Committee; regular presentations across the state with various organizations including the housing summit hosted by the California Community Living Network (CCLN), another summit sponsored by the Lanterman Housing Alliance, 8 regional advisory committees (RAC), and the Supportive Life conference.
- ✓ 2024 Legislative Discovery: ongoing meetings with individuals and advocacy organizations discussing possible bills they plan to prioritize for 2024, these range from addressing challenges in housing subsidies to wage disparities accompanied by the new minimum wages set for fast food workers (\$18/hour) and healthcare workers (\$25).
- ✓ Colaboración Latina (via UC Davis Health- MIND Institute): Collaboration group is comprised of different Spanish speaking agency staff. Attended meetings to learn more about concerns affecting the Latino clients, to learn more about inclusiveness of services in response to findings in the Little Hoover Commission Report and the Bill Ideas Report that Latino parents found it difficult to navigate services from regional centers. Gave presentations in Spanish on new policy developments such as Employment 1st office and AB 447.
- ✓ **Deaf Steering Committee:** Attended monthly meetings as a Committee Member. Discussions centered on how to better provide/improve assistance/services to the deaf/hearing impaired clients; this included identifying how deaf clients communicate (as there are different levels of hearing loss and different ways deaf clients communicate) and creating a process to assess (assessments) what is needed to communicate with deaf clients. Training and hiring staff were also discussed to improve communication with deaf clients.

#### COMMUNICATIONS UPDATE

#### OUTREACH

✓ OCTOBER NEWS & EVENTS: Included active links and messaging that highlighted National Disability Employment Awareness Month, Filipino American History Month, Down Syndrome Awareness Month, and National Bullying Prevention Month. Notable mentions included World Cerebral Palsy Day, Indigenous Peoples Day, and the Great California ShakeOut. Also included the initial introduction of the SDM-TAP Grant Input Survey in English and Spanish. Messaging was disseminated to over 17,000 unique email addresses, including the CA Legislature via Constant Contact, and shared via the Council's primary social media pages.

- ✓ SDM-TAP Week of Community Conversations Dual Language Messaging (English and Spanish). Promoted the week-long series of community conversations to engage the public and gather feedback that will influence the direction of the grants available through SDM-TAP. Messaging was disseminated to over 19,000 unique email addresses, including the CA Legislature via Constant Contact, and shared via the Council's primary social media pages.
- ✓ October Self-Determination Program (SDP) Orientations–Multiple Languages: An email blast with messaging promoted the schedule of SDP orientations in Hmong, Spanish, Mandarin, Cantonese, and American Sign Language. Messaging also, included translated flyers and was disseminated to over 19,000 unique email addresses, including the CA Legislature via Constant Contact, and shared via the Council's primary social media pages.
- ✓ SDM-TAP Statewide Community Input Survey Dual Language Messaging: Comms created a single sheet Constant Contact survey in <a href="English">English</a> and <a href="Spanish">Spanish</a> as an alternative to the multi-page Qualtrics survey. Messaging was disseminated to over 19,000 unique email addresses, including the CA Legislature via Constant Contact, and shared via the Council's primary social media pages.
- ✓ NOVEMBER NEWS & EVENTS: Included active links and messaging that highlighted Native American Heritage Month, and Election Day–California County Elections. Also included ongoing messaging about the SDM-TAP Grant Input Survey in English and Spanish, and the multi-language Self-Determination Program orientations. Messaging was disseminated to over 17,000 unique email addresses, including the CA Legislature via Constant Contact, and shared via the Council's primary social media pages.
- ✓ 2023 SCDD Legislative Update: The 2023 Legislative Update included a list of bills that the Council supported, their status and an active link to the bill text. The update included bills in the following categories: Civil Rights, Education, Housing, Human Services, and Public Safety. The update was disseminated to over 19,000 unique email addresses, including the CA Legislature via Constant Contact, and shared via the Council's primary social media pages.
- ✓ Participated in legislative outreach planning meetings and assisted regional offices, SCDD committees, and partners with disseminating information about existing and upcoming initiatives (including webinars and live in-person events) via statewide email or social media.

47 training and events occurred in this time frame. 157 collaborative meetings/chats and clinics occurred with 34 prep sessions to support self-advocate and family advocate leadership.

# Spreading the Word; SCDD at Statewide and Local Conferences Supported Life Conference:

• SCDD staffed a resource table at the Sacramento Statewide Supported Life Conference. Much interest in our emergency preparedness training and past grant projects like "Let's Work" exists. Staff will join the planning team for future conferences to help ensure SCDD priorities and speaking opportunities for self-advocates and staff are optimized in this venue. Deputy Director Bridget co-presented in Employment First with a supported employment provider at the Supported Life Conference. Bridget gathered feedback and ideas for the Employment First Office which will be created under California Health and Human Services in 2024.

#### San Diego Self-Determination Conference:

 A Self-Determination Program (SDP) Presentation titled "Getting Unstuck" occurred at the San Diego Regional Center (SDRC). SDRC has the highest rates of SDP enrollment and a large SD team. Many SA led sessions explored the positive aspects of programming like heightened individualization of services leading to more community-based activities like art classes, gym classes, and small business development in areas of personal interest.

SCDD's statewide SDP Trainer Christine Tolbert, SCDD's Regional Office Manager Mary Ellen Stives, and Debra Jorgensen, co-facilitated the "Gtting Unstuck" Break Out Session.



Many self-advocates, family members, providers and regional center staff attended this session. Opportunities to ask questions and brainstorm solutions to the person-centered plan development, budget creation process and service access phases of SDP occurred.

Additional presentations at the conference highlighted self-determination success stories and shared lived experiences with the program which provides more versatility in services and begins with a person driven plan.

#### **New NEON Federal Grant Application**

SCDD completed and submitted Year 2 Office of Disability Employment, NEON federal technical assistance grant application with a 4-part focus. SCDD successfully applied to the 2023 NEON cohort. Deliverables included developing a community of practice and facilitating meetings with national subject matter

experts on blending, braiding and sequencing funding for competitive integrated employment. This supported interagency collaboration and funding strategies for employment initiatives.

#### **Emergency Preparedness, Go-Kit Distribution**

Deliveries of Go-Kits and planning for a second round of emergency preparedness training is beginning. High demand for this training exists. It is also an excellent opportunity for self-advocate co-trainers and draws in new stakeholders. Ordering, planning for delivery, unpacking and dissemination is a huge task for SCDD regional teams which are not resourced for large scale storage and dissemination. This is an "all-in" project that often leverages HQ staff and community partners for storage, dissemination, and delivery facilitation.

This is the second round of emergency preparedness go-kit dissemination. The first round, sponsored by American Red Cross (see photos below), amplified community need for these life-saving resources and training. This year, SCDD's go-kits are provided via a grant from California Community Foundation.



#### **Self-Advocates Leading NDEAM Webinar**

SCDD Statewide Self Advocacy Network (SSAN) hosted its first all Self Advocate planned and executed Employment focused webinar. Members took leadership and project design to a new level as they decided on a workgroup chair, discussed the goals and objectives of the event, discussed roles and responsibilities of members, and worked with the SCDD team to advertise

and implement the interactive ZOOM webinar celebrating National Disability Employment Awareness Month (NDEAM). This exciting opportunity to share insights and lived experience is the first in a series of SA led webinars.

SCDD commemorates 25 years of interagency collaboration with DDS to serve individuals residing in and transitioning from the DDS California state facilities. SCDD through the CRA/VAS Program worked through the successful closures of the following Developmental Centers - Sonoma, Agnews, Fairview, and Lanterman and Sierra Vista Community Facility. Stockton and Camarillo DC closed prior to 1998. CRA and VAS served the newly created DDS STAR crisis units. From an institutional population of approximately 5000 individuals in 1998 down to about 300 in 2023, SCDD was a key partner in California's deinstitutionalization of individuals with intellectual / developmental disabilities.

#### **Porterville Developmental Center**

Covid outbreaks created the need to quarantine some client areas this reporting period. CRA attended 15 IPP/special meetings; 8 transition, 14 Human Rights and Behavior committee meetings; CRA and VAS advocating least restrictive interventions and supports for transgender individuals; VAS assisted individuals with end of life planning in the community; VAS program attended 10 IPP/special team meetings; and 50 transition planning meetings inside the DC and in the community

# Quality Assessment Project (QAP) Report

#### **Eligibility for Family Surveys**

Family Surveys collect demographic information on both the individual receiving services ('family member') as well as the person who fills out the survey (the 'respondent') and information on services and supports received.

Child Family Survey (CFS): Mailed to families who have a child family member (ages 17 and under) who lives with the respondent and receives at least one regional center funded service in addition to case management.

Adult Family Surveys (AFS): Mailed to families who have an adult family member (ages 18+) who lives with the respondent and receives at least one regional center funded service in addition to case management.

Family Guardian Survey (FGS): Mailed to families who have an adult family member (ages 18+) who lives in the community (outside the family home) and receives at least one regional center funded service in addition to case management.

#### **Upcoming Cycle: Family Surveys**

SCDD continues to prepare for family surveys to be mailed. Mail out is anticipated to begin January 2024. Staff are currently conducting outreach and educating the community about the importance of completing family surveys.

While the sampling strategy has not yet been finalized, DDS has returned to the strategy of sampling all eligible families per regional center (RC), per family survey as opposed to sampling 2,000 eligible families per 21 regional center (RC), per family survey. Each survey will also now be offered in 4 additional languages (Urdu, Portuguese, Japanese and Hindi), for a total of 17 languages.

More to come as we enter the Family Survey Cycle.

#### **About National Core Indicators**

National Core Indicators<sup>™</sup>(NCI) strives to provide states with valid and reliable tools to help improve system performance and better serve people with intellectual and developmental disabilities and their families.

Through a contract with Department of Developmental Services (DDS), State Council on Developmental Disabilities (SCDD), using the NCI Survey tools, collects quantitative data on consumer satisfaction, provision of services, and personal outcomes. Data collection is completed through face to face interviews with consumers as well as mail-in surveys from families.

This data collection effort will enable DDS to evaluate the quality and performance of California's developmental disability service delivery system and among all the 21 regional centers over time.
