

Who Is the SSDAC?

The Statewide Self-Determination Advisory Committee (SSDAC) is comprised of the chairs of the 21 local advisory committees or their designees and a Councilappointed Co-Chair. The State Council on Developmental Disabilities is responsible for convening these meetings.

The SSDAC is responsible for identifying best practices, effective training materials, implementation concerns, and systemic issues. The Committee also makes recommendations on ways to enhance the SDP.

The SSDAC is committed to ensuring regional center clients are informed about the program and given the opportunity to achieve more freedom in their lives.

What has the SSDAC been doing?

The SSDAC has had a number of successes over the last few years, including:

- Releasing "the Barriers to Implementing the Self-Determination Program" report in 2020.
- Creating workgroups to work on Committee identified priorities in between meetings.
- Developing and releasing the Best Practices Platform.

What's New With FMS?

The Department of Developmental Services has made several changes to improve participants' experiences and increase access to FMS.
