

Housing forms are often written at a 15th-grade reading level, so many residents do not understand their rights or responsibilities about housing and rental rules

The Kelsey | Plain Language

Plain language is writing that helps the reader understand documents as quickly, easily, and completely as possible

It has been used by many other government programs - but not with housing

The Kelsey: Collaborative Efforts

The Kelsey brought together a team of professionals to review, simplify, and make sure six (6) commonly used, affordable housing documents had the same legal protections as nonplain language documents.


The Kelsey | Plain Language: Example

Lease Agreement	Describes rental arrangement between landlord and resident	Security Deposit: We may apply the deposit after you vacate the premises to repair any loss or damage caused by you or your guests to the Dwelling Unit or the Property	Plain Language When you move out, if you do not owe rent or mone for damages, beyond normal wear and tear, we will send you the entire security

The Kelsey | Impacts



Strong positive feedback from stakeholders, including people with I/DD

By end of 2025, the Kelsey's plain language documents will be used for 300+ units of housing for people with disabilities

The Kelsey | Barriers and Lessons Learned

Translating legal language into plain language takes a **LOT** of time

Plain language and accessible documents create shared respect between the landlord and resident



The Kelsey | Barriers and Lessons Learned (Cont.)

People who fund affordable housing have no interest in changing something that doesn't affect them; it's important for residents to advocate for fully accessible documents

Federal leasing documents made through HUD are the most complicated leasing documents, even though there is a federal mandate to use plain language; advocacy is needed to encourage all levels of government to adopt the use of plain language documents.
