## SCDD Cycle Grants Previously Asked Questions and Answers (Q&A)

## GrantVantage Platform-Related Questions: As updated on March 29th, 2024

#### 1. What is the GrantVantage website link, in order to create a new account?

# 2. If we have already established a GrantVantage account for a previous grant (e.g. through DDS), will we still need to set up another account?

Yes. SCDD's grant portal is separate from that of any other entity and requires its own separate account.

#### 3. How can I start the grant application?

We recommend that all potential applicants begin by reviewing the Cycle 47 'Grants Guidelines' document at: Cycle 47 Request for Proposal Grant Guidelines (ca.gov).

## 4. Will we need to set up a Microsoft account all over again, or can we use our company account?

No, you don't need to set up a separate Microsoft account. You will just need to register a new account on SCDD's grant application platform at: <a href="https://cascdd.gvgrantcloud.com/">https://cascdd.gvgrantcloud.com/</a>.

### 5. How many questions do we need to answer in the application?

There are 39 questions in the application, <u>all</u> of which require responses. This includes both a) those that require documents to be uploaded and b) declarations/assurances that will require authorizing initials, as confirmation.

#### 6. Can one ask for support in the portal itself?

Yes, there is a 'Help Desk' link in the header of the SCDD GrantVantage portal. If you click on the 'question mark' icon, it will take you directly to the Help Desk.

## 7. What are the GrantVantage office hours?

GrantVantage Help Desk hours are from 8:00am-6:00pm, Pacific Time.

## 8. Is there a Help Desk chat or is it just available via telephone call?

The Help Desk will respond to a 'help ticket' sent via email. If your issue cannot be resolved through email communication, you will be sent an invitation for a meeting to troubleshoot.

## 9. Is the GrantVantage Help Desk open on weekends?

No, the Help Desk is only open Monday through Friday, from 8:00am-6:00pm, Pacific Time.

## 10. Will future SCDD grants use the GrantVantage platform?

Yes, pending any future program changes, grants will continue to use the GrantVantage platform.

## **General Cycle 47 Questions**

11. How long does one have to be in business to qualify to apply for the Cycle 47 Grant?

SCDD does not require any minimum length of time in business. All are welcome to apply.

# 12. Is this open to sole proprietors' consultants? Can a school-based entity, such as a County Office, apply?

The Council will award funding on a competitive basis to California-based agencies and organizations that represent and/or serve individuals with intellectual/developmental and cross-disabilities. Eligible Applicants may include:

- Local government agencies
- Non-governmental organizations
- Tribal organizations
- Community-based non-profits

Established coalitions that are classified as 501(c)(3) tax exempt under the Internal Revenue Services (IRS) Code. Under this definition, community is defined as a city, a group of cities, a county, a group of counties, and/or Tribal land(s). Applicants may submit proposals as a single organization or on behalf of a consortium of organizations.

# 13. The grant requests are very specific. Can the proposals address areas that are related to - but outside of - those specific grant focus area descriptors?

#### 14. Who is on the State Plan Committee (SPC)?

The Scoring Panel members are qualified SCDD staff and members of the State Council on Developmental Disabilities with the requisite knowledge and/or experience in the supports and services needed by Californians with I/DD and their families and are knowledgeable about the processes related to the Council's Program Development Grants (PDG).

### 15. Can you explain what a Bidder's Conference is?

A Bidder's Conference is a meeting that an agency schedules upon the release of a new bid proposal. The Bidder's Conference is designed to give interested, eligible, and/or potential applicants the opportunity to ask questions regarding the project(s) and/or application process.

#### 17. What is the maximum request/award amount per application?

For federal fiscal year (FFY) 2025, the Council has designated a total amount of \$300,000 to fund Cycle 47 projects in one or more of the following proposed topic areas: Health (Tribal), Self-Advocacy (Plain Language), and Self-Advocacy (Isolation). The Council understands that the final list of approved grant projects may not address all three (3) of the targeted topic areas. The Council will consider all proposal submissions and choose one (1) or more grant-funded projects that (in combination) will not exceed the full \$300,000 budgeted amount.

18. Can one organization apply for all focus areas in one application or do you recommend separate applications with specific focus/target areas?

No, you must apply separately for each focus/target area and project.

19. If a project addresses two areas, but the budget can be identified clearly for each area, should there be 2 applications (1 for each area), explaining that they are both part of the same project?

No, you must submit one application per project, even if that project addresses two areas. You will need to select the focus area that best fits your project.

20. If individuals with I/DD have high support needs and/or require multiple areas of services and supports (e.g. developmental, behavioral and/or health/medical, etc.), would that community or population be considered under-served/unserved?

Yes, there is a question in the application that lists various unserved/underserved populations from which you are to select. One of those options is 'cross-disabilities.'

21. What contributions qualify for the 'in-kind' match? What counts as an 'in-kind' cost?

Matching funds include:

- Non-federal public or private funds
- Funds that are not used as match for any other federal program
- Unrecovered indirect costs
- Either cash or in-kind, fairly evaluated\*\*

In other words, match can be either an actual cash expenditure or a something that involves tangible contributions (in-kind contribution). In-kind match contributions come from the grantee organization. In-kind match is typically provided in the form (assigned value) of personnel, goods, and/or services, including direct and indirect costs. Third party in-kind match contributions come from other non-federal third-party sources. Third-party in-kind match contributions come in the form (assigned value) of personnel, goods, and services (including direct and indirect costs), which may also include covering the cost of facility use, etc. Grantees and third parties must document the contributed resource and its value, using receipts, payroll records, etc.

The most common type of match -, and the easiest to track - is a cash match, which is an actual cash contribution. A cash match comes from either the grantee organization's own non-federal (general revenue) funds or cash donations of non-federal funds from third parties (e.g., partner organizations), or by non-federal grant sources.

22. Does the Match requirement mean that my organization has to provide a percentage of the money/cash for the project? My organization just uses volunteers and has no fiscal budget; does this mean we will not qualify?

The match may be in-kind or cash, with appropriate documentation for the resources provided.

23. Can you clarify what the Match requirement is again (e.g. for Los Angeles County)?

A match of 25% is required for Non-Poverty Areas and a 10% match is required for Poverty Areas in which services will be provided. A 'poverty area' is typically defined as that in which 20% or more of the population lives below the established poverty level. Poverty levels, by county, can be found at: Exhibit A California Poverty Levels by County 2021.

24. Is there a percentage limit on administrative costs?

No, there is no percentage limit, as long as the basic requirements are met.

25. Is the deadline for Questions May 1 2024 or April 1 2024?

The deadline for questions is May 1, 2024

26. Could a partnership between non-profit and for-profit apply?

Yes, if the bidder/applicant is the non-profit agency.

27. What outcomes do you envision for teaching Plain Language "translation" to Pwl/DD?

28. We are located in a California-designated, low-income community; is that a 'poverty area?'

29. We received funding in 2023 for Community Integration with our regional center, which was DDS funding, grant cycle was April to November. Will that not allow me to qualify for this grant or disqualify us?

SCDD grants are funded through federal monies and are not necessarily limited by other funding sources.

30. If we need to keep checking for updates until May 3, is it safe to submit before then? In other words - is it possible something will change?

31. Can organizations be formed elsewhere as long as they obtain good standing in California?

You will be required to provide a letter showing that you are in good standing and proof that your are registered with the CA Secretary of State.

# 32. If our county has less than a 20% poverty rate, but the clients we serve are all LMI, does that affect the required match?

The poverty percentage is based solely on the county in which the project is located.

#### 33. Can this support staff pay?

Yes, there is a section for salaries in the budget sheet.

#### 34. Is there a certain number of applicants that will be funded?

No, but the total number of funded projects cannot exceed the \$300,000 grant allotment for Cycle 47.

#### 35. Can we purchase transportation - like a van?

No. A list of 'Allowable' and 'Non-Allowable' costs is located on pages 14-16 in the Cycle 47 'Grant Guidelines' document at: Cycle 47 Request for Proposal Grant Guidelines (ca.gov).
