1. CALL TO ORDER

Council Chair Wesley Witherspoon announced that SAAC Committee Chair Eric Ybarra is unable to attend the meeting and asked him to chair the July SAAC meeting. Council Chair Witherspoon called the meeting to order at 1:35 P.M.

2. ESTABLISHMENT OF QUORUM

A quorum was established.

3. WELCOME AND INTRODUCTIONS

Committee members and others in attendance introduced themselves. During the introductions several members shared their struggles with adjusting to the heatwaves happening in several parts of the state and different cooling strategies. Members raised concerns about consistent access to air conditioning and other cooling methods.

4. PUBLIC COMMENTS

There were no public comments.

5. APPROVAL OF MAY 20, 2024 MINUTES

Members reviewed the minutes from the May 20th, 2024 meeting. The minutes can be found starting on page 7 of the July 2024 SAAC packet.

ACTION 1

It was moved/seconded (Reyes [SA]/ Ponton [SA]) and carried to approve the May 20th minutes as presented. (**Vote Count:** 6 Ayes, 1 Abstention, and 3 Absent; Ayes: Gaona, Garnica, Jones, Ponton, Reyes, Witherspoon; Abstention: Ryan; Absent: Adler, Nieves, and Ybarra) Motion Passed.

6. REVIEW OF COUNCIL BUSINESS

SCDD Executive Director Aaron Carruthers reviewed Council Business with members. Members shared their experiences with Person Centered Thinking and Planning. Additionally, members shared that they are frustrated with ongoing reports that regional center workers, service providers, and venders are not listening to the clients that they support. Members shared their frustration with last minute cancelation of meetings without rescheduling. Members shared that they benefited from access to social and recreational activities like yoga, and inclusive education models.

7. EMERGING ISSUES AND CONCERNS

Members shared that greater outreach and strategies for engaging selfadvocates, especially youth with disabilities, are needed. Organizations and advocates continue to adjust to hybrid meeting schedules, and it is a challenge to connect with others.

Other concerns brought up included the need for better training for medical professionals, concerns with isolation, transportation, selfdetermination, and having enough people present to hold an advocacy meeting (having a quorum, or half plus one member present).

Alex Reyes, the SCDD Representative to SSAN announced that they would be stepping down from their role as the SCDD SSAN Representative and requested that a new representative be chosen.

8. STATEWIDE SELF-ADVOCACY NETWORK (SSAN) REPORT

Outgoing SCDD Representative to the SSAN, Councilmember Alex Reyes, provided members with a summary report of the June 6, 2024, hybrid SSAN meeting held in Sacramento and over Zoom. The June SSAN Report can be found in the July SAAC Meeting Packet starting on page 15.

9. PANEL DISCUSSION: INDEPENDENCE, EMPLOYMENT, AND FINDING COMMUNITY

Since the passage and signing of the Americans with Disabilities Act (ADA) on July 26, 1990, July has been known as Disability Pride Month. In Celebration of Disability Pride Month, Desiree Boykin, Consumer Advocate for the South-Central Los Angeles Regional Center and PJ Swan, a Workforce Development and Administrative Aide in Lodi, shared how employment has helped them to create a community and build a sense of independence.

10. CALIFORNIA POLICY CENTER FOR I/DD WORKFORCE STUDY OVERVIEW

California Policy Center for I/DD (CPCIDD) Executive Director, Teresa Anderson, spoke to the Committee about CPCIDD's efforts to collect information about the impact of the shortage of direct support professionals on people with I/DD. Ms. Anderson asked for the Committee's help in recommending people to participate in their interview study.

11. REGIONAL OFFICE ADVOCACY PROJECTS HIGHLIGHT: SAN DIEGO AND IMPERIAL

Debbie Marshall, Community Program Specialist for the San Diego and Imperial Regional Office shared with the committee, the work she and the regional office have been doing to support self-advocacy in the San Diego and Imperial Valley regions of California.

Ms. Marshall highlighted the offices efforts to organize different regional conferences, support self-advocacy groups, and support self-advocates in creating and giving self-advocate led trainings on different topics.
