#### 1. CALL TO ORDER

Committee Chair Harold Ashe called the meeting to order at 10:32 AM.

#### 2. ESTABLISH QUORUM

A quorum was established.

#### 3. WELCOME/INTRODUCTIONS

Members and others in attendance introduced themselves.

#### 4. PUBLIC COMMENTS

Brian Capra, Senior Staff Attorney with Public Counsel provided public comment informing committee members about SB 1197, which Public Counsel has co-sponsored alongside Children's Law Center of California. This legislation aims to address a gap in respite services for children in the California foster care system that was caused by an inaccurate citation in SB 84. Mr. Capra requested that the Council consider supporting SB 1197, which will correct the unintended mistake

and will update the language of the law to account for changes in the legal framework pertaining to "resource families" and services for non-minor dependents. Mr. Capra informed members that Public Counsel will release a sample support letter for the bill.

#### 5. APPROVAL OF THE OCTOBER 2023 MEETING MINUTES

It was moved/seconded (Ryan [SA]/Neward [FA]) and carried to adopt the January 16, 2024 meeting minutes as presented. (Motion passed unanimously. See page one for a record of members present)

### 6. OVERVIEW OF LEGISLATIVE AND BUDGET PROCESS FOR MARCH THROUGH JUNE

Deputy Director of Policy and Public Affairs Bridget Kolakosky provided a brief overview of the legislative and budget process. #### 7. STATE LEGISLATIVE AND BUDGET UPDATES

Deputy Director of Policy and Public Affairs Bridget Kolakosky reminded committee members of the Council's 2024 legislative priorities of home, health and work, which the committee approved at the January 2024 meeting.

Deputy Director Kolakosky informed members that the following 2023 bills will continue in 2024:

- SB 37 (Caballero) Older Adults and Adults with Disabilities Housing Stability Act.
- SB 483 (Cortese) Pupil rights: prone restraint.
- AB 1147 (Addis) Disability Equity and Accountability Act of 2023.

The following bills, which were previously supported by the Council, were presented for consideration and discussion:

- SB 1384 (Dodd) Power Wheelchair Repair
- AB 447 (Arambula) Public postsecondary education: students with disabilities: inclusive college programs

The following 2024 bills were introduced to the committee for consideration:

- ACR 150 (Nguyen) Resolution to recognize March as Developmental Disabilities Month
- SB 1001 (Skinner) Death penalty: intellectually disabled persons
- AB 1977 (Ta) Health Care coverage: behavioral diagnoses
- AB 2510 (Arambula) Dental care for people with developmental disabilities
- AB 1885 (Addis) Student Success Completion Grant program
- AB 1938 (Gallagher) Special education: inclusive practices and strategies
- AB 1914 (Grayson) Community colleges: providers of care for individuals with developmental disabilities: model curriculum
- AB 2821 (Grayson) Postsecondary education: students with disabilities
- AB 2753 (Ortega) Durable medical equipment and services
- AB 2423 (Mathis) Annual review of regional center transportation rates
- AB 1876 (Jackson) Developmental Services: individual program plans and individual family service plans: remote meetings
- AB 1281 (Menjivar) Advancing Equity and Access in the Delf-Determination Program Act
- AB 2043 (Boerner) Medi-Cal: nonmedical and nonemergency medical transportation
- AB 2002 (Sanchez) Vehicles: public safety: Blue Envelop Program
- AB 2289 (Low) Vehicles: parking placards for disabled veterans and persons with disabilities
- SB 1285 (Laird) Drivers licenses: disability identifier

Deputy Director Kolakosky provided an update on H.R. 6405, which is in the Subcommittee on Health and addresses marriage equality for people with disabilities. This bill will increase the federal asset limit for Social Security Insurance from \$2,000 to \$10,000 and increase the limit for married couples to \$20,000.

Deputy Director Kolakosky informed members that SCDD has offered to provide resources and recommendations to the Health and Human Services Agency as they work to establish the Employment First Office and will also

work to make sure that the details and priorities of the Master Plan for Developmental Services include the Employment First Office.

It was moved/seconded (Neward [FA]/Ryan [SA]) and carried to recommend that the Council support SB 37, SB 483, SB 1384, SB 1443, SB 1001, AB 1977, AB 2510, AB 1885, AB 2753, and SB 1281. (Motion passed unanimously. Councilmember Harold Ashe was not present for the vote. See page one for a list of members present)

It was moved/seconded (Imparato/Witherspoon [SA]) and carried to recommend that the Council support AB 1876. (Motion passed unanimously. Councilmember Harold Ashe was not present for the vote and Councilmember Nicole Adler Abstained. See page one for a list of members present)

It was moved/seconded (Imparato/Neward [FA]) and carried to recommend that the council support H.R. 6405. (Motion passed unanimously. Councilmember Harold Ashe was not present for the vote and Councilmember Nicole Adler Abstained. See page one for a list of members present)

#### 8. UPDATES AND STANDING AGENDA ITEMS

Executive Director Aaron Carruthers referred committee members to the meeting packet for hyperlinks to official agency updates on the DDS Taskforce and Workgroup, Self-Determination Program and CalABLE and provided an overview of the upcoming Council meeting agenda, which will include a vote on the LPPC's legislative recommendations, an update on the budget, and review of Cycle 47 Grants proposed project descriptions. The Council will also hold an open discussion of the Master Plan for Developmental Disabilities.

Mr. Carruthers informed members that the Statewide Self-Determination Advisory Committee (SSDAC) will meet in April and announced that the committee has released a report of the concerns and recommendations put forth by community members at the December 2023 SSDAC FMS Townhall event. # Housing #1

**Bill:** SB 37 (Caballero) Older Adults and Adults with Disabilities Housing Stability Act

What will the bill do? it would have created a rental assistance pilot program, to prevent homelessness for persons that are older or for persons with disabilities.

**Position: Co Sponsors** 

**STATUS: Vetoed by Governor**. Two reasons for Veto: a) the pilot is not funded in this year's budget and b) it's better to leverage existing programs

# Housing #2

Bill: SB 1443 (Jones) CA Interagency Council on Homelessness (ICH)

What will the bill do? Would have added SCDD to the council on homelessness (ICH).

**Position:** Support

**STATUS: Vetoed by Governor-** DD representation is covered by HHS Secretary and an advisory committee member with DD

# Civil Rights

Bill: SB 1001 (Skinner) Death penalty: intellectually disabled persons

What will the bill do? This bill will protect individuals with an intellectual disability from the death penalty. Not all adults with IDD were diagnosed as children. This bill is for people in prison who have been sentenced with the death penalty but that were not diagnosed with IDD as children. It allows a disabled person in prison to show, through evidence like a medical evaluation, testing, and testimony that they were intellectually disabled before the end of their developmental period.

**Position:** Support

**STATUS:** Approved by Governor- **SIGNED!** 

# **Employment**

**Bill: AB 1147** (Addis/Garcia/Mathis) Disability Equity, Transparency, and Accountability Act of 2024

What will the bill do? It makes regional centers subject to requirements of the California Public Records Act, which means it will improve transparency. Also, it prohibits regional center employees from accepting gifts over \$15 per year from certain agencies and prohibits regional center senior staff from hiring relatives.

**Position:** Support

**STATUS:** Approved by Governor- **SIGNED!** 

### Health #1

Bill: AB 1977 (Ta) Health care coverage: behavioral diagnoses

What will the bill do? Would prohibit healthcare plans from requiring a person who is already diagnosed with a developmental disability or autism to be reevaluated to keep healthcare coverage for their condition. These conditions are for life, they do not change or go away-- getting re-tested just creates a risk of losing important healthcare insurance. Also, re-evaluations are difficult and lengthy.

**Position**: Support

STATUS: Vetoed by Governor- it's not reasonable to prohibit utilization review.



# Health #2

Bill: AB 2510 (Arambula) Dental care for people with developmental disabilities

What will the bill do? Would have created a training program for dental staff to provide dental care services to persons with developmental and intellectual disabilities and reduce the need for regional center consumers to receive dental treatment using sedation and general anesthesia. People with I/DD must wait a long time to receive dental care. This is because there are not a lot of trained dental staff to work with persons with I/DD. Right now, persons with I/DD are sedated or receive anesthesia (puts them to sleep) to receive dental care. This is not always necessary and delays dental care. Delayed dental care means bad health outcomes. This bill will improve dental health.

**Position:** Changed from Support to Watch

**STATUS:** Failed in Appropriations Committee



### Health #3

Bill: AB 2753 (Ortega) durable medical equipment and services

What will the bill do? Would have required health plans to include coverage of durable medical equipment, services and repair. When health insurance plans do not pay for durable medical equipment (DME), people with disabilities are impacted the most because they use health equipment the most. Health equipment is too expensive without health insurance.

**Position:** Support

**STATUS**: Failed in Appropriations Committee

# Education #1

Bill: SB 483 (Cortese) Pupil Rights: Prone Restraints

What will the bill do? This bill protects students with disabilities from being held face-down. This new law will prohibit the practice of prone-restraint on students with disabilities.

**Position:** Support

**STATUS:** Approved by Governor- **SIGNED!** 

# Education #2

Bill: AB 1885 (Addis) Student Success Completion Grant program

What will the bill do? reduces the minimum required units for students in Disabled Student Programs & Services (DSPS) to receive Cal Grant assistance to 9 units, from its current 12 units requirement. Students in DSPS who enroll in 9 units are considered full-time at 9 units but the Cal Grant definition of full-time is currently 12 units. Changing the unit requirement to 9, would make qualifying for Cal Grant assistance more equitable by giving students with disabilities the same opportunity that students without disabilities have to apply for and receive grants to attend college. These grants would be approximately \$1,2000 a year.

**Position:** Support

**STATUS:** Approved by Governor- **SIGNED!** 

### **Human Services #2**

**Bill**: SB 1281 (Menjivar) Advancing Equity and Access in the Self-Determination Program Act

What will the bill do? Would have required the Self Determination Program (SDP) process to be the same statewide by January 2026. The Self-determination Program is not the same from one regional center to another.

**Position:** Support

**STATUS: Vetoed by Governor-** can make these recommendations via Masterplan for DD platform

# Human Services/Housing #3

**Bill**: AB 3291 (Assembly Human Services Committee, Chair Lee) <u>Developmental</u> <u>Services Omni Bill</u>

What will the bill? 1) Allows regional centers (RC) to offer rent, mortgage, or lease assistance when an independent living services consumer is at-risk of being homeless, and when the RC executive director can certify in writing that the consumer has demonstrated risk of homelessness. 2) Requires Regional Centers to discuss a caregiver succession plan with consumers to ensure when their caregiver is unable to provide care there is a plan in place.

**Position:** Support

**Status:** Approved by Governor- **SIGNED!** 



# **Human Services #4**

Bill: SB 1384 (Dodd) Power Wheelchair Repair

What will the bill do? This bill allows wheelchair users to fix their chairs themselves by requiring the makers of wheelchairs to provide information, tools, and replacement parts to owners or other providers.

**Position**: Support

**STATUS**: Approved by Governor- **SIGNED!** 

# **Human Services #5**

Bill: SB 1197 (Alvarado-Gil) In-home respite services: resource families

What will the bill do? bill updates/adds foster youth and their families to the list of persons that can receive in-home respite services. Current law is written to prohibit this group from qualifying for services.

**Position**: Support

**STATUS**: Approved by Governor- **SIGNED!** 

# **Federal**

Bill: H.R. 6405 Marriage Equality for Disabled Adults Act (Congressman Panetta)

What will the bill do? The Act will increase the federal asset limit for persons with disabilities from \$2,000 to \$10,000. For couples, the limit would be raised to \$20,000. So people do not have to choose between getting married or keeping benefits

**Position**: Support

**STATUS**: TBA

# **Budget Update 2024**

### **Budget Approved 2024 for AB 447 (2023):**

- What? In 2023, we sponsored AB 447 (Arambula) to create Inclusive College Programs for students with disabilities, but it passed with no money to fund the program.
- SIGNED! This year Governor Newsom approved \$2 Million Recurring funds for a California Center for Inclusive College (Ca Center) to help students with intellectual disabilities transition to college.
- How will it work? A County of Education will be selected to receive funds via a grant to administer the Ca Center. The Ca Center will provide best practice guidance to create and expand inclusive college programs. It will also assist programs in identifying other funding sources.

# **Budget Update 2024**

**Bill:** AB 1876 (Jackson) <u>Developmental services: individual program plans and individual family service plans: remote meetings</u>

What will the bill do? Allows meetings to be remote (video, like Zoom) for individual program plans (IPP) and individualized family service plans (IFSP). It also improves accessibility to participate in meetings.

**Position**: Support

**STATUS: Passed via Budget**

### **2022-26 State Plan**

### **Goal 1: Self-Advocacy**

By 2026, the Council will maintain and/or increase the number of people with intellectual/developmental disabilities to become strong self-advocates, peer trainers and community leaders.

### **Objectives**

The Council will provide information and resources through 300 regional/statewide self-advocacy chats, 40 regional/statewide projects/events and 200 trainings to strengthen 15,000 self-advocates in:

- 1) Achieving self-governance with supports, as requested;
- 2) Identifying and asking for the supports and services that they need;
- **3)** Becoming and serving as peer trainers;
- **4)** Developing skills and opportunities to engage as strong activists for issues that are important to them and their families; and,
- **5)** Participating in culturally diverse, cross-disability coalitions.
- The Council will collaborate with and/or support self-advocates in peer networks, including culturally diverse, cross-disability coalitions, by providing facilitation, tangible supports and peer advocacy/leadership opportunities through at least 1 statewide and 12 regional self-advocacy entities, reaching 6,000 self-advocates.
- In the event of unforeseen project opportunities, emerging needs, and/or community, cross-regional or statewide requests, the Council may engage in additional activities with and/or on behalf of self-advocates and those who support and serve them.

### **Goal 2: Systems Change/Advocacy**

By 2026, the Council will lead in partnership with family/self-advocates and others to protect and enhance civil rights to improve community-based systems and be more fully inclusive and supportive of people with intellectual/developmental disabilities and their families.

**Objectives** 

2.1	The Council will monitor and collaborate with local, regional and/or statewide entities to develop, improve and/or change 85 practices, 70 policies, and 20 regulations (or guidance), statutes and/or laws in the systems of regional centers, community-based services, and governmental entities. This work will include the areas of employment, education, housing, health/safety and/or emerging issues in ways that will benefit people with intellectual/developmental disabilities and protect their civil rights, promote full inclusion, and/or

provide additional supports and services, improving their lives in tangible ways.

The Council will engage in 40 regional and 5 statewide innovative/special projects and/or events in the areas of employment, education, housing, health/safety and/or self-determination to:

- 2.2
- 1) Support 45,000 people (family/self-advocates and others) in systems change efforts and give them information, skills and/or supports to increase their abilities to become effective advocates;
- **2)** Engage in professional training and/or other efforts to implement systems, demonstrate or support systems change; and/or,
- **3)** Increase services and/or improve supports for people with intellectual/developmental disabilities and their families.

## 2.3

The Council, in collaboration with California's four (4) partners (one Protection and Advocacy agency and three University Centers for Excellence in Developmental Disabilities), will seek to improve the generic service system that impacts people with intellectual/developmental disabilities by choosing one or more areas of emphasis in the State Plan, such as education, employment, housing, and/or health/safety, and report on how that system is serving people with I/DD, gaps in that service delivery system, recommendations on how to improve the systems to meet the goals of the DD Act, and/or pursue policy and practice changes in those areas. The collaboration will result in the review or development of 2 reports, 6 recommendations for policy or practice changes, and 2 Legislative or Administrative changes to policy or practice.

### **Goal 3: Capacity-Building/Advocacy**

By 2026, the Council will increase partnerships with and support of more people with intellectual/developmental disabilities and their families, so they know their rights and can advocate for and receive supports and services.

	Objectives
	The Council will increase the capacity of 60,000 people with assistance and resources to identify and obtain the supports and services to help people with intellectual/developmental disabilities live a safer and healthier life, by:
2.1	1. Establishing and/or collaborating with and supporting 10 family-advocate groups/networks,
3.1	2. Providing (staff-led, peer-led and/or collaborative) training to 35,000 people (family/self-advocates/others) throughout the state – virtually, online and/or in person, and
	<b>3.</b> Providing technical assistance (TA)/advocacy clinics and/or resources, reaching 25,000 people.
3.2	The Council will engage in 150 projects and events in the areas of employment, education, housing, health/safety, and/or emerging issues, reaching 45,000 people (family/self-advocates/others) with information and resources to enhance their knowledge and increase their capacity to obtain supports and services that are important to them.
3.3	In order to reduce the disparities in obtaining a free, appropriate public education, the Council will work with 5,000 Spanish-speaking family/self-advocates throughout the state to advocate for and increase the number and type/quality of special education services they receive through their own local education agencies.

# CALIFORNIA STATE COUNCIL ON DEVELOPMENTAL DISABILITIES

### **Policy Priorities 2025-26**

#### PROTECTING AND ENHANCING CIVIL RIGHTS

Every person with intellectual and developmental disabilities (I/DD) has the right to self-determination, equality of opportunity, full participation, independent living and economic self-sufficiency no matter their disability.

The Council will work to ensure civil rights, including identification and reduction of racial and ethnic inequalities and disparities, are protected and enhanced and full implementation of state/federal policies including but not limited to the Workforce Innovation and Opportunity Act, Home and Community-Based Services Settings Rule, Every Student Succeeds Act and Achieving Better Life Experience Act.

### **GUARANTEEING ACCESS TO EDUCATION AND EMPLOYMENT**

Every student with I/DD has the right to a quality inclusive education with their peers that prepares them for post-secondary education and/or competitive integrated employment (CIE). Students with disabilities must be provided the same opportunities for learning, in the classroom and online, as students without disabilities.

Every person with I/DD should have the opportunity to be employed in CIE. Individuals must have access to information, benefits counseling, transition planning, job training, career exploration and information and support for inclusive post-secondary education. New or expanded pathways to CIE must be developed and supported, including apprenticeships and internships.

The Council will work to ensure the implementation of the Individuals with Disabilities Education Act, Every Student Succeeds Act and other federal and state policies to ensure that students with disabilities are provided the services and supports needed to receive quality inclusive education.

The Council will work to ensure the full and robust implementation of the Workforce Innovation and Opportunity Act and California's Employment First Law, that policies and practices improve opportunities for and incentivize CIE, to create hiring incentives and supports for all employers and contractors and make the state a model employer.

#### **IDENTIFYING & PRIORITIZING EMERGING ISSUES IN THE I/DD COMMUNITY**

Every person with a developmental disability should not have to deal with problems of that arise due to the emergence of inequality issues in the community. Events in our every day lives, both due to policy changes and unforeseen events, have the ability to cause unintended consequences for the I/DD community. These issues must be identified and acted upon swiftly to ensure as little harm as possible is inflicted.

The Council will work to ensure any and all emerging issues including but not limited to dealing with disparity across all I/DD issues, barriers to participating in a community setting, and roadblocks to access for people with I/DD are dealt with through policy changes. The Council will work to ensure the Self Determination Ombudsperson program at the Department of Developmental Services uses its authority to ensure people with I/DD become successful participants in the Self Determination Program.

### PROMOTING ACCESS TO QUALITY SUPPORTS IN THE COMMUNITY

Every person with I/DD should have the ability to fully participate in their communities. Receiving quality, individualized services is the cornerstone for people with I/DD to be safe, healthy and to promote self-determination, interdependence and inclusion. Community-based services/supports require adequate wages for providers; therefore, the state must restore rates. Disparities in access, outcomes and quality for services and supports must be addressed. Complexities in the service delivery systems must be reduced.

The Council will work to continue to restore the Department of Developmental Services programs cut in 2009, to make meaningful improvements to the service delivery system to reduce disparities, increase transparency and accountability and increase quality outcomes, support efforts to provide adequate wages to providers for inclusive and quality supports, and work to ensure successful implementation of the Self-Determination Program.

#### **ENSURING SAFETY IN THE COMMUNITY**

Every person with I/DD has a right to be safe and must be provided emergency preparedness training and training in personal safety. Law enforcement personnel, first responders, emergency medical professionals and the judicial system must be trained in how to work with people with I/DD (including those who are suspects, victims or witnesses of crimes) during the course of their duties.

The Council will work to ensure people with I/DD are safe, free from abuse and neglect and have access to services and supports in their communities during all types of disasters or emergencies and an adequate safety net for people in crisis and access to adequate crisis intervention services.

### IMPROVING HOUSING AND COMMUNITY LIVING

Every person with I/DD should have the opportunity to live in the community. Permanent, affordable, accessible, safe and sustained housing options must be continually developed. Statewide inclusive living options for individuals with I/DD must be increased and enhanced through access to housing and subsidies that are paired in a timely manner with needed services and supports.

The Council will work to implement the policy recommendations in the Statewide Strategic Framework for Housing and create a dedicated housing fund to support integrated community housing for people with I/DD.
