

This misunderstanding has traumatized individuals. It also created lasting legacies of addiction, abuse, and poor coping mechanisms, continuing cycles of suffering within families.

5:29p Chair Emily Witkin called the meeting to order. Valerie Buell took roll call of RAC members and confirmed a quorum was present.

5:30p Approval of meeting minutes for December 4, 2024:

Moved: Terri Carol Seconded: Bird Sellergren

Roll Call Vote: All Ayes

Public Comments: Emily Witkin asked for public comments. Highlights include:

- Jessica Gould, legislative advocacy consultant, formally thanked the Bay Area RAC for always inviting her into these conversations, and introduced her firm's intern, Kai Ryan.
- Alyssa DiFilippo, from Parents Helping Parents, talked about Connections California, a statewide online resource and information hub for transition to adulthood and adult services provided by Parents Helping Parents. She was allowed to share screen and review some details about the hub.
- Patanisha Davis Peterson, District Director for Assemblymember Anamarie Avila Farias' Office:



- The office introduced Assembly Bill (AB) 1034 on teacher credentialing for youth with mental health needs. This bill would require, when commission assessments are next revised on or after January 1, 2026, the commission to include an assessment of a teacher credential candidate's knowledge of youth mental health.
- Assemblymember Anamarie Avila Farias, Assembly District 15:
 - Introduced 25 bills and a few are around the needs of marginalized community members, social service programs and behavioral health.
- Debra Adler shared concern over a federal resolution plan that features tax cuts and potential state funding cuts, including those that could impact Medicaid funding for states. Acknowledged Representative Kevin Mullen for voting against these cuts.
- Frankie Falzon, District Director for Assemblymember Catherine Stefani's office:
 - Introduced himself, the office, and reviewed their district.
 - Mentioned bills they office is working on regarding gun violence prevention, human trafficking, public procurement processes, and protecting seniors from elder abuse.
 - Assemblymember Stefani was formerly a supervisor and county clerk in San Francisco. During that time, she worked to ensure records and services were more accessible to constituents, regardless of accessibility needs.
- Janessa Oriol, District Director for Congressman Mark DeSaulnier:
 - Their office has had a number of phone calls over the last month regarding the current administration's changes, including last night's vote on the budget.
 - Congressman DeSaulnier is a proponent of the developmental disabilities community and is fighting to keep all protections available.
- Tiffanee Jones, District Director for Assemblymember Lori D. Wilson's office:
 - The office introduced 14 bills.
 - AB 394 was introduced to prevent violent crime on public transit. They
 welcome feedback from this community on how this can help the
 disability community.
- Seth Besse, CEO of Undivided:



- Undivided supports families of kids with disabilities as they navigate services to get the care they need.
- Currently in the process of getting vendored with Golden Gate Regional Center (GGRC). Already working with other regional centers in California.
- Nicholas Hargis, representative for Congressman Sam Liccardo's office:
 - Congressman Liccardo is the new representative for District 16, and their office is here to help whenever constituents have a problem with a federal agency.
- Nicole Cuellar-Nelson from Senator Chris Cabaldon's office:
 - Senator Cabaldon has introduced a range of bills from affordable housing to access to higher education. Welcomes constituents to reach out to their office.
- Dr. Rebecca Nanyonjo from Regional Center of the East Bay (RCEB):
 - Introduced herself as the new Executive Director for RCEB.
 - RCEB is committed to helping the community, especially as we experience the federal administration looking to trim resources from states.
- Julian Sanchez from Assemblymember Matt Haney's office:
 - Assemblymember Haney introduced 20 bills this session.
 - One of these bills, AB 371, is about the right to dental care. It would require insurance companies provide access to a dentist near a person's home or workplace and ban insurance companies from requiring patients to pay out of pocket for dental care that is covered by the policy.
 - Assemblymember Haney is chairing the Assembly Housing & Community Development Committee.
- Daijon Jackson from Assemblymember Buffy Wicks' office:
 - Assemblymember Wicks is chairing the Assembly's Appropriations Committee.
 - Happy to be here representing the office and fighting for the community.

Member Reports: RAC Members and Councilmembers reported on their regional and statewide advocacy work and priorities. Highlights include:



Terri Carol:

 Individuals have experienced delays hearing back from Social Security about their SSI or SSDI. This has been an issue to monitor in the community.

• Jennifer Fung:

- Has advanced her advocacy skills while being a member of the RAC, representing Marin Co.
- She will be stepping down due to work and family needs. This is her last meeting as a RAC member. She thanked the office and fellow RAC members.

Bird Sellergren:

In the last RAC meeting, there was discussion about intergenerational trauma and how undiagnosed autism in adults can lead to substance abuse and legacies of abuse within families. Bird will be proposing a RAC working group to start collecting data around this topic that may lead to policy recommendations.

• Emily Witkin:

 Has been leading the committee's working group on health and equity and sensory friendly practices in emergency departments. The April RAC meeting will have an update and presentations on this topic.

• Florence Wong:

- The San Mateo County Commission on Disabilities will have a general meeting at County Center in Redwood City. They are welcoming six new commissioners who will be approved by the board of supervisors in one of their March meetings.
- There will be guest speakers focused on Paratransit services in San Mateo County and will talk about a new program called Paratransit Same Day Service.
- At the March general meeting, the Red Cross will be teaching a handsonly CPR class.

Nicole Adler:

 State Councilmembers have been contributing to the CA Health and Human Services (HHS') Master Plan on Developmental Services work.



- The Council recently approved the State Council budget and was introduced to the new Department of Developmental Services (DDS) Director.
- Thank you for AB 371, which is much needed.

Community Reports:

People First Highlights:

- Sara Desumala read the report for Bay Area People First (BAPF):
 - BAPF had their annual planning meetings parts one and two in December and January. They approved the 2025 meeting calendar and set priorities for the year. They also had a presentation on Individual Advocacy to Systems Advocacy.
 - o The next meeting is on April 16th from 4:30 PM to 5:45 PM.

Regional Center Reports Highlights:

- Eric Zigman gave the report for Golden Gate Regional Center (GGRC):
 - GGRC has meetings coming up on Purchase of Service (POS) demographics discussing what they spend money on and how they spend it. All will be on Zoom. The next meeting is March 12th from 10 AM to 12 PM.
 - The Community Resource Development Plan (CRDP) is granting startup dollars for new programs in the region. CRDP is how regional centers identify services that need to be created or enhanced in the community and then ask DDS for start-up funds to be able to invite providers to launch new services.
 - The new provider rates setting methodology is tied to the local cost of labor, travel, and occupancy. It technically rolled out by January 21st.
 There is still work being done to figure out the rate increase for each provider and it will be retroactive to January 1st.
 - GGRC is working on the rollout of the new standardized Individual Program Plan (IPP). Some technology is not rolled out yet, so staff are entering information the old way until the new technology is rolled out.
- Dr. Becky Nanyonjo gave the report for Regional Center of the East Bay (RCEB):



- RCEB has posted Request for Proposals (RFPs) looking for projects conducting outreach on Self-Determination Program (SDP) and related educational targeting initiatives for African American and Black communities around SDP. Another RFP is for producing a Self-Determination Program (SDP) handbook.
- Events can be found on the RCEB website including upcoming celebrations like:
 - The African American celebration for Black History Month at the Ed Roberts Campus.
 - Congreso Familiar happening on March 1st at Met High School in Oakland from 8 AM to 2 PM.
 - The Asian American Community Conference at the San Leandro Community Center on March 8th.

Developmental Disabilities (DD) Councils Report Highlights:

- Vi Ibarra gave the report for the Contra Costa County Developmental Disabilities Council (CCC DD Council).
 - The CCC DD Council had a presentation on the Home and Community Based Services (HCBS) final rule and why it is important to clients and their family members.
 - At the March 26 meeting, Regional Center of the East Bay will present on the new standardized, person-centered, Individual Program Plan (IPP) form. This meeting will be hybrid; in-person location is Las Trampas in Lafayette.
 - The Joint 2025 Transition Conference and Resource Fair will be in Contra Costa County on March 15 at Diablo Valley College in Pleasant Hill. This annual event is a joint effort between Alameda and Contra Costa counties and alternates from one county to the next year by year.
 - The upcoming Annual Awards Event will take place in June,
 Registration will open for award nominations in April.
- Siobhan Burgos gave the report for the Alameda County Developmental Disabilities Council (ACDDC).



- Tickets for the Joint Transition and Resource Fair will be selling until March 6. Because of the conference, the ACDDC will not be meeting in March but will meet again in April and have a panel on social recreation.
- Last Friday the Health and Wellness Committee met. There was discussion on mental health and suicide risk in the intellectual developmental disabilities (IDD) community.
- The American Academy of Pediatrics will be hosting a Youth Suicide Prevention Summit on March 29, 2025.

National Council on Disability (NCD) Report Highlights:

- Sheraden Nicholau read the report on behalf of NCD member, Sascha Bittner:
 - The National Council on Disability will meet on Thursday and Friday, March 6th and 7th. Both meetings start at 7:00 AM Pacific Standard Time and will be live streamed on Zoom. There will be a report release on Disabled Worker Tax Misclassification with a panel discussion and more topics.

Statewide Self Advocacy Network (SSAN):

- Sara Desumala, Bay Area SSAN Rep, read the report:
 - The last meeting was December 10th & 12th where they reviewed SCDD state plan development questions, had leadership nominations, and worked on SSAN workgroups & projects.
 - The next meeting is March 6th on Zoom.

Legislative Office Comment after reports:

- Katie Jaycox, Representative from Congressman Josh Harder's office:
 - A House resolution proposal did pass on Feb 25, 2025, with cuts to Medicaid and Medicare. Congressmember Harder voted against it.
 He is committed to voting against anything that cuts this funding.
 - Social Security Administration (SSA) released an update on the Windfall Elimination Act. SSA will be sending out lump sums to those that qualify, at the end of March. It will be direct deposited into people's accounts. Those that qualify for the increase in benefits



- should be seeing it in the April check. SSA will send a letter to let people know if they are getting a lump sum or if their benefits are increasing. There is nothing people need to do.
- Congressmember Harder co-sponsored bill HR500, the Medicare hearing aid coverage act. This will allow Medicare coverage for hearing aids and related examinations.
- Also, the congressmember co-sponsored bill 842 to amend the Social Security Act to provide Medicare coverage of multicancer early detection screening.
- Leslie Bulbuk from Assemblymember Marc Berman's office:
 - The Assemblymember welcomes constituents who are having issues with any state agency, or who have ideas for future bills to reach out to his office.
- Kathy Reynoso from Congressman John Garamendi's office.
 - If any constituents in Congressional District 8 have issues with Social Security and Medicare, please reach out to this office.

Bay Area RAC Year in Review & SCDD Bay Area Office Year in Review:

- Sheraden Nicholau gave a review of the work done by the Bay Area RAC and Bay Area Office and summaries were shared over Zoom. Some highlights were:
 - Over the last fiscal year there have been nine RAC members representing the five Bay Area counties with a wide range of expertise, and over 25 legislative office elects or staff that have engaged or reported out in RAC meetings.
 - The Bay Area Office developed 15 new curricula of webinars or inperson trainings, translating four of them and updating nine of them this year.
 - Team members serve on four internal statewide expert advisory panels and have provided technical assistance when individuals reach out directly for one-to-one advice for systems navigation.
 - The National Core Indicators (NCI) Project is currently in the process of in-person interviews with thousands of Californians with IDD.



Legislative Cycle Overview & Updates

- Chris Arroyo, New Deputy Director of Policy and Public Affairs shared the Legislative Cycle Overview and Updates. Some highlights were:
 - There are many ways to formally and informally provide input to SCDD about issues that matter to the community.
 - From the day SCDD learned of the proposed cuts to Medicaid, the Council created a training presentation to educate people about the proposed cuts and which services in California receive Medicaid funding. Thus far, there have been seven trainings educating over 800 community members.
 - The Legislative and Public Policy Committee (LPPC) of the Council looks at the bills SCDD wants to take a position on, makes recommendations to the Council, who formally inform staff to take action in support or opposition to work with bill authors to improve a bill.
 - o Three such issues are:
 - Educating doctors and dentists in medical school to work more with people with disabilities and experts.
 - Chronic absenteeism in school.
 - Plain language in government.
 - The Council is taking positions on many of the bills that are of interest to the IDD community.
 - Community members may want to take part in the "There Ought to be a Law" contest around June or July 2025. Ideas will be finalized by September and selected by the State Council's Legislative and Public Policy Committee (LPPC) and then the Council by November 2025.

Florence Wong gave the Update on the Caregiver Abuse Registry:

- The Caregiver Abuse Registry workgroup is looking for an author sponsor as Senator Josh Becker's office did not take on the idea this time. The workgroup is looking for an organization that would be willing to put it in front of different legislators who might be interested in the idea.
- Florence Wong asked the Department of Justice what amount they pay right now to manage the Child Abuse Central Index (CACI) so the



Caregiver Abuse Registry can assume the cost may be similar for an adult registry. They reported \$994,154.84.

Other Announcements (highlights):

- Debra Adler shared that Disability Rights of CA's director was recently interviewed and he denounced the use of the "R" word by a powerful figure in Washington DC. Using it is unacceptable. That person defended using that word. There has been an uptick in people using that word.
- Councilmember Nicole Adler has been working steadily on ending the "R" word and found its use by someone so influential to be hurtful.


