- Positions taken on 19 bills
- SCDD supported 18 bills and opposed 1
- Of the 18 SCDD supported bills, 7 were signed into law
- The one SCDD opposed died in committee
- The remainder may be acted upon as 2-year bills

2025 There Should Be A Law Contest Report

- Fifth annual contest
- The contest encourages everyone to participate by proposing changes to the law to improve daily life for people with disabilities
 - Bill ideas will be shared with legislators and advocated for if a legislator will champion it
- Report is available on the LPPC webpage

2025 There Should Be A Law Contest Report

150+ bill ideas were submitted

- Timing was a little different due in July
 - Based on when ideas must be presented to bill authors

 Topics with the most ideas: human services, education, health, and civil rights

2026 Legislative and Policy Ideas

- The council approved legislative and policy ideas and authorized staff to work on them. They are:
 - Clarify the authorized representative process
 - Plain language materials from government agencies
 - Protected, paid leave for sibling bonding
 - Fingerprinting of personnel at off-campus school worksites
 - Chronic absenteeism in schools
 - Marriage penalty (SSI)

2026 Policy Priorities

- Council has approved priorities by subject and authorized staff to advocate for them
- Periodically reviewed to ensure they're relevant, timely, and inclusive of emergent issues
- For this reason, a new section was added to the document, "Ensuring Federal Policies and Laws Advance Inclusion and Self-Determination"
- Staff are requesting LPPC consider the document and recommend its adoption to Council for the November meeting
