Perla Elizarraraz De Leon introduced herself. She has a 3 year old daughter who is in Pre-K in Bakersfield and has Down Syndrome. She also has an 8 yr old son, as well as a 12, 23, 24 and 29 year old daughters.

Chris Arroyo - SCDD Deputy Director of Policy and Public Affairs:

Chris Arroyo introduced himself, he has worked for SCDD for 25 years now. He was recently promoted to the position of Deputy Director of Policy and Public Affairs. He works with the Legislative team both at HQ and within the regional offices. He shared his PowerPoint presentation with the RAC that he has been presenting statewide.

Yolanda Cruz's updated that we are still working with Ally Comprehensive services to put on needed trainings. We are also super excited to be bringing a new training course to the Central Valley.
