



5:30p Chair Emily Witkin called the meeting to order. Valerie Buell took roll call of RAC members and confirmed there was a quorum.

Attendees were invited to introduce themselves and/or put their names in the chat if they wanted to do so.

- Zach Unger, Councilmember for the city of Oakland, introduced himself and was glad we
 were able to use this space. He asked that we let him know if there is any way he can
 help with our work.
- Zachary John Taylor introduced himself and expressed his interest in engaging with the RAC and sharing his thoughts this evening.

Public Comments: Emily Witkin asked for public comments. Highlights included:

- Zachary John Taylor shared his concerns about general government procedures, elections, and executive orders.
- Sal Harkins from State Senator Jesse Arreguín's office shared:
 - The senator is focused on health equity and immigrant rights.
 - Senate Bill (SB) 81, authored by the senator, was signed by the Governor. This bill requires hospitals and clinics to establish safe spaces for patient care and dignity.
 - The senator authored Senate Joint Resolution (SJR) 3 urging Congress to protect and expand SNAP benefits.
 - The 2025 Budget Act Assembly Bill (AB) 143 included significant changes to developmental services in June that were administration-driven cost saving measures, as the state faces a difficult fiscal situation. The senator welcomes any feedback from this community that he can take back to Sacramento.
- Elizabeth Vacca from Senator Aisha Wahab's office shared:
 - This office has participated in and collaborated with Preparing Resources &
 Alliances Galvanizing Neurodiversity Acculturation (PRAGNA), an organization



- that supports the neurodiverse community through community integration programs academic online programs and social experiential programs.
- With the support of the Association of Regional Center Agencies (ARCA), the senator worked to pass SB 258 and worked with Disability Rights Education & Defense Fund (DREDF) to address concerns.
- The senator authored SB 1316 which would have required state special schools to align their pay to be comparable to those of similarly qualified personnel in encompassing school districts.
- She was able to secure \$500 million in funding with \$120 million for the multifamily housing program, and additional funds for the low-income tax credit and expanding the renters tax credit.
- Nicole Cuellar-Nelson from Senator Christopher Cabaldon's office shared, directly and in email:
 - o The senator has nine bills sitting on the governor's desk; there are two of interest.
 - SB371 Transportation Network Companies: Currently, Uber and Lyft drivers are required to have \$1m in uninsured driver insurance. This has been shown to be an excessive amount and contributes to higher fares. SB 371 would reduce rideshare companies' Uninsured/Underinsured Motorist (UIM) coverage from \$1 million per incident to \$60,000 per person/\$300,000 per accident, which could lower costs for companies and potentially lead to reduced fares for riders. This legislation also opens up the opportunity for these workers to unionize.
 - SB 351 Health Facilities: This bill aims to provide protection from private equity compromising the quality of health care. It would codify the Medical Board of California's guidance on corporate practice of medicine to explicitly prohibit private equity groups or hedge funds doing business in California from interfering with the professional judgment of physicians or dentists. SB 351 authorizes the Attorney General (AG) to seek injunctive relief for violations of these provisions and makes the provisions severable.
- Jacob Francisco from Assemblymember Lori D. Wilson's office shared:
 - AB 1249, on early voting, seeks to address the gap by ensuring that voters in nonvoter choice act counties have access to early voting locations on the Saturday before the statewide election.
 - The assemblymember has focused on a wide range of bills strengthening transportation safety, improving farmland conservation, and clearing the way for new housing.
 - As co-chair of the Delta Caucus, she is happy to report the proposed delta trailer bills did not move forward, because the Delta Conveyance Project posed a serious threat to our ecosystem and economy.



- They are hosting two accessible transportation town halls; December 9th in Solano County, and on December 10th in Contra Costa County, and welcome this community to share their lived experience on transportation and disability.
- Debra Adler acknowledged Sheraden Nicholau and her dedication to serving the IDD community as the SCDD Bay Area Regional Manager and congratulated her on her new position as SCDD Deputy Director of Regional Office Operations.
- Nicholas Hargis from Representative Sam Liccardo's office shared:
 - Representative Liccardo shares the community's frustration with the federal cuts passed by the current administration and is here to help with constituent case work when folks have issues with federal agencies like Social Security, the Department of Education, the IRS, etc. .
- Gélser Zavala from Representative Lateefah Simon's office shared:
 - Representative Simon is the first member of Congress who is congenitally blind. She has made disability access the central point to her legislation. She is working to use legislation to think differently about the Disability Employment Act, and she introduced a mobile eye clinic for a K-12 partnership with the Department of Education to fund eyewear access.
- Dina Sanchez from Senator Tim Grayson's office shared:
 - The Governor now has until October 12th to sign bills that could potentially become law. The state budget has been severely impacted, and a focus is to preserve as much access to quality healthcare as possible. Senator Grayson has worked to pass bills intended to help affordability, especially at the gas pump. SB237, recently signed by the Governor, is largely focused on preserving California's leading environmental regulation while also making fuel supplies stable to keep gas prices from extreme spikes.

Member Reports: RAC Members and Councilmembers reported on their regional and statewide advocacy work and priorities.

Highlights included:

Terri Carol:

- Attended the San Mateo County Commission on Disability's meeting and was impressed on all the grants the committee is working on, and heard the presentation given by Sheraden Nicholau and Ben McMillian on Disability Etiquette.
- Currently working with people from Special Olympics and Best Buddies to talk about programs they are working on, possibly presenting to the RAC.

Evan Milburn:

 October is National Disability Employment Awareness Month (NDEAM), and San Mateo County is hosting the art showcase they do every October. Residents of San Mateo County are welcome to submit their artwork.



Kevin Mintz:

Kevin Mintz is an instructor in the Department of Pediatrics at Stanford School of Medicine, and lives in San Francisco. He hopes to work on access for everyone focusing on transportation and public facilities around San Francisco. He will be joining the Bay Area RAC workgroup on intergenerational trauma.

Kerry Rich:

- Kerry Rich and his wife attended the Urban League on Saturday at their annual gala and heard Representative Simon speak. They also attended, and hosted a table for Joshua's Gift, at the Friends of Children with Special Needs (FCSN) resource fair in Fremont.
- Joshua's Gift has launched "CODE Joshua" program, including training first responders and law enforcement on how to interact with a person on the spectrum or a person with IDD in a crisis situation.

Bird Sellergren:

- Bird is seeing that autistic adults are seeking spaces to build connections with each other and are trying to facilitate some of those connections in their online meetings. There is a need for more physical spaces that could benefit the community.
- They have also been in talks with some autism researchers working in biology research who have expressed a desire to start fostering mutual understanding between autism researchers and the autistic community; currently working on a workshop to bring these groups together in mid-October.
- They have also been talking to other autism researchers working in genomics and the social sciences and have identified an urgency to conduct more research that disputes messaging from the current administration, specifically around the causes of autism.
- They are looking for in-person meeting spaces in the North Bay and all the areas that this RAC covers for those attending the virtual meetings who may want a more local space for them.

Sana Shooshtari:

- There are challenges with repairs and replacement of Durable Medical Equipment (DME); vendors who are responsible for supporting these repairs do not recognize that malfunctions can be seen as an emergency. When equipment fails and repairs are not done immediately, this affects the quality of life for individuals who depend on DME. There must be a way to have 24/7 access to support, and she would like to see this as a future agenda topic.
 - Evan Milburn asked about Independent Living Centers have been any help.
 Sana answered she has not had experience with them and has worked more with Medicare and Alameda Alliance for Health.
- There is a free Supported Decision-Making conference for diverse communities at Laney College in Oakland on October 25th from 8-5pm.



Marla Silversmith:

- This is her last meeting as a RAC member, and she reflected on the past six years of service and will continue to be available as a contact.
- Recently, has been engaged with a lot of work around rightful presence in schools to make sure that our students deserve the right to be in classrooms and in schools.
- Echoed Sana's concerns about DME, and that schools also need engineers to come out and fix equipment for the students, who lack access to their education when the equipment isn't working.

Emily Witkin:

 Echoed what Bird said about needing spaces for autistic people to meet in-person and shared that Contra Costa County needs this too.

Florence Wong:

- The Commission on Disabilities hosted their Inclusion Festival on July 30th and SCDD had a table there. Former Councilmember Alex Reyes was the DJ. This was the first time the county flew the Disability Pride flag.
- The Disability Arts Showcase will be held at 800 Main Street in Redwood City, the location for the new center for creativity in Redwood City. Artists with disabilities who live or work in San Mateo County are encouraged to apply to showcase their art. There will be a reception on October 18th from 1-3pm and then a workshop on October 25th from 1-3pm.
- On October 7th there will be a presentation from the Commission on Disabilities to the Board of Supervisors. They expect to have a proclamation for Disabilities Awareness Month.

Alex Reyes:

- Congratulated Bob Twomey for his newly appointed role as the new Bay Area Councilmember of the State Council.
- Congratulated Sheraden Nicholau on her new role.
- Offered condolences to Councilmember Eric Ybarra who passed away in August 2025.

Bob Twomey:

- Reflected on his sister, Elizabeth, and how she is a huge part of his life and how he can represent her.
- Listened to the reports given at this meeting and, as an investigator, thought "what state agency investigates this?"
- Hope to be of service to the RAC as a SCDD Councilmember.

Nicole Adler:

- The State Council is working on developing their 5-year state plan; that will be discussed later in the evening.
- Asked that everyone take a moment to reflect on Councilmember Eric Ybarra's life and legacy.



Community Reports:

Family Resource Navigators (FRN)

- Amelia Ott, the Supported Decision-Making program manager for FRN, gave a slide presentation about the work they do and about Supported Decision-Making.
 - The presentation reviewed who they are, what they do, resources for Supported Decision-Making, the types of trainings they provide, community partners they collaborate with, and their goals.

Regional Center Reports Highlights:

- Eric Zigman gave the report for Golden Gate Regional Center (GGRC):
 - GGRC has had three community events funded through their language access and cultural competency programs.
 - GGRC is rolling out their new website that will be easier to navigate and have more clarity around eligibility, in plain language.
 - The Deaf Plus conference was held in Fremont recently and had about 300 registrants.
 - GGRC had a Self-Determination Resource Fair in San Francisco at the Pomeroy Center.
 - There is a Request for Proposal (RFP) on their website to do a roommate matching service for people served.
- Dr. Becky Nanyonjo gave the report for Regional Center of the East Bay (RCEB):
 - Bleu Moon Living, LLC, a first home in California designed to be fully accessible for people who are Deaf, Hard of Hearing, or Deaf+ has been completed in the East Bay. The grand opening just took place in June, in Newark.
 - RCEB has launched community listening sessions conducting outreach for affinity groups of community they would like to hear from. The next is on Saturday September 27th at the San Leandro Offices. There will be a virtual session on Tuesday September 30th from 6p to 8p.
 - Association of Regional Center Agencies (ARCA) hosted an executive retreat and committee meeting in Irvine California for regional center executive directors, attended by both Dr. Nanyonjo and Eric Zigman.

Developmental Disabilities (DD) Councils Report Highlights:

- Vi Ibarra gave the report for the Contra Costa County Developmental Disabilities Council.
 - They held their annual planning meeting in June and voted in new board members: Eric Estrada from Mt. Diablo Adult Education and Matt Bow from Special Olympics in Northern California.
 - They started their new series of meetings on September 24th and will be meeting on the fourth Wednesday of each month.



- Sabreena Sahota gave the report for the Alameda County Developmental Disabilities Council (ACDDC).
 - They had their planning meeting in July and identified key priorities to increase engagement, collaboration, and elevating community voices. There meetings will be on the second Wednesday of the month, and the next meeting will be October 9, 2025. They encourage input from the community on their needs and priorities.
 - They are planning their 2026 conference, and the first planning meetings are in
 October on the first and third Thursday of each month from 3p to 4:45p

Statewide Self Advocacy Network (SSAN):

- Sara Desumala read the report:
 - The SSAN meeting was on September 3rd and 4th on Zoom. They learned about medical advocacy, the Systemic Advocacy Leadership Academy (SALA), emergency planning for wildfires and floods, and updates on the Developmental Services Master Plan.
 - They welcome the public to attend all SSAN meetings and learn about leadership and advocacy.

7:08p Break

Legislative Office Comments:

- Senator Aisha Wahab
 - Her focus has been on most vulnerable community members. She has a doctorate in social work, and her chief of staff is a licensed marriage and family therapist.
 - The senator has collaborated with the CA School of the Deaf and CA School for the Blind to ensure that the faculty and staff get an increase in their pay. Many staff are on the verge of homelessness.
 - There has been misrepresentation of many of the bills put forth to protect the vulnerable. SB 258, which ends the spousal rape loophole, affirms consent as a right for people with disabilities and aims to close the last loophole. It is on the Governor's desk to sign.
 - The senator is trying to establish standards for ADA compliance as the natural standard in housing development. There is a home in San Jose that was built with best practices. Unfortunately, the bill for this did not make it through the legislature.
 - The senator also authored a bill about wage theft, currently on the Governor's desk, that highlights if a worker was not paid fully, the employer is fined additionally.

Sheraden Nicholau gave a presentation on the Real Input Real Impact California State Plan Survey: Highlights include:



- Every five years, the California State Council works with Californians to identify priorities that become part of a 5-year state plan.
- Past feedback included areas of emergency preparedness and response, public safety, self-advocacy and employment.
- We, SCDD, are asking you and your networks to complete the current survey. October 15th is the deadline.
- Additionally, SCDD hosts town halls up and down the state. One in the Bay Area will be on October 9th from 1:30 to 3p, at the Oakland State Building.
- If needed, SCDD can help you with the survey. You can give us verbal responses that we can type for you, or we can give you a hard copy that you can return to us.

Celebrating Outgoing Leaders: Highlights include:

- Sheraden Nicholau presented the certificates to each of the outgoing members of the RAC and State Council that were sent by their district representatives.
 - Outgoing Councilmember Nicole Adler started as a Bay Area RAC member before being appointed to SCDD by the Governor. She was given a certificate of recognition from Senator John Becker, from Assemblymember Diane Papan, and from Congressman Kevin Mullin. Nicole shared she will continue with her advocacy and is excited to see what is next.
 - Outgoing Councilmember Alex Reyes was a Bay Area representative on SSAN before becoming a councilmember. He values contact with media and journalists, making sure community needs are elevated and represented in mainstream media. He was given a certificate of recognition from Assemblymember Alex Lee and from Senator Aisha Wahab. He dedicated these to his family and friends, Fremont Unified School District, and to the State Council.
 - Outgoing SCDD Bay Area RAC Vice Chair and Member Marla Silversmith began on the RAC as a member and became Vice Chair. She connected the SCDD Bay Area Regional Office with Supporting Innovative Practice (SIP), which led to an inclusive panel at their 2025 statewide conference, comprised of panelists with lived experience. She was given a certificate of recognition from Senator Jerry McNerney and from Assemblymember Liz Ortega. Marla is excited to continue the work and continue being a connector.

Other Announcements (highlights):

- Jerry Grace encouraged people to attend upcoming RCEB Consumer Advisory Committee (CAC) meetings, and look into the ARC in San Francisco for workshops they may be interested in.
- Bob Twomey thanked Nicole Adler for their friendship over the years and the impact she
 has had on him. She has been a great mentor and leader for so many people.

Policy Priorities 2025–2026

Protecting and Enhancing Civil Rights

A Every person with intellectual and developmental disabilities (I/DD) has the right to self-determination, equality of opportunity, full participation, independent living and economic self-sufficiency, no matter their disability.

The Council will work to ensure civil rights, including identification and reduction of racial and ethnic inequalities and disparities are protected and enhanced and full implementation of state and federal policies, including but not limited to the Workforce Innovation and Opportunity Act, Home and Community-Based Services Settings Rule, Every Student Succeeds Act and Achieving Better Life Experience Act.

Guaranteeing Access to Education and Employment

Every student with I/DD has the right to a quality inclusive education with their peers that prepares them for post-secondary education and/or competitive integrated employment (CIE). Students with disabilities must be provided the same learning opportunities, in the classroom and online, as students without disabilities.

Every person with I/DD should have the opportunity to be employed in CIE. Individuals must have access to information, benefits counseling, transition planning, job training, career exploration and information and support for inclusive post-secondary education. New or expanded pathways to CIE must be developed and supported, including apprenticeships and internships.

The Council will work to ensure the implementation of the Individuals with Disabilities Education Act, Every Student Succeeds Act, and other federal and state policies to ensure that students with disabilities are provided the services and supports needed to receive quality inclusive education.

The Council will work to ensure the full and robust implementation of the Workforce Innovation and Opportunity Act and California's Employment First Law, that policies and practices improve opportunities for and incentivize CIE, to create hiring incentives and supports for all employers and contractors and make the state a model employer.

Identifying & Prioritizing Emerging Issues in the I/DD Community

Every person with a developmental disability should not have to deal with problems that arise due to the emergence of inequality issues in the community. Events in our everyday lives, both due to policy changes and unforeseen events, have the ability to cause unintended consequences for the I/DD community. These issues must be identified and acted upon swiftly to ensure as little harm as possible is inflicted.

The Council will work to ensure any and all emerging issues, including but not limited to dealing with disparity across all I/DD issues, barriers to participating in a community setting, and roadblocks to access for people with I/DD, are dealt with through policy changes.

The Council will work to ensure the Self-Determination Ombudsperson program at the Department of Developmental Services uses its authority to ensure people with I/DD become successful participants in the Self-Determination Program.

Promoting Access to Quality Supports in the Community

Every person with I/DD should be able to fully participate in their communities. The ability to receive quality, individualized services, is the cornerstone for people with I/DD to be safe, healthy, and to promote self-determination, interdependence, and inclusion.

Community-based services/supports require adequate wages for providers; therefore, the state must restore rates. Disparities in access, outcomes, and quality of services and supports must be addressed, and complexities in the service delivery systems must be reduced.

The Council will work to continue to restore the Department of Developmental Services programs cut in 2009, to make meaningful improvements to the service delivery system to reduce disparities, increase transparency and accountability, and increase quality outcomes, support efforts to provide adequate wages to providers for inclusive and quality supports, and work to ensure successful implementation of the Self-Determination Program.

Ensuring Safety in the Community

Every person with I/DD has a right to be safe and must receive emergency preparedness training and training in personal safety. Law enforcement personnel, first responders, emergency medical professionals, and the judicial system must be trained in how to work with people with I/DD (including those who are suspects, victims or witnesses of crimes).

The Council will work to ensure people with I/DD are safe, free from abuse and neglect and have access to services and supports in their communities during all types of disasters or emergencies and an adequate safety net for people in crisis and access to adequate crisis intervention services.

Improving Housing and Community Living

Every person with I/DD should have the opportunity to live in the community. Permanent, affordable, accessible, safe, and sustained housing options must be continually developed. Statewide inclusive living options for individuals with I/DD must be increased and enhanced through access to housing and subsidies, paired promptly, with needed services and supports.

The Council will work to implement the policy recommendations in the Statewide Strategic Framework for Housing and create a dedicated housing fund to support integrated community housing for people with I/DD.

Goal 1: Self-Advocacy

By 2031, the Council will increase the number of people with intellectual/developmental disabilities to become effective self-advocates, peer trainers, and/or community leaders.

By 2031, the Council will reach 10,000 self-advocates with community-building activities, training, events, projects and resources that build their capacity for self-governance and to become effective, active leaders, peer trainers and mentors. By 2031, the Council will reach 5,000 self-advocates, representing California's population, to be active in cross-disability and peer networks and groups by providing support and peer advocacy/leadership opportunities. In the event of unexpected project opportunities, emerging needs, and/or community, cross-regional or statewide requests, the Council may engage in additional activities with and/or on behalf of family and self-advocates and those who support and serve them.

Goal 2: Systems Change/Advocacy

By 2031, the Council will lead, in partnership with family/self-advocates and others, to protect and enhance civil rights and improve statewide and community-based systems to be fully inclusive and supportive of people with intellectual/developmental disabilities and their families.

Objectives By 2031, the Council will develop, improve and/or change 40 practices, 25 policies, and 15 regulations (or guidance) and/or laws in the systems of regional centers, community-based services, education, and government entities. This work will include the areas of 2.1 health/safety, employment, housing, and/ or emerging issues in ways that will benefit people with intellectual/developmental disabilities and protect their civil rights, promote full inclusion, and/or provide additional supports and services. By 2031, the Council will support 50,000 people (family/self-advocates and others) by engaging in 20 Statewide/Cross-regional/regional systems change efforts/projects/events in the areas of health/safety, employment, housing, self-determination, and/or emerging issues to: 1. Provide them information, skills and/or supports to increase their abilities to become 2.2 effective advocates; 2. Engage in professional training and/or other efforts to implement systems, demonstrate or support systems change; and/or, 3. Increase services and/or improve supports for people with intellectual/developmental disabilities and their families.

Goal 3: Capacity-Building/Advocacy

By 2031, the Council will increase partnerships with and support more people with intellectual/developmental disabilities and their families, so they know their rights and can advocate for and receive personalized services.

Objectives By 2031, the Council will increase the capacity of 50,000 people (family/selfadvocates/others) with assistance and resources to identify and obtain the supports and services they need, by: 3.1 1. Providing (staff-led, peer-led and/or collaborative) training, 2. Providing technical assistance (TA)/advocacy clinics and/or resources, and 3. Establishing and/or collaborating with and supporting family-advocate groups/networks By 2031, the Council will engage in projects and events in the areas of health/safety, housing, employment, education, and/or emerging issues, reaching 35,000 people 3.2 (family/self-advocates/others) with opportunities for community inclusion and family peer support networks that increase their knowledge and capacity to obtain supports and services that are important to them.






2025: Total People Trained (all Goals)






